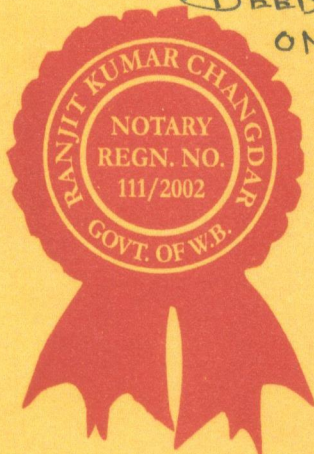

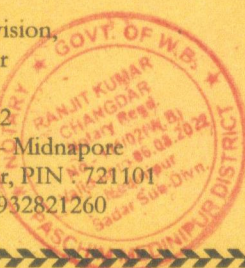

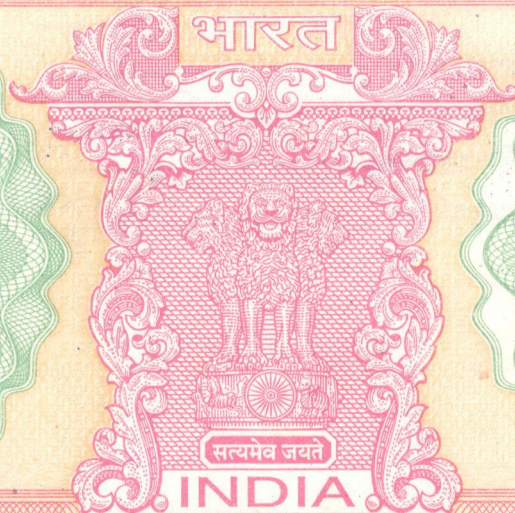

opportunity as dietitian to the students (who successfully completed their degree or diploma) as per the availability of vacancy.

Now this MOU witness and it is agreed by and between the parties as follows:

1. A written request for training should be made by VU. This request will be either faxed / e-mailed or hand delivered by the beneficiary to the Ruby authority and produced at the time of training programme along with photo identity proof issued from VU. Ruby will not provide training facility without this letter.
2. Ruby shall provide seven days to thirty days cashless training programme to the students
3. Ruby shall also send their dietitians or doctors to VU as resource person or trainer.
4. VU students will also take training by visiting Ruby for seven days to thirty days.
5. VU will pay honorarium to the dietitian or doctors or trainer or resource person of Ruby conducting classes or training as per VU norms.
6. Benefeciary will not pay any cost to Ruby for training by Hospital visits of the student.
7. Ruby shall give opportunity to the VU students (who sucessfully completed their degree or diploma) to work as trainee Dietitian and or Dietitian Assistant in Ruby as per the vacancy from time to time.
8. MOU can be terminated by either party by giving one month's prior notice.
9. Any disputes, claims arising out of this Agreement are subject to arbitration and subject to the jurisdiction of MIDNAPORE COURT only.
10. Any clauses in the MOU can be affected as an addendum and on corrigundum, after the written approval from both the parties.

#### FINANCIAL LIABILITIES:

There will be no financial burden on both the parties. In case of students & faculties exchange programs the cost will be borne by respective participants. Both Universities and (RUBY) will work to get funds from agencies such as ICSSR, ICMR, DST, DBT, UGC, MOES, CSIR etc. In case if both the parties are jointly carrying out a joint project the financial terms will be decided by both the parties based on the cost of the project.

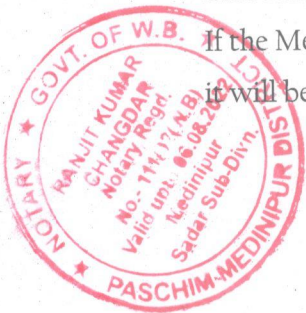
