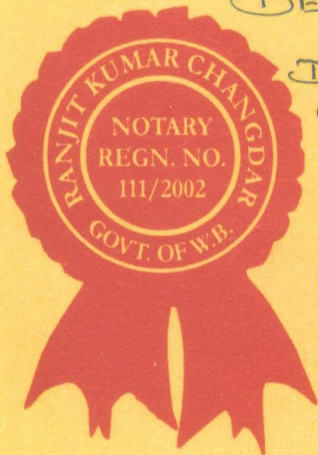

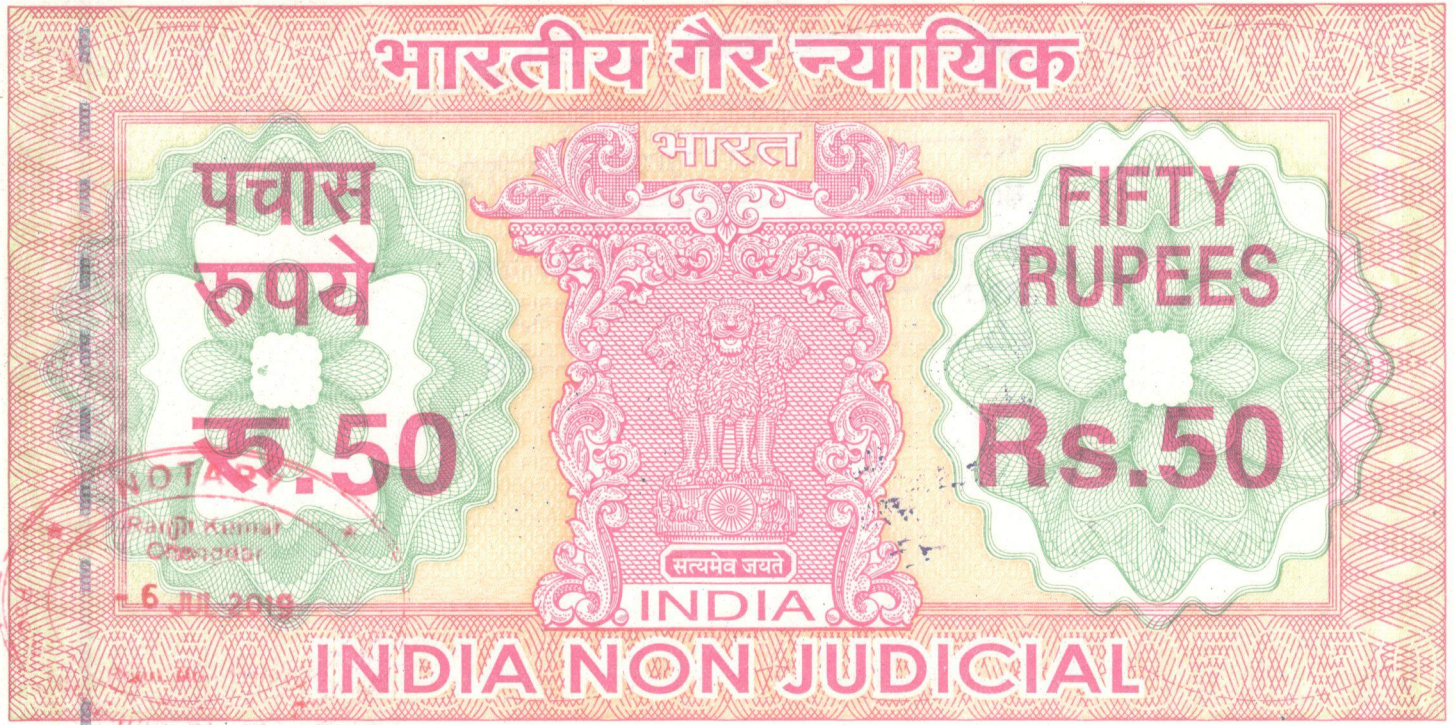

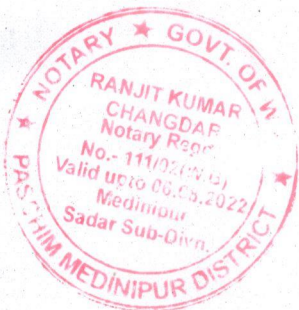
FINANCIAL LIABILITIES:

TERMINATION:

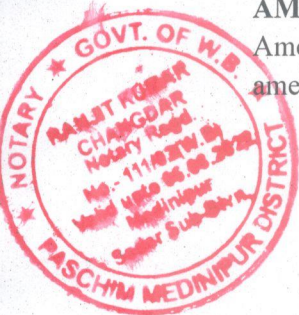
