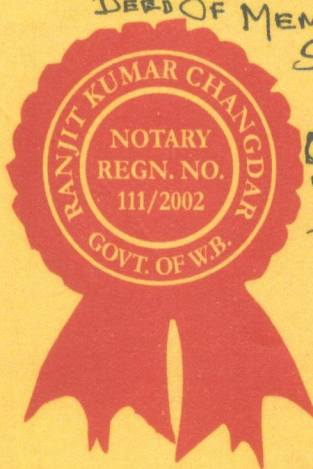

India, agrees to give training facilities in all the fields regarding Beekeeping, Honey production, Marketing & Management and agrees to provide placement opportunity as Trainer/Beekeeper to the students (after successfully completed their course/degree/diploma) as per the availability of opportunity.

Now this MOU witness and it is agreed by and between the parties as follows:

1. A written request for training should be made by VU. This request will be either faxed / e-mailed or hand delivered by the beneficiary and produced at the time of training programme along with photo identity proof issued from VU. Laxmi Narayan Apiary will not provide training facility without this letter.
2. Laxmi Narayan Apiary will provide seven days cashless training programme to the students.
3. Laxmi Narayan Apiary will also send their experts to VU as trainer.
4. VU students will also take training by visiting Laxmi Narayan Apiary for seven days.
5. VU will pay honorarium to the trainers of Laxmi Narayan Apiary for conducting classes or training as per VU norms.
6. Benefeciary will not pay any cost to Laxmi Narayan Apiary during their visit.
7. Laxmi Narayan Apiary shall give opportunity to the VU students (after sucessful completion of their course) to work as trainer as per the vacancy from time to time.
8. MOU can be terminated by either party by giving one month's prior notice.
9. Any disputes, claims arising out of this Agreement are subject to arbitration and subject to the jurisdiction of MIDNAPORE COURT only.
10. Any clauses in the MOU can be affected as an addendum and on corrigendum after the written approval from both the parties.

Each of the parties undertakes to appoint an Academic member to serve as "lead contact" with the other party with responsibility for suggesting joint activities, evaluating the program, and making recommendations for continued cooperation.

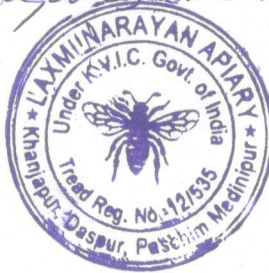

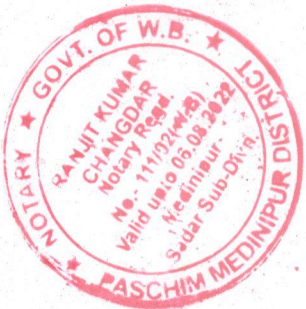
