No. 8-26/2014-TEL dated 09.02.2023 of the Additional Secretary, Department of Higher Education, Ministry of Education, Government of India related to propagate and popularize SWAYAM courses at Universities /Institutions in respective States, requesting for taking appropriate steps in this regard. After thorough discussion on the letter received from the Assistant Secretary to the Government of West Bengal, Department of Higher Education, University Branch regarding propagate and popularize SWAYAM courses at Universities /Institutions in respective States, it was resolved that the said SWAYAM Courses be propagated and popularized in this University as advised by the Higher Education Department, Government of West Bengal and the Government of India respectively. Resolved further that Professor Pinaki Das, Department of Economics of this University would act as the Co-ordinator and the Secretary, Faculty Councils for Postgraduate Studies of this University would act as the Deputy Co-ordinator for such SWAYAM courses and the Co-ordinator and the Deputy Co-ordinator of SWAYAM Courses be requested to submit a detailed report in this regard within one month for placing the same before the next meeting of the Executive Council for further consideration.*

27.12.2022. After joining in the Department of Computer Science he is getting less than his last salary drawn at the CDOE. In this connection he has requested to protect his present salary as was drawn by him at the Centre for Distance and Online Education of this University.

After thorough discussion on the letter submitted by Shri Debkumar Bera, Assistant Professor (Contractual), Department of Computer Science of Vidyasagar University praying for protection of his present salary as was drawn by him in his previous job at the Centre for Distance and Online Education (CDOE) of this University, it was resolved that a Committee consisting of (1) Professor Sumita Roy, Department of Chemistry as the Chairperson, (2) Professor Brajaballav Pal, Head, Department of Commerce, (3) the Finance Officer, (4) the Accounts Officer as the Member-Secretary be constituted to look into the matter and to give their suggestions in this regard for further consideration. Resolved further that the Finance Officer of this University be requested not to mislead the Hon'ble Vice-Chancellor or other stakeholders in any matter by putting unnecessary and favulous information.

He visited this University on 11.12.2022 and delivered a talk to the students. Now he is willing to donate a lump sum amount of Rs.1,00,000/- (Rupees One Lac) only to the University to honour of his mother's hard work and dedication for creation of an Endowment fund for giving a cash prize to the first rank holder of M.Sc. in Mathematics from the interest of such a fund every year in the Convocation of Vidyasagar University. He has also requested that such a prize will be his mother's name "Swarna Majhi" and his mother will remain present on the occasion and will hand over the prize to the recipient.

After thorough discussion on the letter submitted by Dr. Sudhan Majhi, Associate Professor, Department of Electrical Communication Engineering, Indian Institute of Science (IISC), Bangalore for creation of an Endowment fund in this University to award a cash prize to the first rank holder of M.Sc. in Mathematics, it was resolved that the said proposal for creation of an Endowment Fund of Rs.1,00,000/- (Rupees one lakh) only in this University for giving a cash prize from the interest of such fund every year to the first rank holder of M.Sc. in Mathematics of Vidyasagar University in the Convocation be accepted as per the existing norms of the University. Resolved also that the cash prize be prepared in the name of his mother, namely, "Swarna Majhi Cash Prize" as proposed by Dr. Majhi in his aforesaid letter and his mother will be invited to remain present in the Convocation as one of the Spectators but cannot handover the prize to the recipient, as also desired by Dr. Majhi, as it is beyond the norms of the University. Resolved further that the Finance Officer of this University be requested to process further regarding this.

**Resolution:** *The Executive Council of Vidyasagar University noted the note dated 31.03.2023 prepared and submitted by the Executive Director of Computer Centre of Vidyasagar University alongwith the bills amounting to Rs.21,100/- (Rupees Twenty One thousand One Hundred) only stating that as per the practice for providing the mobile set and SIM service to the Hon'ble Vice-Chancellor alongwith other officers of the University, a new mobile handset alongwith the Airtel SIM and other accessories has been provided to the present Vice-Chancellor of Vidyasagar University for official purposes. Now the payment of such mobiles set and accessories may be done. The Executive Council noted also that the bills amounting to Rs.21,000/- (Rupees Twenty One Thousand) only to be paid to M/s. Kamala Communication, Midnapore from which the new set has been purchased. The Executive Council noted further that the Hon'ble Vice-Chancellor proposed/desired to pay the cost of such mobile of his own but the house at the same time requested him to use the said phone provided by the University to him and to return the same to the University either at the end of the tenure or as per his convenience.*

*After thorough discussion on the note dated 31.03.2023 prepared and submitted by the Executive Director of Computer Centre of Vidyasagar University regarding payment of new Mobile Handset alongwith its accessories including SIM, it was resolved that the bills of such mobile handset alongwith the accessories and new SIM amounting to Rs.21,000/- (Rupees Twenty One Thousand) only be paid to the concerned vendor from the University fund and the Executive Director of Computer Centre be requested to process further regarding this.*

- 06(l) To place before the Executive Council of Vidyasagar University, the Note Sheet dated 15.03.2023 prepared and submitted by the Deputy Registrar (Academic) of Vidyasagar University regarding extension of the contract with Mr. Arabinda Sarkar for maintenance of gardens, parks, grass lawns and tub plants of Vidyasagar University for a further period of three months with effect from 01.04.2023 with the existing terms & conditions.

**Resolution:** *The Executive Council of Vidyasagar University noted the Note Sheet dated 15.03.2023 prepared and submitted by the Deputy Registrar (Academic) of Vidyasagar University stating that two tenders for maintenance of Gardens, Parks, Grass Lawns, Tub Plants etc. in the University campus were published. Thereafter an Expression of Interest was invited and e-tender for this purpose has been invited to select the new Vendor and it will take time. Under these circumstances, the contract of Mr. Arabinda Sarkar for this purpose may be extended for another three months with effect from 01.04.2023, i.e. April, 2023, May, 2023 & June, 2023 with the existing terms & conditions to complete the process.*

*After thorough discussion on the Note Sheet prepared and submitted by the Deputy Registrar (Academic) of Vidyasagar University regarding extension of the contract with Mr. Arabinda Sarkar for maintenance of gardens, parks, grass lawns and tub plants of Vidyasagar University for a further period of three months with effect from 01.04.2023 with the existing terms & conditions, it was resolved that the said proposal for extension of the contract period of Mr. Arabinda Sarkar for a further period of three months w.e.f. 01.04.2023 for this purpose be accepted with the*

existing terms & conditions as suggested by the Deputy Registrar (Academic) and the process for selection of new vendor be completed within three months. Resolved further that the Deputy Registrar (Academic) be requested to process further in this regard in consultation with the Finance Officer of this University immediately.

- 06(m) To place before the Executive Council of Vidyasagar University, the Note Sheet dated 28.03.2023 prepared and submitted by the Finance Officer of this University regarding waiving the room rent of New Xerox.

**Resolution:** The Executive Council of Vidyasagar University noted the Note Sheet dated 28.03.2023 prepared and submitted by the Finance Officer of this University based on the prayer dated 06.03.2023 submitted by the Proprietor of M/s. New Xerox for waiving the monthly rent of the room occupied by them for xerox purposes. The Executive Council noted also from the said note that the monthly rent of the room occupied by M/s. New Xerox is Rs.2,000/- (Rupees Two thousand) only and the total outstanding rent due from M/s. New Xerox during the period from April, 2020 to March, 2023 is Rs.72,000/- (Rupees Seventy Two Thousand) only. The Executive Council noted further that M/s. New Xerox prayed for waiving of such rent due to reduction in volume of business, increase in the cost of materials and also no business was there during the pandemic situation of COVID-19 as the University campus was totally closed and restricted. The Executive Council noted again that based on the application, no such concrete opinion in the matter was made by the Finance Officer and he only forwarded the same to his subordinate officials & others for their opinion. The Executive Council condemned such activity made by the Finance Officer who is the head of the section and also DDO of the University. Being the Finance Officer he should have put his opinion in the matter clearly.

After thorough discussion on the the Note Sheet dated 28.03.2023 prepared and submitted by the Finance Officer of this University regarding waiving the room rent of New Xerox, it was resolved that considering the pandemic and outbreak situation of Covid-19, out of the total rent of Rs.72,000/- (Rupees Seventy Two thousand) only during the period from April, 2020 to March, 2023, two years rent, i.e. @ Rs.2,000/- x 12 x 2 = Rs.48,000/- (Rupees Forty Eight Thousand) only be waived and rest of the rent of Rs.24,000/- (Rupees Twenty Four Thousand) be paid by M/s. New Xerox to the University immediately. Resolved also that the Finance Officer of this University be requested to process further in this regard. Resolved further that the Finance Officer be also requested to put his opinion clearly henceforth for all such cases instead of making the cases complicated and passing the buck.

- 06(n) To place before the Executive Council of Vidyasagar University, the statement of applicants applied for intending Provident Fund Loan both for refundable and non-refundable modes, if applicable, from their Provident Fund Account of Vidyasagar University.

**Resolution:** The Executive Council of Vidyasagar University noted the statement dated 13.03.2023 prepared and submitted by the Finance Officer of Vidyasagar University wherein two applicants, namely, Shri Nitai Samanta, Security Guard and Shri Prabir Das, Driver of this University applied for a non-refundable provident fund loan of Rs.3,00,000/- (Rupees Three Lakh) only and a refundable provident fund loan of Rs.45,000/- (Rupees Forty Five Thousand) only for the purpose of construction of house and for medical treatment respectively. The Executive Council noted also from the said statement that there was a provision of

five (05) signatories including the Registrar and the Vice-Chancellor of Vidyasagar University which was not desirable. The Hon'ble Vice-Chancellor cannot be one of the signatories in the statement of provident fund loan applicants where the honour of a Hon'ble Vice-Chancellor in a University has been degraded. The Executive Council noted further that there should be a provision of only three (03) signatories, viz., the Dealing Assistant, the Accounts/Audit Officer and the Finance Officer who is the DDO and thereafter such statement may be placed before the Hon'ble Vice-Chancellor for his kind approval, if required, for further process. No signatures of the Registrar and the Vice-chancellor is required in such a statement but the Finance Officer is trying to complicate the matter unnecessarily by putting the provision of their signatures in the statement although there is no such a provision as per the norms of the University. The Executive Council condemned and disapproved the entire above matter and regarding de-grading the honour of the Hon'ble Vice-Chancellor of Vidyasagar University in this regard.

After thorough discussion on the statement of applicants applied for intending Provident Fund Loan both for refundable and non-refundable modes, if applicable from their Provident Fund Account of Vidyasagar University prepared and submitted by the Finance Officer of this University, it was resolved that a Committee consisting of (1) Professor Kalpataru Bandyopadhyay as Chairperson, Department of Commerce, (2) the Head, Department of Commerce, (3) Dr. Tarak Nath Sahu, Department of Business Administration and (4) the Accounts Officer as Convener be constituted to look into the matter and to give their observations, findings, suggestions and recommendations in this regard. The Committee may consult other officials, if required, in this regard. Resolved further that henceforth no signature of the Vice-Chancellor and the Registrar is required on such a statement and the Finance Officer be requested not to complicate the case unnecessarily. If Hon'ble Vice-Chancellor's approval is required at all for such case, approval to be sought for from the Hon'ble Vice-Chancellor by the Finance Officer separately.

- 06(o) To place before the Executive Council of Vidyasagar University, the letter bearing No. 253(31)-Edn(U)/EH/1U-49/21 dated 14.03.2023 received from the Assistant Secretary to the Government of West Bengal, Department of Higher Education, University Branch regarding introduction of NCC as an elective subject at UG course curricula under State-aided Universities.

**Resolution:** The Executive Council of Vidyasagar University noted the letter bearing No. 253(31)-Edn(U)/EH/1U-49/21 dated 14.03.2023 received from the Assistant Secretary to the Government of West Bengal, Department of Higher Education, University Branch alongwith two Department's letter bearing No. 956(20)-Edn(U) dated 12.11.2021, 117(6)-Edn(U) dated 03.02.2023 and Advisories dated 23.02.2023, 09.07.2021, 15.04.2021 and 11.11.2016 of the University Grants Commission, New Delhi regarding introduction of NCC as an elective subject at UG course curricula under State-aided Universities. The Executive Council noted also that based on such an advisory of the Higher Education Department, Government of West Bengal as well as the University Grants Commission, New Delhi regarding introduction of NCC as an Elective subject at UG Course curricula has already been implemented in this University.

After thorough discussion on the letter received from the Assistant Secretary to the Government of West Bengal, Department of Higher Education, University Branch regarding introduction of NCC as an elective subject at UG course curricula under State-aided Universities, it was resolved that the Inspector of Colleges of this

*University be requested to process further in this regard in discussion with the Secretary, Council for Undergraduate Studies of this University.*

- 06(p) To discuss the matter regarding the payment procedures pertaining to payment of various bills to the vendors/suppliers by the Finance Department of Vidyasagar University.

**Resolution:** *The Executive Council of Vidyasagar University noted as follows :*

- (a) *several statements of vouchers alongwith the cheques and supporting bills prepared and submitted by the office of the Finance duly forwarded by the Finance Officer of this University wherein such statements have been prepared clubbing different dates of bills of various payees in a month at a time since phase by phase ;*
- (b) *In the aforesaid statements prepared and submitted by the Finance Officer wherein a provision of the signature of the Registrar of Vidyasagar University is required ;*
- (c) *The Finance Officer was requested by the Registrar to provide the specific order where it has been clearly stated that the signature of the Registrar is required on such a statement ;*
- (d) *Instead of providing the reasons and the required documents the Finance Officer sent another negative note mentioning "please provide relevant documents where it is reflected that the said clubbing cannot be done" ;*

  - (3) *Rs.2,00,00,000/- and above - Signature of all three.*
- (g) *as the Registrar did not receive the specific reasons/order/provision/ supporting documents regarding preparation of statement of vouchers and cheques clubbing different dates of bills at a time & the signature of the Registrar on the statement of vouchers from the Finance Officer but was receiving such statements phase by phase continuously, a proposal regarding preparation of such vouchers and cheques date wise on a day to day basis without delay for disbursement of the payment activities of the University and to maintain the reputation of the University, was placed before the Hon'ble Vice-Chancellor for his kind approval ;*
- (h) *Based on such proposal, the Hon'ble Vice-Chancellor directed the Finance Officer to do the needful and submit his opinion ;*
- (i) *The Finance Officer opined as follows :*
  - (i) *this is an illegal proposition contrary to the financial procedure. The procedure adopted is attune to transactions in vogue and also to save time ;*
  - (ii) *the proposal will create unnecessary complications in the payment system and it is not admissible to deviate from the system which is in force ;*

- (iii) requested the Hon'ble Vice-Chancellor to direct the Registrar to immediately sign the cheques which have been awaiting a signature since long;
- (iv) requested the Hon'ble Vice-Chancellor to direct the Registrar to immediately sign the cheques which have been awaiting a signature since long;
- (j) based on such opinions made by the Finance Officer, the Registrar in a Note sheet dated 24.03.2023 made his views and observations to the Hon'ble Vice-Chancellor, which are as follows :
- (a) the Finance Officer did not provide the specific order/provision where it has been clearly stated that the signature of the Registrar is required on the statement of vouchers prepared/to be prepared by the office of the Finance inspite of several requests ;
- (b) the Finance Officer did not provide the specific reason for preparation of the statement of vouchers after a long time of receiving the bills, and also the specific order/document where it has been clearly stated that the bills to be released through a single cheque/statement clubbing various bills together instead of releasing individual bill on a day to day basis inspite of several requests ;
- (c) we have received several in writing and verbal complaints from different vendors/suppliers against the Finance Officer for non-payment of their bills for a long time ;
- (d) the Finance Officer is trying to create the problem deliberately and intentionally to defame the image of the Registrar and also the goodwill of the University as a whole ;
- (e) the Finance Officer had the intention not to run the function of the University smoothly, otherwise bills could have been released on a day to day basis without keeping those pending for a long time even in many cases more than a month;
- (f) the Finance Officer is deliberately not releasing the payments individually where the billed amount is within the limit of Rs.50,000/- (Rupees Fifty Thousand) only. Instead, he is clubbing the bills probably with other intention ;
- (g) In terms of the provision of the Vidyasagar University Act, 1981 as amended from time to time, the University officers are – (i) the Vice-Chancellor, (ii) the Registrar and all others are after the Registrar ;
- (h) the Finance Officer cannot suggests to direct the Registrar, superior to him, to sign the cheques and others which tends to be insubordination as per the Ordinance of the University ;
- (i) the Finance Officer cannot advise the Registrar not to infringe upon the function of the Finance Department overlapping the statutory provisions as the Registrar is the Administrative Head of the University. Not only that, the Registrar is one of the authorized signatories for bank transactions which was approved by the Executive Council based on the recommendation of the Finance Committee. How can the Finance Officer

- challenge the collective wisdom and decision of the University authority (i.e. the Finance Committee and the Executive Council) ;
- (j) the Finance Officer was requested to provide the following documents/provisions immediately.
- the specific order/provision where it has been clearly stated that the signature of the Registrar is required on the statement of various vouchers together ;
  - the specific reason/order/provision for preparation of such a statement of vouchers after a long time of receiving the bills and the specific order/document where it has been clearly stated that the bills to be released through a single cheque/statement clubbing various bills together instead of releasing individual bills on a day to day basis ;
  - the provision of the financial procedure ;
  - the existing financial rules which were approved by the University authority (the Executive Council) and its details ;
  - the payment system of the University (which has been followed by him) duly approved by the competent authority (the Executive Council) ;
  - the relevant provisions/documents regarding the Registrar not to infringe upon the functions of Finance Department overlapping the statutory provisions, under the above stated facts ;
  - the documents based on which the Finance Officer concluded that the Registrar is infringing upon the function of the Finance Department ;
  - the documents where it has been clearly stated that the Registrar has to put his signature blindly on cheque and other various financial documents without checking anything, even if payment is proposed to a vendor without any bill and voucher as proposed on 15.03.2023 by the Finance Officer to pay to Mr. Biswajit Ghosal ;
  - the said 'adopted financial procedure to save time" be disclosed alongwith the date of the meeting and names and signatures of the members present in the meeting and its resolutions where the said "financial procedure" has been adopted and also approved by the University Authority (i.e. Executive Council) ;
  - the date of inception of the said "financial procedure" in the University ;
  - the date of inception of the current "payment system" in the University ;
  - the approved copy of the above stated financial procedure and payment system, by the Executive Council ;
  - the constraints of the previous payment system which compelled the Finance Department to replace it with the current payment system.

After thorough discussion on the matter regarding the payment procedures pertaining to payment of various bills to the vendors/suppliers by the Finance

*Department of Vidyasagar University and subsequently the observations and opinions made by the Registrar and the Finance Officer in this regard, it was resolved that the Committee consisting of (1) Professor Kalpataru Bandyopadhyay as Chairperson, Department of Commerce, (2) the Head, Department of Commerce, (3) Dr. Tarak Nath Sahu, Department of Business Administration and (4) the Accounts Officer as Convener as has been constituted vide Item No. 06(n) be requested to look into the matter and to give their observations, suggestions and recommendations in this regard considering the above and also the norms of the University. The Committee may consult other officials, if required, in this regard.*

- 06(q) To place before the Executive Council of Vidyasagar University, the letter bearing No. 266(31)-Edn(U)/EH/1U-45/2020 (Pt.) dated 17.03.2023 received from the Assistant Secretary to the Government of West Bengal, Department of Higher Education, University Branch regarding implementation of new Curriculum and Credit Framework for Undergraduate Programmes in all the Higher Educational Institutions of this State from the forthcoming academic session.

**Resolution:** *Consideration of the item was deferred.*

- 06(r) To place before the Executive Council of Vidyasagar University, the letter bearing No. 237(31)-Edn(U)/1U-01/14 dated 10.03.2023 received from the Assistant Secretary to the Government of West Bengal, Department of Higher Education, University Branch regarding grant of Dearness Allowance (DA) to the regular Teaching and Non-teaching employees and Dearness Relief (DR) for the Pensioners of the State-aided Universities with effect from 01.03.2023.

**Resolution:** *The Executive Council of Vidyasagar University noted the letter bearing No. 237(31)-Edn(U)/1U-01/14 dated 10.03.2023 received from the Assistant Secretary to the Government of West Bengal, Department of Higher Education, University Branch alongwith forwarding the Finance (Audit) Department Memorandum No. 850-F(P2) dated 24.02.2023 regarding the matter of grant of Dearness Allowance and Dearness Relief with effect from 01.03.2023 for the regular Teachers, Officers, Non-Teaching Employees, Pensioners of the State-aided Universities and requested to act accordingly.*

*After thorough discussion on the letter submitted by Shri Soumya Chakraborti, Computer Officer (Contractual), Centre for Distance and Online Education (CDOE) of Vidyasagar University praying for issuance of No Objection Certificate in favour of him for admission into BLISc Course at the Netaji Subhas Open University under distance mode for the academic session 2022-2023, it was decided that the Registrar and the Establishment Section of this University be requested to process further regarding this.*

- 06(t) To place before the Executive Council of Vidyasagar University, the letter dated 10.12.2022 submitted by Shri Prabir Das, Driver of Vidyasagar University regarding his reply to the Charges leveled against him.

**Resolution:** *Consideration of the item was deferred.*

- 06(u) To place before the Executive Council of Vidyasagar University, the Order bearing G.O. (Ms)No. 259 dated 18.11.2022 issued by the Principal Secretary, Higher Education (J1) Department, Tamil Nadu Government by order of the Governor regarding equivalence of B.Tech (Hons.) in Chemical Engineering awarded by Vidyasagar University as B.E./B.Tech. in Chemical Engineering for the purpose of higher studies.

**Resolution:** *The Executive Council of Vidyasagar University noted the Order bearing G.O. (Ms)No. 259 dated 18.11.2022 issued by the Principal Secretary, Higher Education (J1) Department, Tamil Nadu Government by order of the Governor stating that the Government after careful consideration approved the resolution passed in the 17th Equivalence Committee in its meeting held on 20.12.2022 under the Chairmanship of the Principal Secretary to the Government and directed that the degrees in B.Tech.(Hons.) in Chemical Engineering offered by Vidyasagar University be equivalent to the similar degrees of B.E./B.Tech. in Chemical Engineering for the purpose of higher studies.*

*After thorough discussion on the Order bearing G.O. In this connection she has requested to permit her to pursue the same.*

*After thorough discussion on the letter submitted by Ms. Rinku Mukhi, Junior Peon of Vidyasagar University seeking permission for pursuing M.A. course from Netaji Subhas Open University for the academic session 2023-2024, it was*

*resolved that the Registrar and the Establishment Section of this University be requested to process further in this regard.*

- 06(w) To place before the Executive Council of Vidyasagar University, the final draft of "Institutional OER (Open Educational Resources) Policy of Vidyasagar University".

**Resolution:** *Consideration of the item was deferred.*

- 06(x) To place before the Executive Council of Vidyasagar University, the Budget Estimate for the year 2023-2024 and Revised Budget Estimate for the year 2022-2023 of Vidyasagar University.

**Resolution:** *Consideration of the item was deferred as no such Budget book was received from the Finance Officer of this University although the Finance Officer was informed regarding this long ago by the Registrar and the Accounts Officer of this University was also contacted to send those required documents by the Registrar's office over phone. Resolved that the Finance Officer of this University be requested to provide such document to the Registrar well in advance for consideration henceforth.*

- 06(y) To place before the Executive Council of Vidyasagar University, the Note Sheet dated 16.03.2023 prepared and submitted by the Registrar regarding the proposals for appointment of a whole-time Medical Officer for the Medical Unit of Vidyasagar University.

**Resolution:** *Consideration of the item was deferred.*

- 06(z) To consider the letter dated 26.04.2023 submitted by Ms. Gita Jani, wife of Late Dhanapati Jani, former Group-D Staff of Vidyasagar University, praying for release of the death benefits & family pension of her husband Late Dhanapati Jani and also permit her to stay at the Bankim Chandra Abasan as usual.

**Resolution:** *The Executive Council of Vidyasagar University noted the letter dated 26.04.2023 submitted by Ms. Gita Jani, wife of Late Dhanapati Jani, former Group-D staff of Vidyasagar University stating that her husband, Late Dhanapati Jani expired in service on 04.12.2022 and till date they have not received the death benefits and family pension of her dead husband. They are staying now at the Bankim Chandra Abasan with the permission of the University authority. Due to shortage of money they could not vacate the said Abasan. In this connection she has requested to kindly release the death benefits & family pension of her dead husband immediately. She has also requested to permit her to stay in the said Abasan of Vidyasagar University till release of such benefits and pension.*

*After thorough discussion on the letter submitted by Ms. Gita Jani, wife of Late Dhanapati Jani, former Group-D Staff of Vidyasagar University, praying for release of the death benefits & family pension of her husband Late Dhanapati Jani and also permit her to stay at the Bankim Chandra Abasan as usual, it was resolved that Ms. Jani be permitted to stay in the Unit No. 20 of Bankim Chandra Abasan of Vidyasagar University which was allotted in favour of her dead husband, for a further period of six months with effect from 01.03.2023 or until further order whichever is earlier as a special case on sympathetic and humanitarian ground. Resolved further that the Registrar of this University be requested to communicate the same to the incumbent concerned.*

06(z-1) To consider the Leave Application dated 25.04.2023 submitted by Professor Samir Kumar Ghosh, Department of Commerce of Vidyasagar University praying for granting of medical leave during the period from 12.01.2023 to 23.04.2023 taken by him for suffering from Trochanteric fracture in left Femur.

**Resolution:** *The Executive Council of Vidyasagar University noted the leave application through Leave Management System of Vidyasagar University alongwith the discharge certificate submitted by Professor Samir Kumar Ghosh, Department of Commerce of Vidyasagar University praying for granting of medical leave during the period from 12.01.2023 to 23.04.2023 taken by him for suffering from trochanteric fracture in left Femur. The Executive Council noted also the medical document submitted by Professor Ghosh in support of such treatment. After thorough discussion on the Leave Application submitted by Professor Samir Kumar Ghosh, Department of Commerce of Vidyasagar University praying for granting of medical leave during the period from 12.01.2023 to 23.04.2023 taken by him for suffering from Trochanteric fracture in left Femur and careful consideration of the medical supporting document, it was resolved that the medical leave during the period from 12.01.2023 to 23.04.2023 as prayed for by Professor Ghosh be granted to him for this purpose as per the norms of the University. Resolved further that the Registrar and the Establishment Section of this University be requested to process further in this regard.*

06(z-2) To consider the Leave Application dated 17.03.2023 submitted by Shri Nandan Mondal, Junior Assistant-cum-Typist of Vidyasagar University praying for granting of medical leave during the period from 13.02.2023 to 16.03.2023 taken by him for the treatment of his left knee injury.

**Resolution:** *The Executive Council of Vidyasagar University noted the leave application through Leave Management System of Vidyasagar University alongwith the medical supporting documents submitted by Shri Nandan Mondal, Junior Assistant-cum-Typist of Vidyasagar University praying for granting of medical leave during the period from 13.02.2023 to 16.03.2023 taken by him for the treatment of his left knee injury. The Executive Council noted also the medical documents submitted by Shri Mondal in support of such treatment. After thorough discussion on the Leave Application submitted by Shri Nandan Mondal, Junior Assistant-cum-Typist of Vidyasagar University praying for granting of medical leave during the period from 13.02.2023 to 16.03.2023 taken by him for the treatment of his left knee injury and careful consideration of the medical supporting documents, it was resolved that the medical leave during the period from 13.02.2023 to 16.03.2023 as prayed for by Shri Mondal be granted to him for this purpose as per the norms of the University. Resolved further that the Registrar and the Establishment Section of this University be requested to process further in this regard.*

06(z-3) To consider the proposal bearing letter No. VU/DO/80/2023 dated 12.04.2023 submitted by the Development Officer of Vidyasagar University regarding re-constitution of various committees of Vidyasagar University.

**Resolution:** *The Executive Council of Vidyasagar University noted the proposal bearing letter No. VU/DO/80/2023 dated 12.04.2023 submitted by the Development Officer of Vidyasagar University alongwith the list of existing committee members of various committees, proposing for re-constitution of various committees of Vidyasagar University, like, Works & Tender Committee, Maintenance/Repairing Committee, Space, Planning and Development Committee, Canteen Supervision*

*Committee, Committee for Beautification and Naming of the Buildings of Vidyasagar University, Equal Opportunity Cell, SC/ST Complaint Cell etc. After thorough discussion on the letter submitted by the Development Officer of Vidyasagar University regarding re-constitution of various committees of Vidyasagar University, it was resolved that the matter be left to the Hon'ble Vice-Chancellor to take necessary action in this regard in discussion with Professor Brajaballav Pal, Head, Department of Commerce, Professor Biswapati Jana, Head, Department of Computer Science, Professor Sumita Roy, Head, Department of Chemistry and the Registrar of Vidyasagar University.*

- 06(z-4) To nominate one member from among its own members other than the Deans to the Finance Committee of Vidyasagar University in place of Dr. Pabitra Kumar Mishra, Principal, Bhatler College, Dantan.

**Resolution:** *The Executive Council of Vidyasagar University noted that Dr. Pabitra Kumar Mishra, Principal, Bhatler College, Dantan and one of the members of the Ninth Executive Council of Vidyasagar University was nominated by the Executive Council from among its own members other than Deans as a Member to the Finance Committee of Vidyasagar University in terms of the provision of 32(f) of the Vidyasagar University First Statutes, 1983 as amended from time to time. The Executive Council noted further that now Dr. Mishra has retired from his service with effect from 31.03.2023. In this connection the Finance Officer submitted a proposal bearing letter No. VU/FO/043/2023 dated 13.04.2023 regarding nomination of one member to the Finance Committee in place of Dr. Mishra in terms of the said provision. The Executive Council noted again the point raised by the Registrar that he was not invited in the Emergency Meeting of the Finance Committee of Vidyasagar University held on 27.04.2023 related to the payment of legal bills received from the Lawyers who are rendering the legal services on behalf of the University although his presence in the meeting was essential and also he has been attending the meetings of the Finance Committee of Vidyasagar University as an Invitee since last so many years.*

*After thorough discussion on the matter regarding nomination of one member from among its own members other than the Deans to the Finance Committee of Vidyasagar University in place of Dr. Pabitra Kumar Mishra, Principal, Bhatler College, Dantan, it was resolved that Dr. Mantu Kumar Das, Principal, Ghatal Rabindra Satabarshiki Mahavidyalaya be nominated from among its own members other than Deans as EC nominee to the Finance Committee of Vidyasagar University in terms of the provision of 32(f) of the Vidyasagar University First Statutes, 1983 as amended from time to time. Resolved further that the Registrar be requested to put his observation as he has not been invited in the meeting of the Finance Committee of Vidyasagar University.*

- 06(z-5) To consider the letter dated 13.04.2023 submitted by Dr. Amal Kumar Bhunia, Deputy Registrar (Administration) of Vidyasagar University praying for relinquishing him from looking after the assignment of Security and House-Keeping Services.

**Resolution:** *Consideration of the item was deferred.*

- 06(z-6) To place before the Executive Council of Vidyasagar University, the Note Sheet dated 23.03.2023 prepared and submitted by the Registrar regarding non-marking of regular attendance through the biometric system by Dr. Amal Kumar Bhunia, Deputy Registrar (Administration) of Vidyasagar University.

**Resolution:** *The Executive Council of Vidyasagar University noted the Note Sheet dated 23.03.2023 prepared and submitted by the Registrar stating that it has been observed from the biometric attendance record that Dr. Amal Kumar Bhunia, Deputy Registrar (Administration) of Vidyasagar University did not mark his attendance through the biometric system since a long period of time without any information/intimation to the University authority resulting in we failed to understand his presence and absence regularly while other officers are marking their attendance through biometric system regularly as per the norms of the University. The Executive Council noted also that like other officers, the biometric attendance of Dr. Bhunia is required regularly for keeping his day to day attendance records of the University. The Executive Council noted further as follows :*

- (i) *Dr. Bhunia remained absent on 26.04.2023 without the information and prior approval of the competent authority ;*
- (ii) *on 25.04.2023 Dr. Bhunia left the University at around 3-00 P.M. without the information and prior approval of the competent authority ;*
- (iii) *on 18.04.2023 Dr. Bhunia visited to the office of the District Magistrate, Paschim Medinipur for any purposes without the information and prior approval of the University authority and introduced himself as a Registrar to the said office ;*
- (iv) *Dr. Bhunia called up to the Hon'ble Vice-Chancellor on 18.04.2023 in the evening and handed over the phone to the District Magistrate, Paschim Medinipur without prior briefing to the Hon'ble Vice-Chancellor which put him an awkward situation when he was busy with an urgent official work ;*
- (v) *the Sub-Divisional Officer, Medinipur Sadar, Paschim Medinipur in a meeting dated 28.04.2023 reported that Dr. Bhunia introduced himself over a phone call as a Registrar of Vidyasagar University, on a date.*

*The Executive Council condemned the above activities made by Dr. Bhunia and it was decided that henceforth Dr. Bhunia be requested not to communicate any official views/opinions to any officials (external) without the knowledge of the Vidyasagar University authority, not to introduce himself as Registrar to anybody which is misleading information and also not to handover any phone call to anybody to talk to the Hon'ble Vice-Chancellor without prior briefing the purpose of such a call. Resolved further that the Registrar be requested to communicate the same to the incumbent concerned in this regard.*

- 06(z-7) To consider the application dated 24.04.2023 submitted by Shri Ratan Mishra, a contractual employee of Vidyasagar University, praying for granting of Special Medical Leave during the period from 10.04.2023 to 19.05.2023 taken by him for his spine surgery.

**Resolution:** *The Executive Council of Vidyasagar University noted the Note sheet dated 26.04.2023 prepared and submitted by the Establishment Section of Vidyasagar University based on the application submitted by Shri Ratan Mishra at present engaged in the office of the Registrar purely on contractual basis praying for granting of Special Medical Leave during the period from 10.04.2023 to 19.05.2023 taken by him for his spine surgery, stating that in terms of the decision taken by the Executive Council vide Circular No. VU/R/Circular/8EC-25/C0360/2019 dated 30.07.2019, fourteen days Special Leave on medical ground is granted to an employee engaged in Vidyasagar University purely on contractual basis and in case of Shri Mishra, out of total 39 days of leave, 14 days may be granted to him as special leave on medical ground and rest of the days may be granted to him leave without pay.*

After thorough discussion on note sheet prepared and submitted by the Establishment Section of this University based on the application dated 24.04.2023 submitted by Shri Ratan Mishra, a contractual employee of Vidyasagar University, praying for granting of Special Medical Leave during the period from 10.04.2023 to 19.05.2023 taken by him for his spine surgery, it was resolved that out of total thirty nine (39) days of leave, fourteen (14) days leave with pay on medical ground and the rest of twenty five (25) days leave without pay on medical ground be granted to Shri Mishra for this purpose as per the norms of the University. Resolved further that the Registrar and the Establishment Section of this University be requested to process further in this regard.

- 06(z-8) To place before the Executive Council of Vidyasagar University, the Notification bearing Memo No. HF/SPSRC/22/2022/Pt.I/26 dated 17.03.2023 issued by the Principal Secretary to the Government of West Bengal, Department of Health and Family Welfare regarding formation of the West Bengal Allied and Healthcare Council.

**Resolution:** The Executive Council noted the Notification bearing Memo No. HF/SPSRC/22/2022/Pt.I/26 dated 17.03.2023 issued by the Principal Secretary to the Government of West Bengal, Department of Health and Family Welfare stating that the Governor is pleased to constitute the West Bengal Allied and Healthcare Council consisting of the members specified therein with immediate effect as referred to by the National Commission for Allied and Health Care Professions Act (NCAHP) 2021 vide section 22 of the Act.

**Resolution:** The Executive Council of Vidyasagar University noted the proposal alongwith the existing members of different committees prepared and submitted by the Executive Director of Computer Centre requesting for re-constitution of the ICT - MIS Committee, Betar Vidyasagar Committee and Fire Fighting and Fire Safety Committee of Vidyasagar University and others etc.

After thorough discussion on the proposal submitted by the Executive Director of Computer Centre of Vidyasagar University regarding re-constitution of various committees for resolving different IT related issues of Vidyasagar University, it was resolved that the matter be left to the Hon'ble Vice-Chancellor to take necessary action in this regard in discussion with Professor Brajaballav Pal, Head, Department of Commerce, Professor Biswapati Jana, Head, Department of Computer Science, Professor Sumita Roy, Head, Department of Chemistry and the Registrar of Vidyasagar University.

06(z-10) To consider the proposal bearing letter No. VU/CL/VC/38/23 dated 12.04.2023 submitted by the Assistant Librarian & Incharge of Central Library of Vidyasagar University regarding formation of a New Library Committee for the Central Library of Vidyasagar University.

**Resolution:** *The Executive Council of Vidyasagar University noted the proposal bearing letter No. VU/CL/VC/38/23 dated 12.04.2023 submitted by the Assistant Librarian & Incharge of Central Library of Vidyasagar University stating that the validity of the existing Library Committee of Vidyasagar University has already expired and the new Library Committee needs to be created on priority basis. *After thorough discussion on the proposal submitted by the Assistant Librarian & Incharge of Central Library of Vidyasagar University regarding formation of a New Library Committee for the Central Library of Vidyasagar University, it was resolved that the matter be left to the Hon'ble Vice-Chancellor to take necessary action in this regard in discussion with Professor Brajaballav Pal, Head, Department of Commerce, Professor Biswapati Jana, Head, Department of Computer Science, Professor Sumita Roy, Head, Department of Chemistry and the Registrar of Vidyasagar University.*

06(z-11) To place before the Executive Council of Vidyasagar University, the Note Sheet bearing No. VU/UE/163/2023 dated 12.04.2023 jointly submitted by the Joint Incharge of Engineering Section of Vidyasagar University regarding formation of the new AC (Air Conditioned) Committee of Vidyasagar University.

**Resolution:** *The Executive Council of Vidyasagar University noted the Note Sheet bearing No. VU/UE/163/2023 dated 12.04.2023 jointly submitted by the Joint Incharge of Engineering Section of Vidyasagar University proposing for formation of new AC Committee for smooth processing of the requisitions for AC installation received from different stakeholders as the existing AC Installation Committee is non-functioning.*

*After thorough discussion on the Note Sheet jointly submitted by the Joint Incharge of Engineering Section of Vidyasagar University regarding formation of the new AC (Air Conditioned) Committee of Vidyasagar University, it was resolved that the matter be left to the Hon'ble Vice-Chancellor to take necessary action in this regard in discussion with Professor Brajaballav Pal, Head, Department of Commerce, Professor Biswapati Jana, Head, Department of Computer Science, Professor Sumita Roy, Head, Department of Chemistry and the Registrar of Vidyasagar University..*

06(z-12) To place before the Executive Council of Vidyasagar University, the Note Sheet dated 12.04.2023 jointly submitted by the Development Officer and the Accounts Officer of Vidyasagar University regarding sending the five proposed projects to the Department of Higher Education, Government of West Bengal for getting final administrative approval and financial approval during 2023-2024.

**Resolution:** *The Executive Council of Vidyasagar University noted the Note Sheet dated 12.04.2023 jointly submitted by the Development Officer and the Accounts Officers of this University regarding sending of five (05) numbers of projects, namely, construction of Vice-Chancellor Bungalow, balance portion of Internal Bituminous Road including side drain within the campus, construction of Gate No. 2, one staff quarter (3-storied), vertical extension of new Humanities Building (2nd, 3rd & 4th floor) and a Swimming Pool etc. with revised DPR to the Department of Higher Education, Government of West Bengal for final administrative approval and financial approval 2023-2024.*

Resolved also that the Executive Engineer of P.W.Dte., Government of West Bengal be requested to prepare the revised Detailed Project Proposal (DPR) for construction of Gate No. - 2 of the University, one 3-stories staff quarter, vertical extension of new Humanities Building (2nd, 3rd & 4th floor) and a Swimming Pool etc. for onwards transmission of the same to the Department of Higher Education, Government of West Bengal for final administrative and financial approval. Resolved further that the Development Officer and the Joint Incharge of Engineering Section of Vidyasagar University be requested to co-ordinate the whole process in this regard.*

06(z-13) To place before the Executive Council of Vidyasagar University, the Note Sheet dated 10.04.2023 prepared and submitted by the Inspector of Colleges of Vidyasagar University seeking advice regarding further extension of affiliation to IQ City United World School of Business, Kolkata for conducting the BBA and MBA programmes without the approval of the AICTE.

**Resolution:** *The Executive Council of Vidyasagar University noted the Note Sheet dated 10.04.2023 prepared and submitted by the Inspector of Colleges of Vidyasagar University stating that Vidyasagar University provided affiliation to IQ City United World Schools of Business, Kolkata from the academic session 2020-2021 for conducting BBA and MBA programme for two years with a condition that the Institution will obtain approval from the AICTE in this regard in due course of time. Such affiliation was renewed for 2022-2023. Now they have applied for further extension with effect from 2023-2024 and after enquiry the approval of the AICTE in this regard they submitted an undertaking to the effect that they will obtain the same within a span of three years. In this connection, the Inspector of Colleges has sought for the direction for further extension in this regard.*

*After thorough discussion on the Note Sheet prepared and submitted by the Inspector of Colleges of Vidyasagar University seeking advice regarding further extension of affiliation to IQ City United World School of Business, Kolkata for conducting the BBA and MBA programmes without the approval of the AICTE, it was resolved that the same Committee consisting of (1) Professor Sebak Kumar Jana, Department of Economics of Vidyasagar University as Chairperson, (2) Professor Biswapati Jana, Department of Computer Science of Vidyasagar University, (3) Professor Brajaballav Pal, Department of Commerce of Vidyasagar University, (4) Professor Surajit Ghosh, Department of Physics of Vidyasagar University, (5) Professor Anandamohan Pal, Department of Business Management, University of Calcutta and (6) the Inspector of Colleges of Vidyasagar University - as Convener as has been constituted vide Item No. 06(a) be requested to look into the matter considering the measures specified therein. Resolved further that the Registrar be requested to process further in this regard.*

06(z-14) To place before the Executive Council of Vidyasagar University, the Note Sheet dated 18.04.2023 prepared and submitted by the Registrar of Vidyasagar University regarding insertion of one agenda Item in the confirmed resolutions of the Fourteenth (14th) meeting of the Ninth Executive Council of Vidyasagar University held on 29.06.2022.

**Resolution:** *The Executive Council of Vidyasagar University noted the Note Sheet dated 18.04.2023 prepared and submitted by the Registrar of Vidyasagar University stating that one agenda item regarding modified revision of professional fees for rendering the legal services towards Vidyasagar University at the High Court, Calcutta submitted by Ms. Debjani Sengupta, Advocate, High Court, Calcutta was placed before the Fourteenth (14th) meeting of the Ninth Executive Council of Vidyasagar University held on 29.06.2022 on table wherein it was considered and accepted with effect from 06.06.2022. The decision of the Executive Council also communicated to the incumbent concerned accordingly. Now, it has been observed from the confirmed resolutions of the Fourteenth meeting of the Ninth Executive Council already signed by the then Chairman and uploaded on the University website, inadvertently, such item has not been inserted in the said confirmed resolution. This particular item should be inserted in the resolutions as it was considered by the Executive Council in its aforesaid meeting.*

*After thorough discussion on the Note Sheet prepared and submitted by the Registrar of Vidyasagar University regarding insertion of one agenda Item in the confirmed resolutions of the Fourteenth (14th) meeting of the Ninth Executive Council of Vidyasagar University held on 29.06.2022, it was resolved that the said confirmed resolutions of the Fourteenth (14th) meeting of the Ninth Executive Council of this University held on 29.06.2022 be uploaded again on the University website inserting such missing agenda and the resolutions will be signed by the then Vice-Chancellor, Professor Sibaji Pratim Basu. Resolved further that the Registrar be requested to process further in this regard.*

06(z-15) To consider the letter dated 27.04.2023 submitted by Shri Biplab Chakraborty, Controller of Examinations of Vidyasagar University praying for accepting his resignation from the post of Controller of Examinations of this University and to permit him to join his previous position of Information Scientist within the lien period.

**Resolution:** *The Executive Council of Vidyasagar University noted the letter dated 27.04.2023 submitted by Shri Biplab Chakraborty, Controller of Examinations of Vidyasagar University stating that he assumed the position of Controller of Examinations of Vidyasagar University with effect from 15.06.2022. Before taking such an assignment, he spent 23 years as the Information Scientist in this University. He has a technical background and his previous post of Information Scientist was in technical nature. Now he is unable to acclimatize to the typical administrative work procedure in the post of Controller of Examinations because the most of his career has been spent as professional expert in the computer and library fields and his current position is entirely administrative in nature. Due to this he intends to tender his resignation from the post of Controller of Examinations and return to his previous position of Information Scientist in this University on fulfillment of formalities. In this connection he has requested to accept his resignation from the post of Controller of Examinations and release him from the said post as soon as possible and also permit him to join his previous position of System Analyst within the lien period. The Executive Council noted also from the said letter that Shri Chakraborty has not received any additional*

increments after taking the position of Controller of Examinations. He did not receive his regular increment also in the month of July, 2022 since the pay fixation was done using the salary from May, 2022, following the rules ( as per information from the finance department). In this situation, presently he is losing Rs.4,869/- per month in basic pay, and since DA is calculated based on the basic pay, this has a cumulative effect on his overall salary in due course of time as stated by him. The Executive Council noted further that based on the similar letter submitted by Shri Chakraborty in this regard, the Executive Council in its earlier meeting (Fifteenth) held on 09.09.2022 decided that one additional increment be given in favour of Shri Chakraborty to his new post of Controller of Examinations and the matter be forwarded to the Committee constituted for this purpose.

After thorough discussion on the letter submitted by Shri Biplab Chakraborty, Controller of Examinations of Vidyasagar University praying for accepting his resignation from the post of Controller of Examinations of this University and to permit him to join his previous position of Information Scientist within the lien period, it was resolved as follows :

- (i) regarding non-receipt of additional increments after taking the assignment as Controller of Examinations, regular increment in the month of July, 2022 etc., the matter be forwarded to the Finance Officer of Vidyasagar University for taking necessary action in this regard as per the norms of the University and also considering the decision taken by the Executive Council in its earlier meeting (Fifteenth) held on 09.09.2022 based on the similar letter bearing No. VU/CE/IN/279/22 dated 04.08.2022 submitted by Shri Chakraborty and duly communicated to the Finance Officer of this University in this regard;
- (ii) regarding submission of resignation from the post of Controller of Examinations, Shri Chakraborty be requested to re-think the matter and to continue in the post of Controller of Examinations of Vidyasagar University as usual.

06(z-16) To place before the Executive Council of Vidyasagar University, the letter dated 23.03.2023 submitted by some employees of Vidyasagar University regarding complaints pertaining to some issues of Vidyasagar University.

**Resolution:** The Executive Council of Vidyasagar University noted the letter dated 23.03.2023 submitted by some employees of Vidyasagar University without disclosing their names and signatures addressed to His Excellency the Governor of West Bengal & Hon'ble Chancellor of Vidyasagar University requesting to conduct a thorough enquiry into the complaints for the greater interest of the University, a copy of which was forwarded to us. The Executive Council noted the content of the letter stating that after joining Shri Gautam Pal as Finance Officer of Vidyasagar University, the environment of the Finance Section of Vidyasagar University is being ruined. He does not try to do any work himself or does not allow his subordinate officers and employees below him to do it. He is always putting unnecessary notes on any paper. He always busy in his office chamber gossiping with Dr. Amal Kumar Bhunia, Deputy Registrar (Admin). Most of the bills of the project, projects fellows, research scholar are due but the bills of Rs.16,000/- (Rupees Sixteen thousand) only of Dr. Amal Kumar Bhunia, Deputy Registrar (Administration) was paid by the Finance Officer which was placed by Dr. Bhunia directly to the finance section without any approval of the authority. Dr. Bhunia submits a bill of Rs.2,000/- (Rupees two thousand) only every month for tea of one person directly to the Finance Department and those bills are paid by the Finance Department. An advance of Rs.45,000/- (Rupees Forty Five thousand) only was

paid to Shri Suhas Barik, Sports Officer without any approval of the University authority. Dr. Bhunia and Shri Pal both are busy to plan how they will harass the University authority, teachers and other officers and earn money illegally etc. In this connection they requested to conduct a thorough enquiry and solve those issues.

After thorough discussion on the letter submitted by some employees of Vidyasagar University regarding complaints pertaining to some issues of Vidyasagar University, it was resolved that the said letter be forwarded to the Committee consisting of (1) Professor Kalpataru Bandyopadhyay as Chairperson, Department of Commerce, (2) the Head, Department of Commerce, (3) Dr. Tarak Nath Sahu, Department of Business Administration and (4) the Accounts Officer as Convener as constituted vide Item No. 06(n) for taking necessary measures to enquire the details after checking the original bills and vouchers & these documents and provide their observations, suggestions, findings, recommendations in this regard. The Committee may consult other officials, if required, in this regard.

06(z-17) To consider the proposal bearing letter No. VU/CES/222/23 dated 13.04.2023 submitted by Dr. Jatisankar Bandyopadhyay, Associate Professor, Department of Remote Sensing & GIS and Principal Investigator, ESSO-INCOIS, Govt. of India regarding establishment of Coastal Observatory and Outreach Centre (COOC) of Vidyasagar University.

**Resolution:** The Executive Council of Vidyasagar University noted the proposal bearing letter No. VU/CES/222/23 dated 13.04.2023 submitted by Dr. Jatisankar Bandyopadhyay, Associate Professor, Department of Remote Sensing & GIS and Principal Investigator, ESSO-INCOIS, Govt. of India alongwith a detailed proposal regarding establishment of "Coastal Observatory and Outreach Centre (COOC)" of Vidyasagar University in collaboration with INCOIS, Govt. of India and Fisheries Department, Government of West Bengal for consideration. The Executive Council also noted the detailed proposal submitted by Dr. Bandyopadhyay in this regard.

After thorough discussion on the submitted by Dr. Jatisankar Bandyopadhyay, Associate Professor, Department of Remote Sensing & GIS and Principal Investigator, ESSO-INCOIS, Govt. of India regarding establishment of Coastal Observatory and Outreach Centre (COOC) of Vidyasagar University, it was resolved that the said proposal regarding establishment of Coastal Observatory and Outreach Centre be accepted and Dr. Jatisankar Bandyopadhyay, the Principal Investigator of the project be requested to process further in this regard. Resolved further that the Registrar of this University be requested to communicate the same to the incumbent concerned for this purpose.

06(z-18) To place before the Executive Council of Vidyasagar University, the Note Sheet dated 22.03.2023 prepared and submitted by the Registrar of Vidyasagar University regarding placement/promotion of teachers of this University under the Career Advancement Scheme (CAS).

**Resolution:** The Executive Council of Vidyasagar University noted the Note Sheet dated 22.03.2023 prepared and submitted by the Registrar of Vidyasagar University stating that as per our records the placement/promotion of the following teachers of Vidyasagar University have already been due and under pending for a long period. Now the necessary initiative to conduct the Selection Committee/ Screening Committee meetings for this purpose is to be taken as per the norms of the University.

06(z-19) To place before the Executive Council of Vidyasagar University, the letter bearing D.O. No. F.2-10/2022 (CPP-II) dated 08.04.2022 issued by the Secretary, University Grants Commission, New Delhi regarding compliance of UGC (Grant of Degrees and other Awards by Universities) Regulations - 2008.

**Resolution:** The Executive Council of Vidyasagar University noted the letter bearing D.O. No. F.2-10/2022 (CPP-II) dated 08.04.2022 issued by the Secretary, University Grants Commission, New Delhi stating that the Commission has been receiving a large number of grievances/complaints/RTIs/queries from students enrolled in different programs of study offered by Higher Education Institutions regarding the delay in awarding the Degrees. The Commission has taken a serious

view of this issue and in this connection the attention of all Higher Educational Institutions is invited to the UGC letter bearing D.O. No. F.1-1/2-16 (Secy) dated 19.03.2016. It is also stated that getting a degree in time after having successfully completing a program is an inviolable privilege of a student. Considering the huge significance of this privilege, the Commission notified full-fledged regulation entitled UGC (Grant of Degrees and Other Awards by Universities) Regulations, 2008, the regulation 4.4 of which mandates that : "the Degree award date/s shall be within 180 days of the date/s by which the students are expected to qualify and become eligible for them". The Secretary has requested all Higher Educational Institutions to ensure compliance of the UGC regulations and award the degree to all successful candidates within the prescribed timeline. Also requested to issue a provisional degree alongwith the final year transcripts to students.

After thorough discussion on the letter issued by the Secretary, University Grants Commission, New Delhi regarding compliance of UGC (Grant of Degrees and other Awards by Universities) Regulations – 2008, it was resolved that necessary initiative be taken to conduct the University Convocation as early as possible. Resolved further that the Registrar of this University be requested to process further in this regard.

- 06(z-20) To place before the Executive Council of Vidyasagar University, the matter regarding selection of the Agency for rendering the House-Keeping Services at the Vidyasagar University Campus.

**Resolution:** The Executive Council of Vidyasagar University noted that M/s. HRD Commercial & Industrial Security Force Pvt. Ltd., Kolkata was selected as the lowest tenderer (L1) for rendering the House-Keeping Services at Vidyasagar University although the rate for the consumable materials per month per head was slight high as per the quotation submitted by them through e-Tender bearing NIeT No. WB/VU/NIeT-03/21-22, Tender ID : 2022VU-364294-1. The Executive Council noted further that the Tender Committee decided that M/s. HRD Commercial & Industrial Security Force Pvt. Ltd. be selected for rendering such service at Vidyasagar University provided that the rate for consumable materials may be finalized with negotiation of the concerned vendor. After negotiation the concerned vendor has agreed the rate for such materials of Rs.75/- (Rupees Seventy Five) only per head per month and they have submitted a declaration in this regard. The Executive Council noted also the offer letter prepared by the Deputy Registrar (Administration) in favour of M/s. HRD Commercial & Industrial Security Force Pvt. Ltd. for this purpose is back dated. The Executive Council noted further that the Deputy Registrar (Administration) did not take necessary steps in the matter in due course of time.

After thorough discussion on the matter regarding selection of the Agency for rendering the House-Keeping Services at the Vidyasagar University Campus, it was resolved that the Deputy Registrar (Administration) of this University be re-directed to submit a proposal in this regard after taking into consideration the scope of e-tender as a fresh. Resolved further that the Registrar of this University be requested to communicate the same to the incumbent concerned for this purpose.

**Resolution:** The Executive Council of Vidyasagar University noted the letter bearing No. MCC/TIC-REG/04/23-7653 dated 12.04.2023 submitted by the Teacher-

*in-Charge, Midnapore City College stating that they have admitted twenty three (23) extra students at M.Sc. in Agriculture in Agronomy beyond the approved intake of fifteen (15) and seven (07) extra students at Agriculture in Genetics & Plant Breeding beyond the approved intake of fifteen (15) for the academic session 2022-2023. In this connection, the Teacher-in-Charge has requested to allow the above extra students for registration.*

*After thorough discussion on the letter submitted by the Teacher-in-Charge, Midnapore City College regarding increasing of the intake capacity of M.Sc. in Agriculture in Agronomy and Agriculture in Genetics & Plant Breeding from the academic session 2022-2023, it was resolved that a Committee consisting of (1) Professor Jayanta Kumar Kundu, Department of Zoology as Chairperson, (2) Professor Prakash Karmakar, Department of Botany, (3) Dr. Asis Kumar Nandi, Department of Botany and (4) the Inspector of Colleges as Convener be constituted to visit the concerned institute to see all aspects, like, library facility, faculty staff, physical infrastructure etc. for this purpose and to submit a detailed report in this regard for further consideration of the Executive Council. Resolved further that the Registrar of this University be requested to process further in this regard.*

06(z-22) To consider the letter bearing No. MCC/TIC-REG/04/23-7654 dated 12.04.2023 submitted by the Teacher-in-Charge, Midnapore City College seeking permission for admission of the students who have passed their undergraduate programmes in 2020 into different postgraduate programmes of the college for the academic session 2022-2023.

**Resolution:** *The Executive Council of Vidyasagar University noted the letter bearing No. MCC/TIC-REG/04/23-7654 dated 12.04.2023 submitted by the Teacher-in-Charge, Midnapore City College stating that they have admitted thirty three (33) numbers of students who have passed their undergraduate programmes in the year 2020 into different postgraduate programmes for the academic session 2022-2023. In this connection the Teacher-in-Charge has requested to allow the above students for their study.*

- (c) *the content of the letter dated 06.05.2023 received through mail from Bijan Sarkar without disclosing his identity, regarding necessity to host workshop on "Fake degrees and experience certificates for obtaining government job in the historical perspective of West Bengal. Such mail was also marked copy to the faculty members of Vidyasagar University and others ;*
- (d) *the content of the letter dated 10.05.2023 received through mail from Shri Paritosh Banerjee of 59/2C, Panjabari Road, Guwahati regarding the time is tough with corruption being the core problem with the University ;*
- (e) *the personal and confidential documents in respect of Dr. Jayanta Kishore Nandi, the present Registrar of Vidyasagar University submitted by Ms. Soma Roy alongwith her allegation might have been taken illegally for making copy thereof from the University by the author of the letter with the illegal help of some internal University stakeholders otherwise an outsider cannot get access to such confidential documents.*

- (f) *the author of the email dated 27.04.2023 sent by Ms. Soma Roy advised the Hon'ble Vice-Chancellor to give the charge of the custodianship of all University records and documents to the Inspector of Colleges or the Finance Officer though as per the Act and Statute of the University, the Registrar is the custodian of all University documents and records ;*
- (g) *the allegations made by the authors of the emails without disclosing their identities against some stakeholders of Vidyasagar University are fake, fabricated, manufactured, concocted and trying to defame/malign the image of the Hon'ble Vice-Chancellor, Registrar and others of Vidyasagar University with ulterior motive.*
- (h) *the similar type of allegations made by the offenders against the selection of Dr. Jayanta Kishore Nandi as the then Dean of Students' Welfare in the earlier occasion and based on the report of the Academic Audit Cell of Vidyasagar University constituted for this purpose, the Executive Council in its Emergency meeting held on 17.06.2014 disapproved the actions in the context of unnecessary misguiding, false media reports and letter of allegation and directed to upload the substantive part of the enquiry report in the public domain in the interest of transparency.*
- (i) *as desired by the Assistant Secretary to the Government of West Bengal, Department of Higher Education, University Branch regarding submission of a report pertaining to allegations against gross irregularity and flouting of Govt. rules in recruitment of Dr. J.K. Nandi as Dean of Students' Welfare and Registrar (Actg.) of Vidyasagar University, a detailed report of the Academic Audit Cell of Vidyasagar University in this regard was sent to the Secretary of the Higher Education Department for his kind perusal and information by the then Vice-Chancellor, Professor Ranjan Chakrabarti on 13.06.2014.*

*After thorough discussion on the allegations made by different authors especially of the e-mail sent by Ms. Soma Roy without disclosing her identity against the Hon'ble Vice-Chancellor and the Registrar of Vidyasagar University and based on the decision taken by the Executive Council in its earlier meeting on the basis of the report of the Academic Audit Cell of Vidyasagar University, it was resolved that the allegation made by Ms. Soma Roy is fake, false, fabricated, manufactured, baseless, frivolous with ulterior motive to malign the image of the University and Dr. Sukhen Som, Deputy Registrar (Academic) of this University be requested to lodge a F.I.R. at the local police station immediately stating the facts that Ms. Soma Roy, without disclosing her identity, sent manufactured, fabricated, concocted e-mail dated 27.04.2023 to the Hon'ble Vice-Chancellor and other different persons of the University community with clear and ulterior motive to malign the image of the Hon'ble Vice-Chancellor and the Registrar of the University. The documents which are attached with that email might have been stolen from the University by the same person with the help of some internal University stakeholders, otherwise an outsider cannot get access to such confidential documents. She maligned the position of the Hon'ble Vice-Chancellor designating the Vice-Chancellor as Vice-Chancellor (Acting). In the e-mail Ms. Soma Roy advised the Hon'ble Vice-Chancellor to give the charge of the custodianship of all University records and documents to the Inspector of Colleges or the Finance Officer although as per the norms of the University, the Registrar is the custodian of all University documents and records. Ms. Roy challenged the wisdom and power of the Hon'ble Vice-Chancellor. Resolved also that the Deputy Registrar (Academic) be also directed to request the competent authority of the police administration to investigate the whole matter for identifying the conspirators and also identifying the conspirators of the University involved for*

*such an incident in day light and start appropriate and stringent criminal proceedings against them as per Law as early as possible based on such F.I.R. Resolved further that the similar actions in lodging a F.I.R. be made in the local police station against the other authors who sent such fake, false, fabricated, manufactured, baseless, frivolous allegations through e-mails without disclosing their identities to malign the image of the University step by steps for identifying the conspirators and also identifying the conspirators of the University involved for such an incident for this purpose.*

**Confirmation:** 07(a) To place before the Executive Council of Vidyasagar University, the matter regarding confirmation of service of Shri Santu Mondal as Attendant of Vidyasagar University since his joining the post, i.e. from 08.04.2022.

**Resolution :** *Resolved that on the basis of Performance Assessment Reports (PARs) submitted by the Head of the Department concerned & scrutiny of the performance during the probation period of Shri Santu Mondal joined at Vidyasagar University as Attendant and subsequent positive and successful antecedents like, Police Verification Reports (PVRs) bearing VR No. 236/S dated 29.12.2022 received from the competent authority in his favour, the service of Shri Mondal in the post of Attendant at this University be confirmed with effect from his date of joining the post, i.e. from 08.04.2022. Resolved further that the Registrar and the Establishment Section of this University be requested to process further as per the norms of the University.*
