- (iii) the another letter dated 22.12.2021 received from Professor Chakrabarti addressed to the Vice-Chancellor (Actg.), Vidyasagar University complaining about not send the draft soft copy of the resolutions of the Sixth (6th) meeting of the Ninth Executive Council of Vidyasagar University held on 30.06.2021 to him by the Registrar of Vidyasagar University for alleged modification.

From the above two letters lastly received from Professor Chakrabarti, the Executive Council of Vidyasagar University noted further the contents of the letters as follows :

- (a) that the Registrar initiated and executed certain administrative actions purportedly in the EC resolutions dated 30.06.2021 and such actions has given rise to gross deviations and unauthorized modifications from the actual decisions;
- (b) that the Registrar might have changed the actual decisions by dint of his official position;
- (c) that the Registrar purposefully avoided to forward the draft soft copy of the minutes of the meeting dated 30.06.2021;
- (d) that the Registrar has misused his position and power to malign the image and position of the Chairman of the meeting;
- (e) that Professor Chakrabarti requested the Registrar to visit his office at Jadavpur University to receive the signed copies of the resolutions of the 3rd, 4th & 5th meetings of the Executive Council of Vidyasagar University from him personally;
- (f) that Professor Chakrabarti wrote the letter to Vice-Chancellor as Vice-Chancellor (Actg.);
- (g) that Professor Chakrabarti requested the Vice-Chancellor to enlighten the provisions of the Act/ Statute/ Ordinances of the University on which the Vice-Chancellor or the Executive Council approved the resolutions of the Executive Council dated 30.06.2021;
- (h) that Professor Chakrabarti requested the Vice-Chancellor to send the Registrar to his office for receiving the signed resolutions of the 3rd, 4th & 5th meetings of the Executive Council from him personally and not by any messenger.

After thorough discussion on the decisions taken by the Ninth Executive Council of Vidyasagar University in its earlier Eighth (8th) meeting held on 03.11.2021 based on the letter dated 08.10.2021 received from Professor Ranjan Chakrabarti, former Vice-Chancellor of Vidyasagar University seeking soft copy of the resolutions of the Sixth (6th) meeting of the Ninth Executive Council of Vidyasagar University held on 30.06.2021 under his Chairmanship for necessary correction at his end and subsequently the letters dated 15.12.2021 & 22.12.2021



respectively received from Professor Chakrabarti further in this regard, it is unanimously resolved as follows :

- (1) the allegations made by Professor Chakrabarti regarding alleged deviations or insertions from the actual EC resolutions/decisions held on 30.06.2021 under his Chairmanship are found to be not substantial and hence are not accepted. So no changes/additions/alterations in the resolutions dated 30.06.2021 and duly confirmed by the Executive Council in its next meeting held on 25.08.2021 was done and it was prepared in letter and spirit ;
- (2) it is further resolved that the allegations leveled against the Registrar of Vidyasagar University by Professor Chakrabarti in his letter dated 15.12.2021 regarding execution of actions purportedly, changing the actual decisions and misusing his position and power etc. is disapproved as the Registrar is only a Non-Member Secretary of the Executive Council or the Court, the University Bodies. He only executes the decisions taken by the University authorities like the Court and the Executive Council from time to time and he has nothing to do with any decision;
- (3) the language used by Professor Chakrabarti in his letter dated 22.12.2021 to our Hon'ble Vice-Chancellor as Vice-Chancellor (Actg.) is also disapproved as the competent authority of the State Government in exercise of his power laid down in the Vidyasagar University Act,1981, as amended in 2011, appointed Professor Sibaji Pratim Basu to exercise the powers and perform the duties of the Vice Chancellor of Vidyasagar University with effect from the forenoon of 06.07.2021;
- (4) the questions raised by Professor Chakrabarti in his letter dated 22.12.2021 to our Hon'ble Vice-Chancellor to enlighten the provisions of the Act/Statute/Ordinances of the University to which, the Vice-Chancellor or the Executive Council approved the resolutions of the EC meeting dated 30.06.2021 be further disapproved because as per the present practice, the draft actions were prepared based on the decisions taken by the Ninth Executive Council in its Sixth (6<sup>th</sup>) meeting held on 30.06.2021 phase by phase and some of the actions were placed before Professor Chakrabarti, for his kind approval and corrections/additions/alterations, if any. We received approval of a part of the actions from him within 5th July, 2021 and some were kept pending by him. Thereafter he left/released from the University upon completion of his tenure on 5th July, 2021. Professor Sibaji Pratim Basu, Professor, Department of Political Science and Dean (Actg.), Faculty of Arts & Commerce took the assignment as the next Vice-Chancellor with effect from 6th July, 2021. The rest of the actions as was pending before Professor Chakrabarti were placed before the present Vice-Chancellor and after getting the approval necessary steps were taken by the University. Also the draft minutes/resolutions of the meeting was prepared and placed in the next meeting of EC held on 25.08.2021 with the approval of the present Vice-Chancellor and the same was confirmed by EC.



- (5) *the point raised by Professor Chakrabarti in both the letters dated 15.12.2021 & 22.12.2021 to send the Registrar to his office at Jadavpur University to collect the signed resolutions of the 3rd, 4th & 5th meeting of the Executive Council of Vidyasagar University personally from him is again disapproved. Registrar is requested either to send a messenger from the University with authorization letter prior information to Professor Chakrabarti to collect the same from his office or to request Professor Chakrabarti to send the same through speed post and necessary charges required for this purpose be borne by the University;*
- (6) *Professor Chakrabarti is requested further to honour the collective decision of the Executive Council taken in its meeting held on 30.06.2021 & confirmed on 25.08.2021 and to put his signatures on these resolutions alongwith the resolutions of the 3rd, 4th & Fifth meetings of the Executive Council of Vidyasagar University respectively as Chairman and send the same to us either by messenger or by speed post as per his convenience immediately for uploading on the University website, the public domain of the University. Professor Chakrabarti is requested again to refrain himself from making further acquisitions upon the University or its Registrar in this regard;*
- (7) *the decisions taken by the Executive Council as stated herein above based on the complaints raised by Professor Chakrabarti in the matter of signature on the confirmed resolutions of the Sixth meeting of EC held on 30.06.2021 as Chairman be treated as the final & conclusive decision and no further communications be entertained from Professor Chakrabarti in this regard;*
- (8) *The Registrar is requested to convey the said decisions to Professor Chakrabarti immediately. The Registrar is also requested to forward a copy of the said decisions to the Higher Education Department, Government of West Bengal for information of the concerned Department.*
- 05(l) To consider the letter dated 20.12.2021 submitted by Dr. Siddhartha Sankar Dash, Senior Medical Officer of Vidyasagar University praying for granting him study leave with full pay and admissible allowances during the period of leave for two years taken by him earlier for his higher study of Doctor of Medicine (M.D.) instead of Extraordinary Leave without pay.  
*Resolution:* *Consideration of the item was deferred and decided that the Establishment Section be requested to produce all the documents related with the study leave of Dr. Dash and others for further consideration of the next meeting of the Executive Council.*
- 05(m) To consider the letter dated 17.12.2021 submitted by Dr. Siddhartha Sankar Dash, Senior Medical Officer of Vidyasagar University praying for release him from the University as Voluntary Retirement with effect from the afternoon of 31st December, 2021.  
*Resolution:* *The Executive Council of Vidyasagar University noted that the matter regarding the release of Dr. Siddhartha Sankar Dash from the post of Senior Medical Officer of Vidyasagar University as voluntary retirement vide letter dated 19.06.2021 was placed before the Executive Council of Vidyasagar University in its earlier meeting held on 25.08.2021 wherein the said proposal of Dr. Dash was*

accepted in principle and the matter was brought to the notice of the Department of Higher Education, Government of West Bengal for necessary concurrence/opinion. The Executive Council noted also that the decision of EC was communicated to the competent authority of the said department accordingly and in reply to that a query regarding confirmation whether the benefit of voluntary retirement scheme is available for the Officers of the University as per Statute/Rules of the University was made by the competent authority. The Executive Council noted further that in reply to that we informed that there is no such provision of VRS for the Officers of the University in our Statute but in the earlier occasion an Officer of this University was allowed to VRS as per the WB State-aided University (DCRB) Scheme 1999 in terms of G.O. No. 85-Edn(U) dated 31.01.2000. We have not received any further communication in this regard till date. The Executive Council noted again that now, Dr. Dash has submitted the above mentioned letter praying again for release from the University as VRS with effect from the afternoon of 31.12.2021.

After thorough discussion on the letter submitted by Dr. Siddhartha Sankar Dash, Senior Medical Officer of Vidyasagar University praying for release him from the University as Voluntary Retirement with effect from the afternoon of 31st December, 2021 and subsequently the letter received from the Higher Education Department, Government of West Bengal in this regard based on his first request, it was resolved that Dr. Dash be released from the said post of Medical Officer of Vidyasagar University as Voluntary Retirement with effect from the afternoon of 31.12.2021 upon fulfillment of other formalities, like submission of No Objection Certificates from different departments/sections etc. but his post-retirement benefits will be released subject to approval/concurrence of the Higher Education Department, Government of West Bengal as there is no such provision at present in our Statute/Ordinances etc. Resolved also that the post of Medical Officer be declared as vacant and necessary processes for recruitment of the said post be initiated as per the norms of the University. Resolved further that the Standing Committee for recruitment of the said post be constituted as per the norms of the University and regarding nomination of two experts of EC in the Standing Committee, the matter be left to the Hon'ble Vice-Chancellor for necessary action. Resolved again that due to emergent situation for vacancy of the Medical Officer, a Part-time Medical Officer purely on hiring basis may be recruited immediately and the Registrar and the Establishment Section be requested to process further in this regard.

- 05(n) To place before the Executive Council of Vidyasagar University, the Annual Report of Vidyasagar University for the year 2020-2021 prepared and submitted by the office of the Registrar of Vidyasagar University.

Resolution: The Executive Council of Vidyasagar University noted the detailed Annual Report of Vidyasagar University for the year 2020-2021 prepared by the office of the Registrar. The Executive Council further noted and discussed the different aspects of such Annual Report.

After thorough discussion on the Annual Report of Vidyasagar University for the year 2020-2021 prepared and submitted by the office of the Registrar of Vidyasagar University, it was resolved that the said Annual Report of Vidyasagar University prepared by the office of the Registrar for the year 2020-2021 be accepted with some suggestions made by the members of the house and forwarded the same to the Court of Vidyasagar University for approval and distribution amongst the stakeholders of the University and others. Resolved further that the Registrar be requested to process further in this regard in discussion with the Deputy Registrar (Academic) of Vidyasagar University.

- 05(o) To place before the Executive Council of Vidyasagar University, the letter bearing No. 1092-Edn(U)-HED-12014(45)/5/2020-UNV SEC dated 20.12.2021 received from the Assistant Secretary to the Government of West Bengal, Department of Higher Education, University Branch regarding release of Pension in favour of Dr. Niranjana Kumar Mandal, Ex-Controller of Examinations of Vidyasagar University.

**Resolution:** *The Executive Council of Vidyasagar University noted that as decided by the Executive Council of Vidyasagar University earlier, the matter regarding release of Pension in favour of Dr. Niranjana Kumar Mandal, Ex-Controller of Examinations of Vidyasagar University was brought to the notice of the Higher Education Department, Government of West Bengal and it was declined. Thereafter the person concerned directly appealed to the Hon'ble Minister-in-Charge, I & W Department for re-consideration of his pension and based on the said appeal, we received another letter from the Higher Education Department whether is there any provision in University DCRB Schemes for condonation of deficiency of minimum qualifying service as asked by the Finance Department, Government of West Bengal, Pension Branch and in reply to that we informed that at present there is no such provision in University DCRB Schemes for condonation of deficiency of minimum qualifying service but in the humanitarian ground the prayer of Dr. Mandal was considered by the University authority, the Executive Council, and allow him to get the pension condoning the deficiency of minimum qualifying service subject to approval of the Higher Education Department, Government of West Bengal in this regard. The Executive Council noted further that now, we have received a letter bearing No. 1092-Edn(U)-HED-12014(45)/5/2020-UNV SEC dated 20.12.2021 received from the Assistant Secretary to the Government of West Bengal stating that if there is no such provision in the University DCRB Schemes, do not send the file again to them on the same issue and requested to take necessary steps in this regard as per the existing rules of the University.*

*After thorough discussion on the letter received from the Assistant Secretary to the Government of West Bengal, Department of Higher Education, University Branch regarding release of Pension in favour of Dr. Niranjana Kumar Mandal, Ex-Controller of Examinations of Vidyasagar University, it was resolved that Registrar and the Establishment Section of this University be requested to process further in this regard.*

- 05(p) To consider the matter regarding empanelment of Shri Uttam Kumar Ray of Kolkata in the panel of Advocates of Vidyasagar University to see the legal matters of criminal cases of the University in the district Courts and High Court, Calcutta respectively.

**Resolution:** *The Executive Council of Vidyasagar University noted that Shri Uttam Kumar Roy, Advocate presently practicing in different legal matters in criminal cases at the District Courts and the High Court, Calcutta submitted a prayer alongwith his CV for empanelment his name in the panel of the University Advocates to see the legal criminal matters of the University.*

*After thorough discussion on the prayer of Shri Uttam Kumar Ray of Kolkata regarding empanelment of his name in the panel of Advocates of Vidyasagar University to see the legal matters of criminal cases of the University, it was resolved that the prayer of Shri Ray be accepted and his name may be empanelled to the University panel of advocates to see the criminal matters of the University and the Registrar be requested to process further in this regard.*

- 05(q) To place before the Executive Council of Vidyasagar University, the note sheet dated 21.12.2021 prepared and submitted by the Deputy Registrar (Academic), Vidyasagar University regarding non-issuing of signed copy of the e-migration certificate.


**Resolution:** *The Executive Council of Vidyasagar University noted the Note sheet dated 21.12.2021 prepared and submitted by the Deputy Registrar (Academic) of Vidyasagar University stating that they are facing many difficulties to distribute the signed copy of e-migration amongst huge numbers of students regularly. In this connection he has proposed to issue a notification stating that the e-migration certificate issued by the University through online is valid as well as the signed copy and no signed copy of such certificate will be issued further with effect from 03.01.2022. This certificate is electronically generated and does not require any signature.*

*After thorough discussion on the proposal prepared and submitted by the Deputy Registrar (Academic), Vidyasagar University regarding non-issuing of signed copy of the e-migration certificate, it was resolved that the said proposal of the Deputy Registrar (Academic) be accepted and the e-Migration Certificate issued by the Vidyasagar University through online mode be treated as equivalent to original signed copy of e-Migration Certificate and no signed copy of such certificate will be issued/required further with effect from 03.01.2022. Resolved further that if anybody desires to verify this e-Migration Certificate, may verify the same either scanning the QR Code or through the link provided on this certificate. Resolved again that the Registrar be requested to issue a circular/notification regarding this for information to all concerned.*

- 05(r) To place before the Executive Council of Vidyasagar University, the letter bearing No. 1090-Edn(EH)/1U-44/21 dated 17.12.2021 issued by the Assistant Secretary to the Government of West Bengal, Higher Education Department, University Branch pertaining to cancellation of the Department's earlier Memo No. 959-Edn(EH)/1U-44/12 dated 12.11.2021 regarding expeditious disposal of prayers for employment under compassionate ground.

**Resolution:** *The Executive Council of Vidyasagar University noted that previously the Higher Education Department, Government of West Bengal, University Branch issued a letter bearing No. 959-Edn(EH)/1U-44/21 dated 12.11.2021 to all state-aided Universities seeking a comprehensive report on the disposal of employment under compassionate ground under our control pending till 31.10.2021. Now we have received the above mentioned letter from the Assistant Secretary to the Government of West Bengal, University Branch stating that the letter bearing Memo No. 959-Edn(EH)/1U-44/12 dated 12.11.2021 which was issued by them earlier be treated as cancelled as there is no scheme for compassionate appointment in the state-aided Universities and the same was sent by them inadvertently.*

*After thorough discussion on the letter issued by the Assistant Secretary to the Government of West Bengal, Higher Education Department, University Branch pertaining to cancellation of the Department's earlier Memo No. 959-Edn(EH)/1U-44/12 dated 12.11.2021 regarding expeditious disposal of prayers for employment under compassionate ground, it was resolved that the said letter as was sent by the Higher Education Department be treated as cancelled and the Registrar and the Establishment Section of this University be requested to process further in this regard.*



- 05(s) To consider the letter bearing No. VU/CE/GD/Note/3287/2021 dated 21.12.2021 submitted by the Controller of Examinations of Vidyasagar University seeking guidance regarding printing of Certificates in case of Midnapore College (Autonomous) for the year 2019.

**Resolution:** *The Executive Council of Vidyasagar University noted the letter bearing No. VU/CE/GD/Note/3287/2021 dated 21.12.2021 submitted by the Controller of Examinations of Vidyasagar University stating that the final Degree Certificates both for Undergraduate and Postgraduate courses under Vidyasagar University are issued by the Controller of Examinations of this University. The Executive Council noted further that now they are facing the case of printing of Certificates both for Undergraduate (UG) & Postgraduate (PG) courses for Midnapore College (Autonomous) for the year 2019 and seeking guidance regarding provision of printing, financial liabilities etc. for this purpose.*


