- 06(o) To place before the Executive Council of Vidyasagar University, the draft Declaration to be submitted to the Backward Classes Welfare Department, Government of West Bengal for regularization of Registers of Appointment of Vidyasagar University based on the letter bearing No. 2524-BCW/MRD-49/2000 dated 19.08.2019 received from the Commissioner for Reservation and Secretary, Backward Classes Welfare Department, Government of West Bengal regarding violations in the Registers of Appointments (RoA).

**Resolution:** *The Executive Council of Vidyasagar University noted the letter bearing No. 2524-BCW/MRD-49/2000 dated 19.08.2019 received from the Commissioner for Reservation and Secretary, Backward Classes Welfare Department, Government of West Bengal regarding violations in the Registers of Appointments (RoA). The Executive Council also noted that based on the aforesaid letter, a committee has already been constituted to look into the said matter which is under consideration. The Executive Council noted further that as discussed with the officials of BCW Departments regarding de-reservation of some teaching and non-teaching posts of Vidyasagar University which is under consideration of Backward Classes Welfare Department and also desired by them, a declaration may be made by the University Authority for further consideration from their end. The Executive Council noted again the declaration prepared by the University based on the advice of the Backward Classes Welfare Department, Government of West Bengal. The declarations are as follows :*

- (i) *We are rendering an unconditional apology for the mistake in maintaining the Roster of Appointment made by the Vidyasagar University. The mistakes made by the University inadvertently and due to ignorance.*
- (ii) *The University authority do agree to carry forward the reservations against the reserved vacancies already filled up otherwise than by candidates for whom the vacancies were originally reserved and thereby violation has occurred, to the nearest subsequently unreserved vacancies at the time of consideration of any application.*
- (iii) *The University shall maintain and update the Register of Appointment and furnish it to the BCW Department along with an annual report mentioning the number of persons recruited by it in the establishment, during the previous years reckoned according to the British Calendar for authentication of such ROA.*



- (iv) *The University will henceforth in future abide by the requirements of the West Bengal Scheduled Castes & Scheduled Tribes (Reservation of vacancies in Services and Posts) Act, 1976 and the West Bengal Backward Classes (Other than Scheduled Castes & Scheduled Tribes) (Reservation of vacancies in Services and Posts) Act, 2012 and the related rules and regulations respectively.*
- (v) *The University shall not do De-reservation of any reserve vacancy in any post in the establishment which is required to be filled up by direct recruitment/promotion. In absence of qualified candidate of the right community, as the case may be, to fill up such vacancy, such vacancy shall remain unfilled and we will refer the vacancy to the Government in the BCW Department for De-reservation.*
- (vi) *The University assures that any further violation of the Reservation Roster in the recruitment/promotion will invite penal action (imprisonment for a term of 5 year or with fine of Rs.2,500/- (Rupees Two Thousand Five Hundred) or with both under Section 7 of WB SC & ST (Reservation in Services & Posts) Act, 1976 and Section 10 of the West Bengal Backward Classes (Other than Scheduled Castes and Scheduled Tribes) (Reservation of vacancies in Services and Posts) Act, 2012.*

*After thorough discussion on the Declaration prepared by the University based on the advice of the Backward Welfare Classes Department, Government of West Bengal for regularization of Registers of Appointment (RoA) of Vidyasagar University and also for de-reservation of some teaching and non-teaching posts of Vidyasagar University, it was resolved that the said Declaration prepared by the University for this purpose be accepted and the same be forwarded to the Backward Welfare Classes Department, Government of West Bengal for authentication.*

06(p) To place before the Executive Council of Vidyasagar University, the Enquiry Report submitted by the Enquiry Committee constituted by the Hon'ble Vice-Chancellor to enquire the special review matters of the Controller of Examinations department of this University.

06(q) To place before the Executive Council of Vidyasagar University, the letter dated 23.12.2019 submitted by the Controller of Examinations of this University in reply to the letter bearing No. VC/SECY/42/2019 dated 19.12.2019 issued by the Secretary to the Vice-Chancellor regarding his observations on the Enquiry Report submitted by the Enquiry Committee constituted by the Hon'ble Vice-Chancellor to enquire the special review matters of the Controller of Examinations department of this University.

**Resolution:** *The Executive Council of Vidyasagar University noted the detailed report submitted by the Enquiry Committee constituted by the Hon'ble Vice-Chancellor regarding special review ordered by the Controller of Examinations of this University in respect of two candidates, namely, Shri Sukdeb Ghanti and Shri Binoy Krishna Ghosh in the subject of Remote Sensing & GIS. The Executive Council noted also from the enquiry report that Special Review for these candidates were made beyond the University rules and without approval of the Hon'ble Vice-Chancellor of this University. The applications of the candidates entertained by the Controller of Examinations for such review were not duly forwarded by the Principal/Teacher-in-Charge of the respective colleges. The norms/rules of review were not followed for this purpose and the increase of marks of the*



concerned papers of the students was not properly calculated. The Executive Council noted further from the said report that there was negligence on the part of the Controller of Examinations and associate members (Dr. Tarakeswar Senapati, Officer on Special Duty) and they cannot disown their responsibilities for the irregular actions. The Executive Council noted again that the letter dated 23.12.2019 submitted by the Controller of Examinations regarding his observations on the said enquiry report as requested by the Hon'ble Vice-Chancellor. The Executive Council also expressed its deep concern for such irregularities.

After thorough discussion on the enquiry report submitted by the Enquiry Committee constituted by the Hon'ble Vice-Chancellor to enquire the special review matters of the Controller of Examinations department of this University and subsequently the observations submitted by the Controller of Examinations of this University based on the said enquiry report, it was resolved that the enquiry report submitted by the duly constituted enquiry committee be accepted. Resolved also that a censure letter be issued to the Controller of Examinations and Shri T. Senapati, OSD (Acting) for not repeating such practice in future in this regard as the observations made by the Controller of Examinations on the said enquiry report is dissatisfactory. Resolved further that the admission of these two candidates, namely, Shri Sukdeb Ghanti and Shri Binoy Krishna Ghosh in first year M.Sc. in Remote Sensing & GIS of Vidyasagar University be cancelled as per rules and the Secretary, Faculty Councils for Postgraduate Studies of this University be requested to issue a notice in this regard.

to the Purchase Committee in the name of Departmental Committee for purchase of AFM from DST-FIST grant of the Chemistry Department and subsequently desired by the Hon'ble Vice-Chancellor of this University on the said complaint. The Executive Council also noted the detailed observations made by different officials in this regard.

After thorough discussion on the complaint lodged by Professor Amiya Kumar Panda, Department of Chemistry through mail regarding falsified information given by the then Head of the Department of Chemistry of Vidyasagar University to the Purchase Committee in the name of Departmental Committee for purchase of AFM from DST-FIST grant of the Chemistry Department and careful consideration of the observations made by different officials in this regard, it was resolved that an enquiry committee consisting of (a) Professor Ashutosh Ghosh, Hon'ble Vice-Chancellor, University of Calcutta, (b) Professor Abhjit Chakrabarti, Saha Institute of Nuclear Physics, Crystallography and Molecular Biology Division, Kolkata and (c) the Registrar, Vidyasagar University - Member-Secretary be constituted to enquire the whole matter along with the supporting documents received from them and to submit a report in this regard for further consideration of the Executive Council of Vidyasagar University. Resolved further that the Registrar be requested to process further in this regard.

The Executive Council noted further from the said report that unhealthy and unauthorized financial transactions are taking place within the campus at high rate of interest and employees of this University and outsiders are involved in such transactions both as money-lenders and borrowers. The Executive Council noted again that Shri Ghosh did not turn-up before the Committee despite of several requests of the Committee. After thorough discussion on the report submitted by the Enquiry Committee constituted by the Hon'ble Vice-Chancellor to enquire into a number of complaint letters received against Shri Bholanath Ghosh, former Record-Keeper of Vidyasagar University, it was resolved that the said enquiry report for this purpose be accepted. Resolved also that Shri Ghosh be requested to come to the office of the Finance Officer of this University for final settlement of his retirement benefits and loan outstanding taken from various employees and persons associated with the University amicably. Resolved further that disciplinary actions be initiated hereafter against the employees and persons associated with the University if engaged/involved in such unauthorized financial transactions, i.e. money lending within the University campus. Resolved again that the Registrar be requested to issue the letter to Shri Ghosh to come to the office of the Finance Officer for final settlement of loan retire benefits and loan outstanding taken from various employees and persons associated with the University amicably.*


