- (c) *A storage room, culture room exclusively for microbial samples in the Department of Microbiology should be set up with a bio-safety symbol and there should be a restricted entry. The concerned room(s) should be monitored by a specific faculty.*
- (d) *Quality control of bio-safety of microbiological laboratory would be improved as per WHO guidelines as far as practicable in the University set up. All the microbial samples used in M.Sc. practical classes as well as for research purpose should be documented properly in registered book with relevant papers.*
- (e) *Unwanted, unmarked, unauthorized microbial samples from storage devices should be discarded from the Department immediately with environment friendly manner.*






