**Deferred Item :** 02.(a) To place before the Executive Council of Vidyasagar University, the letter dated 05.12.2018 submitted by the Head, Department of Anthropology pertaining to the observations of the Departmental Committee in the Department of Anthropology of this University regarding some nuisance caused by a guest and his accompanies in Rangamati Guest House during their stay from 28.10.2018 to 10.11.2018.

**Resolution:** *The Executive Council of Vidyasagar University noted the detailed observations taken by the Departmental Committee of the Department of Anthropology in its meeting held on 27.11.2018 and submitted by the Head of the concerned department based on the note put forwarded by the Registrar regarding some nuisance caused by a guest and his accompanies in Rangamati Guest House during their stay from 28.10.2018 to 10.11.2018. The Executive Council noted also that the Departmental Committee opined that such types of nuisance are highly undesirable and should not be repeated again. The said Departmental Committee also recommended that the University may treat the matter as per norms. The members of the Executive Council also condemned such incident that took place in the Rangamati Guest House.*

*After thorough discussion on the letter along with the Observations of the Departmental Committee of the Department of Anthropology submitted by the Head of the concerned department, it was resolved that Dr. Raja Chakraborty, Faculty of Bongaon College and who did his Ph.D. from Vidyasagar University should not be permitted to enter the Rangamati Guest House premises henceforth. Resolved further that the Head of the Department of Anthropology be requested to communicate the above stated observations of the Executive Council and decision to Professor Slewomir Koziel, Polish Scholar and Dr. Raja Chakraborty in this regard.*
