- 06(h) To consider the letter dated 20.09.2018 submitted by Ms. Saswati Ray, Professional Assistant, Womens' Studies Centre of Vidyasagar University praying for payment of her salary for the month of May, 2018 to August, 2018.

**Resolution:** The Executive Council of Vidyasagar University noted the letter dated 20.09.2018 submitted by Ms. Saswati Ray, Professional Assistant, Womens' Studies Centre of Vidyasagar University stating that she joined this University as Professional Assistant at the Womens' Studies Centre of this University on 03.02.2014 and served in the said post upto 02.05.2017 and thereafter she re-joined in the said post at this University with effect from 06.04.2018 and serving till date. She did not receive the salaries for the month of May, 2018 to August, 2018. In this connection she has requested the University authority to pay her salaries for the month of May, 2018 to August, 2018 at the earliest.

After careful consideration of the letter submitted by Ms. Saswati Ray, Professional Assistant, Womens' Studies Centre of Vidyasagar University praying for payment of her salary for the month of May, 2018 to August, 2018, it was resolved that three months salary of Ms. Ray be disbursed from the University fund as a special case. Resolved also that the Registrar of Vidyasagar University be requested to send a letter to the Department of Higher Education, Science & Technology and Biotechnology, University Branch requesting for retention of the post of Professional Assistant at the Womens' Studies Centre of Vidyasagar University. Resolved further that the prayer of Ms. Ray be forwarded to the Internal Pay Revision Committee for further consideration.

- 06(i) To consider the letter bearing No. VSSW/18-19/283 dated 19.09.2018 submitted by the Teacher-in-Charge of Vidyasagar School of Social Work, Kolkata pertaining to issuance of pending Marksheets of six students of MSW for 2016-2018 batch.

**Resolution:** The Executive Council of Vidyasagar University noted the letter bearing No. VSSW/18-19/283 dated 19.09.2018 submitted by the Teacher-in-Charge of Vidyasagar School of Social Work, Kolkata stating that six students of MSW Course in Batch 2016-2018 have completed their Master's Degree in Social Work in the year 2018. They have been awarded the Marksheet of first and second semesters but in case of issuance of third semester marksheets, the University has discovered that the aforesaid


students were not secured the qualifying marks in graduate level for admission to the said course. In this connection, the Teacher-in-Charge has apologized for this mistake and requested the University authority to issue the pending marksheets of such students. The Executive Council also noted that as per the present rules and regulations, pass course student should obtained 45% marks in graduation for admission to MSW course. Six final year students obtained less than 45% marks in Graduation level.

After thorough discussion on the letter submitted by the Teacher-in-Charge of Vidyasagar School of Social Work, Kolkata pertaining to issuance of pending Marksheets of six students of MSW for 2016-2018 batch, it was resolved that there was a gross mistake from the part of the Vidyasagar School of Social Work authority for admitting six students beyond the norms of the University without intimation of the University authority. Resolved further that the third semester marksheets of such six students be issued as a special case. Resolved again that a warning letter be issued to Vidyasagar School of Social Work for doing such a gross mistake and they should submit an undertaking stating not to repeat such practice in the near future. Resolved again that the Controller of Examinations of this University be requested to process further in this regard.

- 06(j) To consider the letter bearing No. NIL dated 06.09.2018 submitted by the Senior Superintendent of Post Offices, Midnapore Division pertaining to permission for installation of Sify Connectivity Pole at the Vidyasagar University Post Office Premises.

**Resolution:** The Executive Council of Vidyasagar University noted the letter bearing No. NIL dated 06.09.2018 submitted by the Senior Superintendent of Post Offices, Midnapore Division stating that the Department of Posts has initiated a prestigious project to modernize the Postal Service for the benefit of the common people of our country. As a part of this project Department of Post has also taken up the Network Integrator system. The Department has approved the install of 6 meter Pole if feasibility is available instead of 15 Mtr. Roof Tower (GBT & RTT) for Vidyasagar University Post Office so that the post office can get the alternate network (NSP2) in addition to NSP1 (BSNL) connectivity at all post offices. In this connection he has requested to accord necessary approval for installation of 6 mtr. Pole at the Vidyasagar University Post Office premises.

After thorough discussion on the letter submitted by the Senior Superintendent of Post Offices, Midnapore Division pertaining to permission for installation of Sify Connectivity Pole at the Vidyasagar University Post Office Premises, it was resolved that considering the present scenario and welfare value, the proposal for installation of Sify Connectivity Pole at the Vidyasagar University Post Office be accepted in principle. Resolved further that the said proposal be forwarded to the ICT Committee of Vidyasagar University for final opinion and the matter be brought to the notice of the Department of Higher Education, Science & Technology and Biotechnology in this regard.



- 06(k) To place before the Executive Council of Vidyasagar University, the letter dated 12.09.2018 received from the Scientist-F & Head, Ocean Info. and Forecast Service Group (ISG), Indian National Centre for Ocean Information Services, Ministry of Earth Sciences, Govt. of India, Hyderabad pertaining to establishment of INCOIS Coastal Laboratory at Digha in collaboration with the Vidyasagar University.

**Resolution:** *The Executive Council of Vidyasagar University noted the letter dated 12.09.2018 received from the Scientist-F & Head, Ocean Info. and Forecast Service Group (ISG), Indian National Centre for Ocean Information Services, Ministry of Earth Sciences, Govt. of India, Hyderabad stating that in collaboration with Vidyasagar University, ESSO-INCOIS has initiated a collaborative R & D and outreach project on the development of Hilsa shad predictive capabilities for West Bengal coast. This has a huge potential towards uplifting the livelihood, sea safety and disaster aspects of the marine fishing and coastal community of West Bengal. Establishment of INCOIS Coastal Laboratory at Digha for regular biogeochemical and fisheries data analysis and outreach activities are the major objectives of this project. In this connection he has requested to accord necessary approval to the Project Investigator of the Project to initiate the minor work and necessary purchase for the said laboratory. Instruments provided and purchased under the project can be insured using project money.*

*After thorough discussion on the letter received from the Scientist-F & Head, Ocean Info. and Forecast Service Group (ISG), Indian National Centre for Ocean Information Services, Ministry of Earth Sciences, Govt. of India, Hyderabad pertaining to establishment of INCOIS Coastal Laboratory at Digha in collaboration with the Vidyasagar University, it was resolved that the INCOIS Coastal Laboratory be established at Digha in collaboration with the Vidyasagar University provided that 15% (Fifteen percent) of the overhead be retained by Vidyasagar University and other facilities in this regard be extended by the Vidyasagar University except monetary involvement.*

- 06(l) To consider the letter dated 19.09.2018 submitted by the Secretary, Vidyasagar University Alumni Association pertaining to creation of an Endowment Fund in the name of "Vidyasagar University Alumni Endowment Fund" for a medal to a student who secure the highest percentage of marks in Postgraduate examinations of Vidyasagar University in the current year.

**Resolution:** *The Executive Council of Vidyasagar University noted the letter dated 19.09.2018 submitted by the Secretary, Vidyasagar University Alumni Association along with a Cheque for Rs.50,000/- (Rupees fifty thousand) only requesting for creation of an Endowment Fund in the name of "Vidyasagar University Alumni Endowment Fund" for a medal to a student who secure the highest percentage of marks in Postgraduate examinations of Vidyasagar University in the current year as decided by the Board of Directors of the said association.*

*After thorough discussion on the letter submitted by the Secretary, Vidyasagar University Alumni Association pertaining to creation of an Endowment Fund in the name of "Vidyasagar University Alumni Endowment Fund" for a medal to a student who secure the highest percentage of marks in Postgraduate examinations of Vidyasagar University in the current year, it was resolved that the said Endowment*

*Fund in the name of 'Vidyasagar University Alumni Endowment Fund' be created in this University for this purpose. Resolved further that the amount of Rs.50,000/- (Rupees fifty thousand) only paid by the said Association for this purpose be accepted and the Finance Officer of this University be requested to explore the matter regarding increasing the fund in this regard.*

- 06(m) To place before the Executive Council of Vidyasagar University, the Inspection Reports submitted by the duly constituted Inspection Team(s) pertaining to extension of affiliation to different undergraduate colleges for introduction of B.Voc. courses under NSQF Schemes of UGC from the academic session 2018-2019.

**Resolution:** *The Executive Council of Vidyasagar University considered the Inspection Reports submitted by the duly constituted Inspection Team(s) pertaining to extension of affiliation to different undergraduate colleges for introduction of B.Voc. courses under NSQF Schemes of UGC from the academic session 2018-2019.*

*After thorough discussion on the the Inspection Reports submitted by the duly constituted Inspection Team(s) pertaining to extension of affiliation to different undergraduate colleges for introduction of B.Voc. courses under NSQF Schemes of UGC from the academic session 2018-2019, it was resolved that necessary affiliation be extended to the concerned colleges for introduction of the B.Voc. Courses under NSQF Scheme for the academic session 2018-2019 as per the norms of the University and duly recommended by the concerned Inspection Team(s) constituted for this purpose. Resolved further that the Inspector of Colleges and the Secretary, Council for Undergraduate Studies of this University be requested to process further in this regard. In this connection he has requested to consider the admission of such two students already admitted in PG course and give necessary approval in this regard.*

*After careful consideration of the letter submitted by the Teacher-in-Charge of Pingla Thana Mahavidyalaya praying for post-facto approval of admission of students already admitted by the college authority in Postgraduate Course of Commerce beyond the norms for the academic session 2018-2019, it was resolved that the admission of two students made by the colleges authority in Postgraduate Course of Commerce for the academic session 2017-2018, who passed their graduation in the year 2015 instead of the year 2016 or 2017 as per the norms of the University, be approved for this year only as a special case subject to submission of declaration by the Principal of the concerned college not to repeat such practice in future. Resolved further that the Inspector of Colleges and the Secretary, Faculty Councils for Postgraduate Studies of this University be requested to process further in this regard.*

- 06(p) To consider the letter bearing No. ESFS/V.UNI/SG-HK/04/18 dated 24.07.2018 submitted by the Authorized Signatory of Elegant Security & Facility Services, Kolkata pertaining to extension of existing contract for Security Services and House Keeping at the Vidyasagar University campus.

Resolved further that the tender which was invited earlier by the University for such services in this University be treated as cancelled and the process for inviting a fresh tender in this regard be initiated by the Registrar and the Finance Officer of this University as per the norms of the University.

- 06(q) To place before the Executive Council of Vidyasagar University, the Notesheet dated 25.09.2018 prepared by the office of the Finance Officer and duly forwarded by the Finance Officer of this University pertaining to issuance of a certificate of attendance of the incumbents concerned viz. Shri Santanu Bera as Research Assistant and Shri Santu Mondal as Attendant engaged in the Womens' Studies Centre of Vidyasagar University during the period from 01.04.2017 to 31.07.2018 for disbursement of their arrear salary.


**Resolution :** After thorough discussion on the Note sheet prepared by the office of the Finance Officer and duly forwarded by the Finance Officer of this University pertaining to issuance of a certificate of attendance of the incumbents concerned viz.
