Under the circumstances, in terms of Section 9 of the West Bengal State Higher Educational Institutions (Reservation in Admission) Rules, 2013 University authorities may fill up the above mentioned vacant reserve seats by General Candidates by De-reservation of those seats (if available) after following due process for filling up of those reserve seats by the candidates of the specific categories but not getting any suitable candidate of the reserved categories to fill up those seats. The Executive Council also noted that no vacant reserved seat may be carried forward to the next academic year under any circumstances.

After thorough discussion on the Circular issued by the Deputy Secretary to the Government of West Bengal, Department of Higher Education, Science & Technology and Biotechnology, University Branch pertaining to De-reservation of Reserved seats for admission to all the Universities, it was resolved that the Inspector of Colleges, the Secretary, Faculty Councils for Postgraduate Studies and the Secretary, Council for Undergraduate Studies of this University be requested to process further in this regard.

Session Judges Court, Paschim Medinipur regarding his acquittal from the case and the said certified copy of the verdict be placed in the next meeting of the Executive Council for further decision in this regard.*

06(h) To place before the Executive Council of Vidyasagar University, different communications made by the University to Dr. Indrani Datta (Chaudhuri), Assistant Professor, Department of English of this University, who is now under suspension, and also the replies received from her pertaining to station leave of her without permission of the University and also supply of documents regarding Chargesheet issued to her.

**Resolution:** *The Executive Council of Vidyasagar University noted different communications made by the University to Dr. Indrani Datta (Chaudhuri), Assistant Professor, Department of English of this University, who is now under suspension, pertaining to station leave of her without permission of the University and also supply of documents regarding Chargesheet issued to her. The Executive Council also noted the replies made by Dr. Datta (Chaudhuri) based on the communications made by the University. The Executive Council noted further that several days and several times the office representatives visited her house allotted to the University in the University residential campus, to hand over different communications to her but did not dispatch the same as her quarter was locked.*

*After thorough discussion on the different communications made by the University to Dr. Indrani Datta (Chaudhuri), Assistant Professor, Department of English of this University, who is now under suspension, and also the replies received from her pertaining to station leave of her without permission of the University and also supply of documents regarding Chargesheet issued to her, it was resolved that the action regarding various correspondences made by the University to Dr. Datta (Chaudhuri) be ratified.*



- 06(i) To consider the prayer dated 18.12.2017 submitted by the Head, Department of Sanskrit, Vidyasagar University pertaining to appointment of Part-time/Guest/Contractual Faculty in the Department of Sanskrit for the academic session 2018-2019.

**Resolution:** *The Executive Council of Vidyasagar University noted the prayer dated 18.12.2017 submitted by the Head, Department of Sanskrit, Vidyasagar University pertaining to appointment of Part-time/Guest/Contractual Faculty in the Department of Sanskrit for the academic session 2018-2019. The Executive Council also noted that one post of Assistant Professor purely on contract basis has already been vacant till date.*

*After thorough discussion on the submitted by the Head, Department of Sanskrit, Vidyasagar University pertaining to appointment of Part-time/Guest/Contractual Faculty in the Department of Sanskrit for the academic session 2018-2019, it was resolved that the appointment of guest teacher should be made as per the norms of the University. Resolved also that the Head of the concerned department and the Secretary, Faculty Councils for Postgraduate Studies of this University be requested to process further in this regard.*

- 06(j) To place before the Executive Council of Vidyasagar University, the letter bearing No. 1363(20)-Edn (U)/1U-69/17 dated 14.12.2017 received from the Deputy Secretary to the Government of West Bengal, Department of Higher Education, Science & Technology and Biotechnology, University Branch pertaining to offering the Career Advancement Scheme of Officers of State Aided Universities under the administrative control of the Higher Education Department.

**Resolution:** *The Executive Council of Vidyasagar University noted the the letter bearing No. 1363(20)-Edn (U)/1U-69/17 dated 14.12.2017 received from the Deputy Secretary to the Government of West Bengal, Department of Higher Education, Science & Technology and Biotechnology, University Branch stating that the department in its order dated 12.08.2013, which has directed the Universities not to proceed with offering the Career Advancement of Officers of the State-aided Universities, is hereby withdrawn with immediate effect. The Executive Council also noted that the Department's existing Order No. 228-Edn(U) dated 08.03.2001 shall remain in force regarding Career Advancement Scheme for the Officers of the State-Aided Universities under the administrative control of the Higher Education Department, until further order as stated in the aforesaid letter.*

*After thorough discussion on the letter received from the Deputy Secretary to the Government of West Bengal, Department of Higher Education, Science & Technology and Biotechnology, University Branch pertaining to implementation of the Career Advancement Scheme of Officers of State Aided Universities under the administrative control of the Higher Education Department, it was resolved that the said G.O. of the Higher Education Department, Government of West Bengal be implemented in this University soon. Resolved also that the Establishment Section of Vidyasagar University be requested to process further in this regard immediately. Resolved again that for promotion/placement of Officers of this University, necessary Standing Committee be constituted as per the norms of the University and regarding nomination of EC nominees in the Standing Committee, the matter be left to the Hon'ble Vice-Chancellor for necessary action.*



- 06(k) To place before the Executive Council of Vidyasagar University, the letter dated 18.12.2017 received through e-mail from Mr. D.K. Garg, Nodal Officer, High Court Cases Monitoring Cell, High Court, Calcutta pertaining to appointment of Solicitor Firms by the Government Departments/Corporations/Boards.  
**Resolution:** *The Executive Council of Vidyasagar University noted the letter dated 18.12.2017 received through e-mail from Mr. D.K. Garg, Nodal Officer, High Court Cases Monitoring Cell, High Court, Calcutta along with a scanned copy of letter dated 05.12.2017 written by Ld. L.R., W.B. in the matter of appointment of Solicitor Firms by the Government Departments/Corporations/Boards for necessary action from our end.*
- 06(l) To place before the Executive Council of Vidyasagar University, the draft format of Application Form for promotion of Officers of Vidyasagar University under the Career Advancement Scheme.  
**Resolution:** *The Executive Council of Vidyasagar University noted the detailed format of Application Form prepared by the office of the Registrar for promotion of Officers of Vidyasagar University under the Career Advancement Scheme.*  
*After thorough discussion on the draft format of Application for promotion of Officers of Vidyasagar University under the Career Advancement Scheme prepared by the office of the Registrar, it was resolved that the said format of application form be accepted and approved with minor modification for implementation.*
- 06(m) To consider the letter dated 22.12.2017 submitted by Ms. Nibedita Bose, wife of Shri Swapan Kumar Bose, former Record Keeper of Vidyasagar University pertaining to early implementation of the pension of her husband, Shri Swapan Kumar Bose.  
**Resolution:** *The Executive Council of Vidyasagar University noted the letter dated 22.12.2017 submitted by Ms. Nibedita Bose, wife of Shri Swapan Kumar Bose, former Record Keeper of Vidyasagar University stating that her husband is seriously ill and continuing his treatment at NRS Hospital. Due to financial stringency, she cannot accommodate the treatment of her husband properly. The pension of her husband is not introduced till date. In this connection she has requested to consider her application and to implement the pension of her husband immediately.*  
*After thorough discussion on the letter submitted by Ms. Nibedita Bose, wife of Shri Swapan Kumar Bose, former Record Keeper of Vidyasagar University pertaining to early implementation of the pension of her husband, Shri Swapan Kumar Bose, it was resolved that based on the enquiry report submitted by the One-man Enquiry Committee constituted on the basis of allegations made by Shri Milan Kumar Ghara against your husband, Shri Swapan Kumar Bose, all post-retirement benefits of Shri Bose in this University be withheld till completion of police enquiry/criminal proceedings.*
- 06(n) To place before the Executive Council of Vidyasagar University, the note prepared and submitted by the University Engineer pertaining to repairing and renovation works of the Hon'ble Vice-Chancellor's Bunglow.  
**Resolution:** *The Executive Council of Vidyasagar University noted the note prepared and submitted by the University Engineer stating that some works for repairing and renovation of the Hon'ble Vice-Chancellor's Bunglow are*



required for urgent basis. Such works may be done through work done basis by the experienced contractor, M/s. Das & Co.

After thorough discussion on the note put forwarded by the University Engineer pertaining to repairing and renovation works of the Hon'ble Vice-Chancellor's Bunglow, it was resolved that the said repairing and renovation works of the Hon'ble Vice-Chancellor's Bunglow be made work done basis by the experienced contractor, M/s. Das & Co. as recommended by the University Engineer. Resolved also that the University Engineer be requested to process further in this regard immediately.

- 06(o) To place before the Executive Council of Vidyasagar University, the University Diary, Calendar and Table Calendar for the year 2018.

**Resolution:** The Executive Council of Vidyasagar University noted the detailed University Diary – 2018 and also noted the Calendar and Table Calendar of Vidyasagar University for the year 2018 prepared by the office of the Registrar of this University.

After thorough discussion, it was resolved that the said University Diary, Calendar and Table Calendar of Vidyasagar University for the year 2018 be accepted and approved.

- 06(p) To place before the Executive Council of Vidyasagar University, the note prepared and submitted by the Establishment Section of Vidyasagar University regarding the study leave and other kinds of leave taken by Dr. Siddhartha Sankar Dash, Medical Officer of Vidyasagar University for pursuing postgraduate course in Neuro-Surgery at Appolo Hospital and postgraduate course in Doctor of Medicine at KIIT, Bhubaneswar respectively.

**Resolution:** The Executive Council of Vidyasagar University noted the detailed note prepared and submitted by the Establishment Section of Vidyasagar University regarding the study leave and other kinds of leave taken by Dr. Siddhartha Sankar Dash, Medical Officer of Vidyasagar University for pursuing postgraduate course in Neuro-Surgery at Appolo Hospital and postgraduate course in Doctor of Medicine at KIIT, Bhubaneswar respectively. The Executive Council also noted that the Executive Council in its earlier meeting held on 06.11.2017 granted him 46 (forty six) days of excess leave taken by Dr. Dash as advance from the earned leave which will be admissible to his leave account in the next two years based on the note submitted by the Establishment Section and decided that if Dr. Dash leaves the University before adjustment of the advanced earned leave, the required amount for such leave will be recovered from his salary as per the norms of the University. The Executive Council noted further that the total excess leave taken by Dr. Dash for this purpose is 112 (one hundred twelve) days in place of 46 (forty six) days. The said 46 days was shown inadvertently by the Establishment Section without counting of 66 days extra ordinary leave without pay granted to Dr. Dash. The Executive Council noted again that Dr. Dash availed total Earned Leave 243 days from 07.12.2016 to 06.08.2017. His total earned leave balance upto 31.12.2017 is 186 days [151 days upto 06.08.2014 plus 35 days earned leave credited from 07.11.2016 to 31.12.2017] out of which 55 days was approved by the University. So, the total excess leave taken by Dr. Dash is 112 days [243-131(186-55) = 112].

After thorough discussion on the note put forwarded by the Establishment Section of Vidyasagar University regarding the leave balance in respect of



Dr. Siddhar Sankar Dash, Medical Officer of Vidyasagar University and considering the decision taken by the Executive Council earlier in this regard, it was resolved that the total number of excess leave of 112 days taken by Dr. Dash be granted to him as advance from the earned leave which will be admissible to his leave account from the next years. Resolved also that if Dr. Dash leaves the University before adjustment of the 112 days advanced earned leave, the required amount for such leave will be recovered from him as per the norms of the University before release from this University. Resolved further that the Registrar and the Establishment Section of Vidyasagar University be requested to process further in this regard.

**Recommendations :** 07(a) To consider the recommendations of the Standing Committee for appointment to the Officer posts of (i) Deputy Inspector of Colleges (DIC) and (ii) the Development Officer (DO) of Vidyasagar University.

**Resolution :** (i) Resolved that the recommendation of the Standing Committee for appointment to the post of Deputy Inspector of Colleges of this University be accepted and approved. Resolved also that an option be sought for from the concerned incumbent who has been selected for the post of Deputy Inspector of Colleges in writing within seven days from the date of issue of letter that whether he is willing to join the said post a afresh or interested to get his promotion under the Career Advancement Scheme in this University as per the G.O. of the Higher Education Department, Government of West Bengal. If he is interested to join that post a afresh then his promotion under the Career Advancement Scheme (CAS) will not be considered.

(ii) Resolved that the recommendation of the Standing Committee for appointment to the post of Development Officer of this University be accepted and approved. Resolved also that an option be sought for from the concerned incumbent who has been selected for the post of Deputy Inspector of Colleges in writing within seven days from the date of issue of letter that whether he is willing to join the said post a afresh or interested to get his promotion under the Career Advancement Scheme in this University as per the G.O. of the Higher Education Department, Government of West Bengal. If he is interested to join that post a afresh then his promotion under the Career Advancement Scheme (CAS) will not be considered.

Resolved further that the Registrar of this University be requested to communicate the same to the concerned incumbent in both the cases regarding their options as decided by the Executive Council in this regard.

07(b) To consider the recommendation of the Standing Committee for appointment to the post of Dean of Students' Welfare of Vidyasagar University.

**Resolution :** Resolved that the recommendation of the Standing Committee for appointment to the post of Dean of Students' Welfare of this University be accepted and approved. Resolved also that the Registrar be requested to issue the offer letter to the concerned incumbent selected for the post and the appointee be requested to join the post within three weeks positively from the date of receipt of the offer letter.



**Renewal of contract :** 08(a) To consider the letter dated 15.12.2017 submitted by Shri Sumanta Saha, Technical Assistant (Contractual), Department of Remote Sensing & GIS of this University pertaining to renewal of his contract service for a further period.

**Resolution :** *The Executive Council of Vidyasagar University considered the letter dated 15.12.2017 submitted by Shri Sumanta Saha, Technical Assistant in the Department of Remote Sensing & GIS of this University purely on contract basis pertaining to renewal of his contract service in his present post for a further period.*

*Resolved that the contract period of Shri Saha in the post of Technical Assistant of this University be renewed for a further period of one year with effect from 29.01.2018 or until further order whichever is earlier based on the Performance Appraisal Report during his last contract period submitted by the concerned Head of the department with admissible allowances as per the norms of the University.*
