

In this connection the Secretary has requested to appoint a Nodal Officer in our esteemed University so that the necessary action on the activities regarding preparation of Action Plan regarding all receipts and payments shall be made only through line or digital modes, all students' service in the hostel and otherwise digital mode should be used for all transactions, all canteens and business establishments on the campus may be encouraged to use only digital modes for their receipts and payments etc. can be initiated in a time bound manner. He has also requested to forward the monthly report on the above to UGC by e-mail.*

*After thorough discussion on the letter received from the Secretary, University Grants Commission, New Delhi pertaining to appointment of a Nodal Officer at Vidyasagar University to see the activities regarding all monetary transactions of the educational institutions may be done using digital modes of payment (viz. online IMPS/BHIM/Debit Cards/AEPS) under the National Digital Payments Mission (NDPM) of MHRD, it was resolved that the Finance Officer of this University be appointed as the Nodal Officer to see such activities as advised by the University Grants Commission in its aforesaid letter.*

- 05(m) To note the letter bearing D.O. No. F.1-1/2017(Secy) dated 09.06.2017 received from the Secretary, University Grants Commission, New Delhi pertaining to celebration of International Day of Yoga (IDY) – 2017 at our esteemed University.

Resolution: *The Executive Council of Vidyasagar University noted the letter bearing D.O. No. F.1-1/2017(Secy) dated 09.06.2017 received from the Secretary, University Grants Commission, New Delhi stating that the Ministry of Human Resource Development (MHRD) has desired the additional activities to follow the Common Yoga Protocol, 2017 and Yoga Portal of AYUSH Ministry on the Yoga Day, three generations of family members participate in the exercise in a voluntary and lively manner so that the Yoga activities, including audio, video, photographs and news materials, encouragingly and promisingly reflect active participation of different generations in the family and also send the activities of IDY-2017 to Technical Director, NIC. In this connection the Secretary has requested to make certain the above activities in Vidyasagar University and its affiliated colleges and send the desired information to NIC.*



*After thorough discussion on the letter received from the Secretary, University Grants Commission, New Delhi pertaining to celebration of International Day of Yoga (IDY) – 2017 at our esteemed University, it was resolved that the Programme Co-ordinator, National Service Scheme (NSS) and the Sports Officer of this University be requested to do the needful in this regard very soon.*

05(n) To note the letter bearing D.O. No. F.91-2/2014(GS)pt.I dated 11.07.2017 received from the Secretary, University Grants Commission, New Delhi pertaining to implementation of Guidelines for Gender Champions in Educational Institutions' at Vidyasagar University and its affiliated colleges.  
**Resolution:** *Consideration of the item was deferred.*

05(o) To note the Order bearing No. 65-Edn(B)/5B-15/2017 dated 11.07.2017 issued by the Secretary to the Government of West Bengal, Department of Higher Education, Science & Technology and Biotechnology, Budget Branch pertaining to providing financial assistance to the NET-LS candidates registered as full time M.Phil. or Ph.D. research scholars as on 01.04.2017 or on a date thereafter with effect from 01.04.2017.  
**Resolution:** *The Executive Council of Vidyasagar University noted the Order bearing No. 65-Edn(B)/5B-15/2017 dated 11.07.2017 issued by the Secretary to the Government of West Bengal, Department of Higher Education, Science & Technology and Biotechnology, Budget Branch stating that with the objective of promoting research in the higher educational institutions in West Bengal, the Governor is pleased to give direction that the benefits of the Government order bearing No. 52-Edn(B)/5B-15/2017 dated 07.06.2017 shall also extend to those research scholars who have cleared NET-LS and are conducting full time research as M.Phil. or Ph.D. scholars and still have not got employment as teachers in higher educational institutions and are not in receipt of any financial assistance from any other source. The Governor is further pleased to say that the financial assistance will be admissible to those non-NET candidates and NET-LS candidates registered as full time M.Phil. or Ph.D. research scholars as on 01.04.2017 or on a date thereafter, with effect from 01.04.2017. After through discussion on the order issued by the Secretary to the Government of West Bengal, Department of Higher Education, Science & Technology and Biotechnology, Budget Branch pertaining to providing financial assistance to the NET-LS candidates registered as full time M.Phil. or Ph.D. research scholars as on 01.04.2017 or on a date thereafter with effect from 01.04.2017, it was resolved that the Assistant Registrar of this University be requested to do the needful in this regard.*

05(p) To note the note dated 23.08.2017 prepared and submitted by the Assistance Registrar of Vidyasagar University regarding information pertaining to expiry of two agreements made between the Vidyasagar University and M/s. Elegant Security and Facility Services, Kolkata for providing security personnel and house-keeping staff at the Vidyasagar University campus.  
**Resolution:** *The Executive Council of Vidyasagar University noted the note prepared and submitted by the Assistant Registrar of Vidyasagar University stating that two agreements between the Vidyasagar University and M/s. Elegant Security and Facility Services, Kolkata were made for providing security personnel and house-keeping staff at the Vidyasagar University campus to protect the University and also house keeping*

services for keeping the University campus neat and clean for a period of one year. He has also stated that such agreements were signed on 01.01.2016 which has already been expired on 31.12.2016.

After thorough discussion on the note prepared and submitted by the Assistance Registrar of Vidyasagar University regarding information pertaining to expiry of two agreements made between the Vidyasagar University and M/s. Elegant Security and Facility Services, Kolkata for providing security personnel and house-keeping staff at the Vidyasagar University campus, it was resolved that M/s. Elegant Security and Facility Services be requested to continue for providing such services at the University until further order and necessary e-tender be invited for engagement of new vendor for providing such services as per the norms of the University. Resoled also that the Finance Officer and the Assistant Registrar of Vidyasagar University be requested to process further for e-tendering soon.

- Discussion:** 06(a) To consider the letter bearing No. Tech/Comptn/Network(Sify)/MNP dated 17.07.2017 submitted by the Senior Superintendent of Post Offices, Midnapore Division pertaining to permission for construction of Sify Tower at the Vidyasagar University Post Office premises.

**Resolution :** *The Executive Council of Vidyasagar University noted the letter bearing No. Tech/Comptn/Network(Sify)/MNP dated 17.07.2017 submitted by the Senior Superintendent of Post Offices, Midnapore Division stating that the Department of Posts has initiated a prestigious project to modernize the Postal Service for the benefit of the common people of our country. As a part of this project, Department of Post has also taken up the Network Integrator System. For this reason the Department has approved the construction of Tower (GBT & RTT) so that the Post office can get the alternate network (NSP2) in addition to NSP1 (BSNL) connectivity at all post offices. The Department of Posts has approved RTT (Roof Top Tower) type of tower for Vidyasagar University Post Office. In this connection, he has requested to permit them for construction of said tower at VU post office premises.*

*After thorough discussion on the letter submitted by the Senior Superintendent of Post Offices, Midnapore Division pertaining to permission for construction of Sify Tower at the Vidyasagar University Post Office premises, it was resolved that the clarification regarding the financial benefits of Vidyasagar University for construction of such Tower at the University Campus be sought for and after getting the clarifications in this regard, the matter be placed before the next meeting of the EC for consideration.*

- 06(b) To place before the Executive Council of Vidyasagar University, the letter along with the notification bearing No. 848-Edn(CS)/1M-01/2017 dated 01.08.2017 received from the IT Associate, IT Cell, Department of Higher Education, Science & Technology and Biotechnology, Government of West Bengal regarding medical benefits to the Serving Teachers including Librarians and Graduate Laboratory Instructors of the State-aided Universities.

**Resolution:** *The Executive Council of Vidyasagar University noted the letter along with the notification bearing No. 848-Edn(CS)/1M-01/2017 dated 01.08.2017 issued by the Deputy Secretary to the Government of West Bengal, Department of Higher Education, Science & Technology and*



Biotechnology, C.S. Branch pertaining to providing medical benefits to the Serving Teachers including Librarians and Graduate Laboratory Instructors of the State-aided Universities received through mail from the IT Associate, IT Cell, Department of Higher Education, Science & Technology and Biotechnology, Government of West Bengal requesting to provide the contact details of the Nodal Authority of each of the University for the aforesaid purpose.

After thorough discussion on the letter along with the notification bearing No. 848-Edn(CS)/1M-01/2017 dated 01.08.2017 received from the IT Associate, IT Cell, Department of Higher Education, Science & Technology and Biotechnology, Government of West Bengal regarding medical benefits to the Serving Teachers including Librarians and Graduate Laboratory Instructors of the State-aided Universities, it was resolved that the Audit Officer of this University be nominated as the Nodal Officer of Vidyasagar University for this purpose. Resolved also that a request letter be sent to the Department of Higher Education, Science & Technology and Biotechnology for inclusion of the University Officers for providing such medical benefits.

- 06(c) To place before the Executive Council of Vidyasagar University, the letter dated 25.07.2017 received from Om Prakash of SATYARTHI, Kailash Sathyarathi Childrens' Foundation inviting to join the Bharat Yatra under the leadership of Sh. Kailash Satyarthi's.

**Resolution:** The Executive Council of Vidyasagar University noted the letter dated 25.07.2017 received from Om Prakash of SATYARTHI, Kailash Sathyarathi Childrens' Foundation along with the form of interest, concept note, data sheet and route-map stating that Sh. Kailash Satyarthi, a life-long crusader for child rights in 2014 was awarded the Nobel Peace Prize for his struggle against the suppression of children and young people. Sh. Satyarthi has a deep faith in the power of good education and young people in improving the society. They are planning a mammoth youth awareness campaign - A nation-wide march in India from Vivekananda Rock Memorial, Kanyakumari to Delhi from The Bharat Yatra during 11 September to 15 October, 2017. In this connection he has requested to organize an event in collaboration with them and encourage and mobilize as many people as possible to join in the Yatra when the marchers reach our city and send our confirmation in collaborating with them so that their team can get in touch with us for further consultation.

After thorough discussion on the letter received from Om Prakash of SATYARTHI, Kailash Sathyarathi Childrens' Foundation inviting to join the Bharat Yatra under the leadership of Sh. Kailash Satyarthi's, it was resolved that the said proposal be accepted in principle. Resolved also that the Programme Co-ordinator, National Service Scheme (NSS) of Vidyasagar University be requested to process further in this regard.

- 06(d) To place before the Executive Council of Vidyasagar University, the letter dated 25.07.2017 submitted by Shri Pankoj Kumar Sarker, a Research Scholar in the Department of Library and Information Science of this University praying for residential facilities (accommodation) as foreign research scholar.

**Resolution:** The Executive Council of Vidyasagar University noted the letter dated 25.07.2017 submitted by Shri Pankoj Kumar Sarker, a Research Scholar in the Department of Library and Information Science of this

University stating that at present he is a Ph.D. Research Scholar of the Department of Library and Information Science under the supervision/guidance of Dr. Soumen Mallik. He has come from Bangladesh but there is no residential campus in the Vidyasagar University campus for the foreign research scholar and for this reason he is staying at a Lodge in the Midnapore and take his meals from outside which is more expensive and unhygienic. In this connection, Mr. Sarker has requested to extend him residential facilities as a foreign research scholar for smoothly run of his research work at the University.

After careful consideration of the letter submitted by Shri Pankoj Kumar Sarker, a Research Scholar in the Department of Library and Information Science of this University praying for residential facilities (accommodation) as foreign research scholar, it was resolved that the concerned incumbent be provided accommodation in the Guest House of Vidyasagar University on payment basis as a special case subject to availability of such accommodation in the Guest House and also based on his requirement from time to time for this purpose.

- 06(e) To consider the letter dated 20.07.2017 submitted by Dr. Keshab Chandra Mondal, Associate Professor, Department of Microbiology of this University pertaining to permission for submission of joint collaborative project under INDIA-KOREA JOINT PROGRAMME OF COOPERATION IN SCIENCE AND TECHNOLOGY Programme.

**Resolution:** Consideration of the item was deferred.

- 06(f) To place before the Executive Council of Vidyasagar University, the observations of Dr. Indrani Datta (Chaudhuri), Assistant Professor, Department of English of this University on the Enquiry Report submitted by the Enquiry Officer appointed in relation with the Chargesheet issued to her.

**Resolution:** The Executive Council of Vidyasagar University noted the detailed observations submitted by Dr. Indrani Datta (Chaudhuri), Assistant Professor, Department of English of Vidyassgar University on the enquiry report submitted by Professor Jayashree Roy appointed as Enquiry Officer in relation with the Chargesheet bearing No. dated issued to her. The Executive Council also noted that Dr. Datta (Chaudhuri) declined to participate in the enquiry proceedings and consequently she did not cross-examine the witnesses.

After thorough discussion on the observations submitted by Dr. Indrani Datta (Chaudhuri), Assistant Professor, Department of English of Vidyasagar University on the enquiry report submitted by the Enquiry Officer, it was resolved that –

- (a) an opportunity to controvert the essence of statements made by the witnesses produced before the Enquiry Officer be given to Dr. Indrani Datta (Chaudhuri), Assistant Professor, Department of English of Vidyasagar University as she declined to participate in the enquiry proceedings and consequently she did not cross-examine the witnesses.
- (b) copies of statements recorded in the enquiry proceedings and the documents which were submitted before the enquiry officer be sent to Dr. Datta (Chaudhuri) and also another opportunity be given to her to file a supplementary reply/observation in addition to and without reiteration of the contents of her observations bearing letter dated 12.08.2017.



- (c) if Dr. Datta (Chaudhuri) desires to submit any supplementary observations/reply on the said enquiry report, she may be permitted to submit the same within ten (10) days from the date of receipt of the documents and statements positively.
- (d) the Registrar of Vidyasagar University be requested to communicate the decision of EC to Dr. Indrani Datta (Chaudhuri) in this regard.

06(g) To place before the Executive Council of Vidyasagar University, the letter dated 02.08.2017 received from Dr. Indrani Datta (Chaudhuri), Assistant Professor, Department of English of Vidyasagar University in reply to the show cause letter issued by the University to her pertaining to lodging the false complaint against her departmental colleagues.

**Resolution:** *The Executive Council of Vidyasagar University noted that Dr. Indrani Datta (Chaudhuri), Assistant Professor, Department of English of Vidyasagar University lodged a complaint on 28.02.2017 to the Dean(Acting) Faculties of Arts and Commerce regarding discrimination and harassing perpetrated upon her in the Department of English by her senior male colleagues' namely Dr. Joyjit Ghosh, Professor Debasish Bandyopadhyay, Professor Tirthankar Das Purkayasthya and Dr. Indranil Acharya. The Executive Council also noted that four teachers of English Department namely Dr. Joyjit Ghosh, Professor Debasish Bandyopadhyay, Professor Tirthankar Das Purkayasthya and Dr. Hemant Kumar Golapalli, colleagues' of Dr. Indrani Datta (Chaudhuri) sent a letter to the Hon'ble Vice-Chancellor intimating about threat given by Dr. Indrani Datta (Chaudhuri) towards male members of the said Department amounted to "molestation" towards her. It was stated that all the members were deeply shocked and humiliated by the threat being issued against them and sought for protection from the Hon'ble Vice Chancellor in the larger interest of the Department.*

*The Executive Council further noted that the Hon'ble Vice-Chancellor of this University sent the complaint letter of Dr. Indrani Datta (Chaudhuri) dated 28.02.2017 to Prof. Chandradipa Ghosh, the Chairperson of Internal Complaint Cell (ICC), Vidyasagar University on 02.03.2017 with a request to place the letter in the meeting of ICC. As per UGC (Prevention, Prohibition and Redressal of Sexual Harassment of Women Employees and Students in Higher Educational Institutions) Regulations, 2015, Internal Complaint Cell (ICC) was constituted in Vidyasagar University comprising of 10 (ten) members including Prof Chandradipa Ghosh as Chairperson and circulated by Notification dated 01.12.2016.*

*The Executive Council of Vidyasagar University noted again that the Internal Complaint Cell (ICC) took up the issue, heard Dr. Datta (Chaudhuri), those 4 (four) male colleagues of the Department of English as also other witnesses and submitted the report on 15.06.2017 holding that Dr. Datta (Chaudhuri) brought false, fabricated and baseless allegations against her colleagues of English department and recorded that subsequent dispute and trauma created by Dr. Datta (Chaudhuri) in the University had paralyzed the academic environment and activities of the Department of English. The Committee recommended for taking appropriate steps.*

*The Executive Council of Vidyasagar University noted further that the said Report of ICC was placed before the meeting of the Executive Council (EC) in its meeting held on 12.07.2017 and as decided by EC in its aforesaid meeting, copy of Report of ICC was sent by the Registrar with a letter dated 18.07.2017 to Dr. Indrani Datta (Chaudhuri) with a request to show cause*

why the University would not take appropriate steps for lodging such false, fabricated and baseless allegations against the departmental colleges.

The Executive Council of Vidyasagar University noted again that Dr. Datta (Chaudhuri) replied by a letter dated 02.8.2017 and took a point that Internal Complaint Cell (ICC) had/has no jurisdictional authority to take cognizance of her letter dated 28.02.2017 in view of the provisions of the Sexual harassment of Women at workplace (Prevention, Prohibition and Redressal) Act, 2013. She also challenged the report of ICC on merits and stated too that the ICC travelled beyond its Authority and jurisdiction so as to take cognizance of the independent complaints of Professor Debasish Bandhopadhyay, Dr. Indranil Acharya and Professor Tirthankar Das Purokayasthya.

The Executive Council of Vidyasagar University reminds that in past Dr. Datta (Chaudhuri) made similar complaints of sexual harassment upon her departmental colleagues which were found to be untrue in the enquiry conducted by Prevention of Sexual Harassment Cell. One of such enquiry was conducted upon complaint letter dated 17.07.2013 of Dr. Datta (Chaudhuri) against Dr. Tirthankar Das Purkayastha, the then H.O.D. of English with a counter complaint of Dr. Tirthankar Das Purkayastha dated 17.07.2013 to the effect that Dr. Datta (Chaudhuri) slapped on his face and his glasses flew off. The Committee in its report dated 14.8.2015 found the complaint as 'not proved'. The Committee also condemned the rude behaviour of Dr. Datta (Chaudhuri). Dr. Datta (Chaudhuri) also lodged several complaints before the Police authorities against her departmental colleagues over the issue of sexual harassment.

This time also Dr. Datta (Chaudhuri) lodged complaints before Police authorities over the issue of sexual harassment. The departmental colleagues also made counter complaints apprehending their humiliation over Dr. Datta (Chaudhuri)'s threatened action of framing them with serious criminal offence like 'sexual assault' and sent the copies to the Hon'ble Vice-Chancellor of this University.

After thorough discussion of the report of the Internal Complaint Cell (ICC) submitted by the Chairperson of the said Cell and careful consideration of the complaint letter, statements before ICC and reply letter upon ICC report of Dr. Datta (Chaudhuri), all statements recorded in the meetings of ICC, it was resolved that :

- (a) Objection regarding jurisdictional authority of Internal Complaint Cell (ICC) to hear the dispute is considered and it appears that in exercise of the Powers conferred by Clause (g) of Section 20(1) of UGC Act, 1956, The University Grants Commission (UGC) made UGC (Prevention, Prohibition and Redressal of Sexual Harassment of Women Employees and Students in Higher Educational Institutions) Regulations, 2015 and such Regulations are applicable to all Higher Educational Institutions in India. Under Regulation 4, every Executive Authority of Higher Educational Institutions will constitute an ICC who will enquire upon a complaint and submit its Report. So, ICC has jurisdictional authority to hear the dispute.
- (b) Secondly, Dr. Datta (Chaudhuri) complained against her Departmental male colleagues, namely Professor Debasish Bandhopadhyay, Dr. Indranil Acharya and Professor Tirthankar Das Purokayasthya and it is obvious that ICC will hear them as also the witnesses. So, this objection is also not tenable.

- (c) The Executive Council has given anxious thought over the matter. It appears from the Report of ICC that allegations of Dr. Indrani Datta (Chaudhuri) were found false and malicious and in that event, the Complainant is liable to be proceeded with in accordance with the service Rules of the Higher Educational Institutions, here the University.
- (d) Considering the gravity of the case, appropriate disciplinary proceeding be initiated against the complainant i.e. Dr. Indrani Datta (Chaudhuri), Assistant Professor, Department of English of Vidyasagar University and a Charge-sheet be issued against Dr. Datta (Chaudhuri) according to the Vidyasagar University Act & Ordinances over the false complaints of Dr. Datta (Chaudhuri) as also regarding other complaints the Hon'ble Vice-Chancellor received as well as complaint from the Head of the Department of English regarding dereliction of Duty, absentism of Dr. Datta (Chaudhuri), insubordination, breach of discipline, etc.
- (e) Dr. Datta (Chaudhuri) be placed under suspension with immediate effect in contemplation of the disciplinary proceeding.

06(h) To consider the letter dated 18.08.2017 submitted by Ms. Sukriti Hazra, a student applied for admission to M.Sc. course in Clinical Nutrition and Dietetics of this University for the session 2017-2018 pertaining to permission for admission into the said course as Specially Abled candidate.

**Resolution:** The Executive Council of Vidyasagar University noted the letter dated 18.08.2017 submitted by Ms. Sukriti Hazra, a student applied for admission to M.Sc. course in Clinical Nutrition and Dietetics of this University for the session 2017-2018 stating that she submitted the duly filled-in form for admission into the PG course in Clinical Nutrition & Dietetics of Vidyasagar University for the session 2017-2018 but she could not admitted herself in the said course in due course. She is a specially abled candidate and it is not possible to her to pursue her study in other institutes outside Midnapore. In this connection she has requested to consider her prayer and to permit herself for admission into the said course at Vidyasagar University.

After careful consideration of the letter submitted by Ms. Sukriti Hazra, a student applied for admission to M.Sc. course in Clinical Nutrition and Dietetics of this University for the session 2017-2018 pertaining to permission for admission into the said course as Specially Abled candidate, it was resolved that Ms. Hazra be permitted to take admission into the said course at Vidyasagar University for the session 2017-2018 as a special case, if otherwise eligible, taking into consideration of her Physically Challenged certificate. Resolved also that the Secretary, Faculty Councils for Postgraduate Studies of this University be requested to process further in this regard.

06(i) To place before the Executive Council of Vidyasagar University, the letter bearing No. 884-Edn(CS)/ED-926/2016 dated 08.08.2017 received from the Deputy Secretary to the Government of West Bengal, Department of Higher Education, Science & Technology and Biotechnology, C.S. Branch pertaining to placement of Administrator at Debra Thana Sahid Kshudiram Smriti Mahavidyalaya, Paschim Medinipur.

**Resolution:** The Executive Council of Vidyasagar University noted the letter bearing No. 884-Edn(CS)/ED-926/2016 dated 08.08.2017 received from



*the Deputy Secretary to the Government of West Bengal, Department of Higher Education, Science & Technology and Biotechnology, C.S. Branch stating that in exercise of powers conferred by Section 4(3) of the West Bengal Universities and Colleges (Administration and Regulation) Act, 2017, the Governor is hereby pleased to appoint Sub-Divisional Officer, Kharagpur as Administrator of the said College until reconstitution of the Governing Body of the College or until further order, whichever is earlier.*

*After thorough discussion on the letter received from the Deputy Secretary to the Government of West Bengal, Department of Higher Education, Science & Technology and Biotechnology, C.S. Branch pertaining to placement of Administrator at Debra Thana Sahid Kshudiram Smriti Mahavidyalaya, Paschim Medinipur, it was resolved that the said letter of the Deputy Secretary of Higher Education Department be accepted. Resolved also that the Inspector of Colleges of this University be requested to process further in this regard.*

- 06(j) To consider the letter dated 09.08.2017 submitted by Dr. N.K. Mandal, former Controller of Examinations of Vidyasagar University pertaining to forwarding his application to the Principal Secretary, Department of Higher Education, Science & Technology and Biotechnology, Government of West Bengal for his pensionery benefit.


**Resolution:** *The Executive Council of Vidyasagar University noted the letter dated 09.08.2017 submitted by Dr. N.K. Mandal, former Controller of Examinations of Vidyasagar University along with the application addressed to the Principal Secretary, Department of Higher Education, Science & Technology and Biotechnology pertaining to his pensionery benefit requesting to forward the same to the concerned addressee.*

*After thorough discussion on the letter submitted by Dr. N.K. Mandal, former Controller of Examinations of Vidyasagar University pertaining to forwarding his application to the Principal Secretary, Department of Higher Education, Science & Technology and Biotechnology, Government of West Bengal for his pensionery benefit, it was resolved that the prayer of Dr. Mandal for forwarding his application to the Department of Higher Education, Science & Technology and Biotechnology for his pensionery benefit be declined as Dr. Mandal did not complete his ten (10) years of service at Vidyasagar University before retirement.*
