



The Institute has also been placed in the A++ grade of institutions by the Business India Survey of Educational institutions. Now the Director has requested to extend the 2-Year Full-time Regular Master of Business Administration Programme for another period of five years in continuation of the existing one.

After thorough discussion on the letter dated 11.01.2017 received from the Director and Dean, Eastern Institute for Integrated Learning in Management, Kolkata pertaining to extension of affiliation for conducting 2-Year full-time regular M.B.A. programme for another five years and careful consideration of the other aspects of the said institute, it was resolved that further affiliation be extended to Eastern Institute for Integrated Learning in Management (EIILM), Kolkata for three (03) years starting from the session 2018-2019 for conducting 2-Year full-time regular M.B.A. programme of Vidyasagar University. - 06(e) To place before the Executive Council of Vidyasagar University, the leave application along with the letter and supporting documents submitted by Ms. Latika Sahu, Senior Assistant of this University pertaining to granting of medical leave during the period from 22.11.2016 to 11.01.2017 for fifty one (51) days for the treatment of her foot bone fracture.

**Resolution:** The Executive Council of Vidyasagar University noted the leave application along with the letter and supporting documents submitted by Ms. Latika Sahu, Senior Assistant of this University pertaining to granting of medical leave during the period from 22.11.2016 to

This is one of the steps towards the Digital India vision of Hon'ble Prime Minister which would be incomplete without the active participation of the academic institutions. NAD shall comprise of two interoperable digital depositories namely NSDL Database Management Limited (NDML) and CDSL Ventures Limited (CVL). These digital depositories shall keep the academic awards in the digital format and ensure data integrity. Since the Union Cabinet has approved the establishment and operationalisation of NAD, the Secretary has requested the University to enter into a Service Level Agreement with either of the depositories for boarding on to NAD. He has also advised to designate Nodal Officers and set up a NAD Cell immediately for implementation of NAD under intimation to UGC.

After thorough discussion on the letter received from the Secretary, University Grants Commission, New Delhi pertaining to designate Nodal Officers and set up a NAD Cell for implementation of NAD (National Academic Depository) at the Vidyasagar University, it was resolved that the NAD Cell be set up in this University as advised by the University Grants Commission, New Delhi for implementation of NAD. It was also resolved that the Controller of Examinations of this University be designated as the Nodal Officer of NAD Cell at Vidyasagar University and the matter be brought to the notice of the University Grants Commission in this regard.

- 06(g) To place before the Executive Council of Vidyasagar University, the letter bearing D.O. No. F.1-1/2013(IA) dated 29.11.2016 received from the Joint Secretary, University Grants Commission, New Delhi pertaining to adopting the policy of transactions through bank transfers, credit/debit cards & cheques and in rare cases drafts or cash transfers for utilization of grants.



**Resolution:** The Executive Council of Vidyasagar University noted the letter bearing D.O. No. F.1-1/2013(IA) dated 29.11.2016 received from the Joint Secretary, University Grants Commission, New Delhi stating that with the aim of bringing accountability, transparency and to take transfer of grants seamless and easy to the universities, the University Grants Commission had introduced the disbursement of grants through the Public Financial Management System (PFMS). Now the University Grants Commission has decided to advise the universities and the colleges that for the grants given by it to them, they may adopt the policy of transactions for utilization of grants through bank transfers, credit/debit cards & cheques and in rare cases drafts or cash transfers may be undertaken

After thorough discussion on the letter bearing D.O. No. F.1-1/2013(IA) dated 29.11.2016 received from the Joint Secretary, University Grants Commission, New Delhi pertaining to adopting the policy of transactions through bank transfers, credit/debit cards & cheques and in rare cases drafts or cash transfers for utilization of grants, it was resolved that the Finance Officer and the Inspector of Colleges of this University be requested to process further in this regard.

- 06(h) To place before the Executive Council of Vidyasagar University, the letter bearing D.O. No. F.1-1/2016(SAR) IA dated 31.10.2016 received from the Secretary, University Grants Commission, New Delhi pertaining to the guidelines/instructions to be followed on creation of Reserve/Corpus funds.

**Resolution:** The Executive Council of Vidyasagar University noted the letter bearing D.O.
