**Discussion:** 05(a) To consider the letter dated 12.08.2016 submitted by Dr. Monanjali Bandyopadhyay, Assistant Professor, Department of Bengali of Vidyasagar University pertaining to granting of Child Care Leave (CCL) from 06.12.2016 to 05.02.2017 for sparing the time to her ward for making a good future.

**Resolution :** *The Executive Council of Vidyasagar University noted the letter dated 12.08.2016 submitted by Dr. Monanjali Bandyopadhyay, Assistant Professor, Department of Bengali of Vidyasagar University stating that her little daughter aged about 14 years plus had to stay with her grandparents at Kolkata in their residence as herself and her spouse both are in University service and have to stay outside for various academic, survey and research purposes. Recently her father died and her widow mother has a plan to stay with her elder daughter for mental refreshment. As this transitional age for a girl child is very much important in the context of education, life style and physical and mental health and as they could not offer her a qualitative and quantitative time since long due to their busy schedule of teaching, The Executive Council also noted that Dr. Bandyopadhyay is requested to allow her a leave at least for three months so that she spare a minimum time to her ward for making a good future. In this connection Dr. Bandyopadhyay has requested to grant him Child Care Leave (CCL) from 06.12.2016 to 05.02.2017 for this purpose.*

*After careful consideration of the letter submitted by Dr. Monanjali Bandyopadhyay, Assistant Professor, Department of Bengali of Vidyasagar University pertaining to granting of Child Care Leave (CCL) from 06.12.2016 to 05.02.2017 for sparing the time to her ward for making a good future, it was resolved that the said Child Care Leave (CCL) be granted to Dr. Bandyopadhyay for this purpose as per the norms of the University.*

05(b) To place before the Executive Council of Vidyasagar University, the letter bearing No. BCI : D : 1519 [(LE : Cir.)-6] dated 17.09.2016 received from the Joint Secretary, Bar Council of India, New Delhi pertaining to revival of age restriction under Clause 28 of Legal Education Rules, 2008.

**Resolution:** *The Executive Council of Vidyasagar University noted the letter bearing No. BCI : D : 1519 [(LE : Cir.)-6] dated 17.09.2016 received from the Joint Secretary, Bar Council of India, New Delhi stating that the Bar Council of India had withdrawn Clause 28 vide resolution No. 200/2013 thereby age restriction was removed for admission in LL.B three year and five year course. The Executive Council also noted that later on, withdrawal*

of Clause 28 was challenged before the Madurai Bench of the Hon'ble High Court of Madras, the Hon'ble Court was pleased to allow the petition and held that withdrawal of Clause 28 by the Bar Council of India was illegal. The Executive Council noted further that subsequently, the Bar Council of India challenged the aforesaid decision of the High Court of Madras before the Hon'ble Supreme Court of India and the Hon'ble Court dismissed the Special Leave Appeal (Civil) and as per the decision of the Hon'ble Supreme Court of India, the rule under Clause 28 of Legal Education Rules 2008 has been restored. In this connection, the Joint Secretary has requested to comply with the provision of Clause 28 of Legal Education Rules 2008.

After thorough discussion on the letter received from the Joint Secretary, Bar Council of India, New Delhi pertaining to revival of age restriction under Clause 28 of Legal Education Rules, 2008 for admission to LL.B three year and five year courses, it was resolved that the provision of Clause 28 of Legal Education Rules 2008 regarding age restriction for admission to three year and five year LL.B courses be revived as advised by the Bar Council of India, New Delhi in compliance with the judgement of the Hon'ble Supreme Court of India. Resolved further that the Inspector of Colleges and the Secretary, Council for Undergraduate Studies of this University be requested to process further in this regard.

- 05(c) To place before the Executive Council of Vidyasagar University, the letter bearing Memo No. 1197/Dev. dated 06.09.2016 received from the District Magistrate, Paschim Medinipur pertaining to submission of proposed plan and estimate duly vetted by the competent authority and other supporting documents regarding development work of Vidyasagar University under MPLADS fund for 2016-2017.



The Executive Council also noted that several reminders were sent to Shri Roy for joining his duty at the DDE of the University and also he was requested to submit his formal resignation letter to the Hon'ble Vice-Chancellor and hand over his responsibilities to the Director of DDE for release, if he was unwilling to join his duty at the University, but no action has so far been taken from his end till date. The Executive Council noted further that Shri Roy only verbally communicated his inability to join his duty in this University over telephone.*

University within ten(10) days from the date of issue of the letter he will be terminated from the post of Officer-on Special Duty (OSD) of DDE and all the materials which are kept under his custody should be seized in presence of the local Police.

**Confirmation:** 06(a) To confirm the service of Dr. Dilip Kumar Maiti joined this University as Associate Professor in the Department of Applied Mathematics with Oceanology and Computer Programming with effect from his date of joining the post, i.e. from 30.09.2015.

**Resolution :** Resolved that on the basis of satisfactory performance of Dr. Dilip Kumar Maiti joined as Associate Professor in the Department of Applied Mathematics with Oceanology with Computer Programming of this University during his probation period, the service of Dr. Maiti be confirmed with effect from his date of joining the post i.e. from 30.09.2015.
