The UGC Standing Committee will scrutinize the list of journals and notify the same. In this connection, the Secretary has requested to send the list of journals duly recommended by the Subject Expert Committees in "excel format" to UGC. He has also stated that the hard copies of the list shall follow subsequently with the due signature of the Dean Academic Affairs/Director Research or Officer of equivalent position so as to start the process of scrutiny in UGC.

After thorough discussion on the letter of the Secretary, University Grants Commission, New Delhi pertaining to submission of the list of journals duly recommended by the Subject Expert Committee to the UGC for the purpose of computation of API scores, it was resolved that the Director of Internal Quality Assurance Cell (IQAC) of this University be requested to process further in this regard.

Any violation of these regulation will be viewed seriously. If any Institutions fails to take adequate steps to prevent ragging or does not act in accordance with these Regulations or fails to punish perpetrators of incidents of ragging suitably, it will attract punitive action against itself by the UGC. In this connection the Secretary has requested to set up anti-ragging mechanism by way of adequate publicity through various mediums. He has also requested to hold workshops, seminar or eradication of ragging in higher educational institutions and also requested to display 8x6 feet Anti Ragging Posters at all prominent places of the institutions. He has requested further to immediately instruct all the colleges under the purview of the University to submit online compliance of anti-ragging Regulations on curbing the menace of ragging in higher educational institutions, 2009. The Secretary has also stated that the UGC has notified the 3rd amendment in UGC Regulations on 29.06.2016 to expand the definition of ragging which may also be brought to the notice of colleges affiliated to Vidyasagar University.

After thorough discussion on the letter received from the Secretary, University Grants Commission, New Delhi pertaining to curbing the menace of ragging in higher educational institutions, it was resolved that necessary adequate measures for setting up of Anti-Ragging Mechanism, holding of workshops, seminar or eradication of ragging, display of Anti Ragging Posters at all prominent places of the University and its affiliated colleges be taken in this regard as advised by the UGC. Resolved also that the Inspector of Colleges, the Dean of Students' Welfare, the Secretary, Faculty Councils for Postgraduate Studies and the Secretary, Council for Undergraduate Studies of this University be requested to process further in this regard.

**Resolution:** *The Executive Council of Vidyasagar University noted the detailed proposal bearing letter No. VU/UE/351/2016 dated 25.07.2016 submitted by the University Engineer stating that at present there are eight (08) numbers of supporting staff in the office of the University Engineer in substantive manner. Besides this, ten (10) numbers more supporting staff are also engaged in the said office purely on contractual/daily wage basis. The construction/repairing/renovation/electrical works of the said department are increasing day by day and accordingly the work load of the supporting staff are increasing day by day. In this connection, the University Engineer has proposed to enhance the pay and allowances of the supporting staff engaged in the department purely on contractual/daily wage basis.*

*After careful consideration of the letter submitted by the University Engineer pertaining to the proposal for enhancement of pay and allowances to the staff engaged purely on contract basis/daily wage basis in the said department, it was resolved that a special allowance of rupees five hundred (Rs.500/-) only in addition to the existing pay be given to (a) Shri Ratisubhra Chakraborty, Sub-Assistant Engineer (Electrical), (b) Shri Ranjit Kumar Roy and (c) Shri Rajib Pal, Sub-Assistant Engineers(Civil) engaged in this University purely on contract basis with effect from 1st September, 2016. Resolved also that henceforth in case of further extension of contract period of Shri Ranjit Kumar Roy, the age bar of Shri Roy should be verified properly.*

- 05(c) To place before the Executive Council of Vidyasagar University, the letter dated 28.07.2016 received from the Research Officer, National Commission for SCs, Government of India, Salt Lake, Kolkata pertaining to representation of Ms. Tripti Das (SC), Kolkata regarding denial of age relaxation for admission in 3 years LL.B course from Vidyasagar University.

**Resolution:** *The Executive Council of Vidyasagar University noted the letter dated 28.07.2016 received from the Research Officer, National Commission for SCs, Government of India, Salt Lake, Kolkata opining that as per rules of Legal Education - 2008 framed by the Bar Council of India and the same being adopted by many Universities conducting legal courses of 5 years and 3 years durations relaxing age limits for 2 years and 5 years respectively, but it is evident from the letter issued by the University that*

the same has been denied in case of 3 years LL.B course where relaxation upto 5 years is permissible in case of SC/ST students. Also noted that in various internal meetings of the University, the matter although discussed and age relaxation for 2 years in case of 5 years LL.B course also considered, but due to some reasons, the age relaxation for 5 years in case of 3 years LL.B course have been avoided repeatedly. In the rules of Legal Education framed by BCI, inter alia it has been explicitly mentioned that "maximum age limit for seeking admission into a stream of Three Year Bachelor Degree Course in Law, is limited to thirty years with right of the University to give concession of 5 further year for applicant belonging to SC or ST or any other Backward Community". In this connection he has requested the University authority to amend its Rupees of Procedures for admission in LL.B courses in the spirit of Rules of Legal Education - 2008 and ensure that the SC/ST & OBC students of VU are not denied their legitimate claim for this purpose.

After thorough discussion on the letter received from the Research Officer, National Commission for SCs, Government of India, Salt Lake, Kolkata pertaining to representation of Ms. Tripti Das (SC), Kolkata regarding denial of age relaxation for admission in 3 years LL.B course from Vidyasagar University, it was resolved that the age bar for admission to LL.B. courses of this University for the SC/ST and any other backward community be relaxed as per the guideline of Rules of Legal Education – 2008 in this regard. Resolved also that the Inspector of Colleges and the Secretary, Council for Undergraduate Studies of this University be requested to process further in this regard.

- 05(d) To consider the letter bearing No. SJM/3/38/16 dated 02.08.2016 submitted by the Teacher-in-Charge, Swarnamoyee Jogendranath Mahavidyalaya, affiliated to Vidyasagar University pertaining to extension of affiliation for conducting Education (Honours) Course from the academic session 2016-2017.

**Resolution:** The Executive Council of Vidyasagar University noted the letter bearing No. SJM/3/38/16 dated 02.08.2016 submitted by the Teacher-in-Charge, Swarnamoyee Jogendranath Mahavidyalaya, affiliated to Vidyasagar University stating that they submitted a prayer to the West Bengal State Council of Higher Education and also the University authority for extension of affiliation to Education & Sociology (Honours) and Philosophy and Physical Education (General) subjects and accordingly the inspection for this purpose was held. The college has been favoured with the affiliation of Honours in Sociology and Philosophy and Physical Education as general subjects but the college has not yet been permitted honours course in Education. In this connection the Teacher-in-Charge has requested the University authority to extend affiliation to SJM for conducting Education (Honours) course from the academic session 2016-2017 on positive recommendation of the WBCHSE in this regard.

After thorough discussion on the letter submitted by the Teacher-in-Charge, Swarnamoyee Jogendranath Mahavidyalaya, affiliated to Vidyasagar University pertaining to extension of affiliation for conducting Education (Honours) Course from the academic session 2016-2017, it was resolved that necessary affiliation be extended to Swarnamoyee Jogendranath Mahavidyalaya for conducting Education (Hons.) course from the academic session 2016-2017. Resolved also that the Inspector of Colleges and Secretary, Council for Undergraduate Studies of this University be requested to process further in this regard as per the norms of the University.



- 05(e) To consider the letter bearing No. VU/UE/389/2016 dated 04.08.2016 submitted by the University Engineer pertaining to continuation of temporary service (in extension) rendered by Shri Subhas Ghughu as Pump Operator in the office of the University Engineer of this University since May, 2015 till date.

**Resolution:** *The Executive Council of Vidyasagar University noted that the service of Shri Subhas Ghughu as Pump Operator was extended temporarily initially for a period of one month after his superannuation from the University (31.01.2015) with effect from 01.02.2015 with a consolidated pay per month at the rate of rupees twelve thousand (Rs.12,000/-) per month. Thereafter his temporary service (in extension) was further extended for a further period of two months, i.e. upto April, 2015 and after that no further extension was made by the University in this regard although Shri Ghughu is rendering his temporary service as Pump Operator till date without any break. In this connection the University Engineer has submitted a letter bearing No. VU/UE/389/2016 dated 04.08.2016 requesting for continuation of temporary service (in extension) rendered by Shri Subhas Ghughu as Pump Operator in the office of the University Engineer of this University since May, 2015 till date.*

*After thorough discussion on the letter submitted by the University Engineer pertaining to continuation of temporary service (in extension) rendered by Shri Subhas Ghughu as Pump Operator in the office of the University Engineer of this University since May, 2015 till date, it was resolved that the temporary service (in extension) during the period from May, 2015 to 08.09.2016 rendered by Shri Ghughu as Pump Operator in the office of the University Engineer without approval of the University authority be approved and regularized as post-facto with the same terms & conditions. Resolved also that the temporary service (in extension) of Shri Ghughu be further extended for a period of three months with effect from 09.09.2016.*

- 05(f) To place before the Executive Council of Vidyasagar University, the letter dated 28.07.2016 submitted by the Head, Department of Applied Mathematics with Oceanology and Computer Programming of this University pertaining to the decision of the Departmental Committee regarding extension of leave with lien of Dr. Biswajit Sarkar, Assistant Professor of the said department for further one year more w.e.f. 01.09.2016 to 31.08.2017 for completion of his contractual position at Hanyang University, South Korea.

**Resolution:** *The Executive Council of Vidyasagar University noted that the matter regarding extension of leave with lien of Dr. Biswajit Sarkar, Assistant Professor, Department of Applied Mathematics with Oceanology with Computer Programming of this University for further one year more w.e.f. 01.09.2016 to 31.08.2017 for completion of his contractual position at Hanyang University, South Korea was placed before the Working Committee of Vidyasagar University in its meeting dated 13.07.2016 wherein it was resolved that the Departmental opinion in this regard be sought for and the matter be placed before the next meeting of the Executive Council for consideration. The Executive Council also noted that the concerned department was communicated accordingly and on the basis of the said decision of the Working Committee, the Head of the department concerned has submitted a letter dated 28.07.2016 regarding the decision of the departmental committee taken in an emergency meeting dated*



28.07.2016 in this regard. The Executive Council further noted the decision of the departmental committee in this regard.

After thorough discussion on the letter submitted by Dr. Biswajit Sarkar, Assistant Professor, Department of Applied Mathematics with Oceanology and Computer Programming pertaining to extension of leave with lien for a further period of one year more w.e.f. 01.09.2016 to 31.08.2017 for completion of his contractual position at Hanyang University, South Korea and careful consideration of the decision taken by the Departmental Committee of the said department based on the decision taken by the Executive Council earlier in this regard, it was resolved that the lien period as was granted to Dr. Sarkar earlier be extended for a further period of six months with effect from 01.09.2016 and no further extension be made in this regard. Resolved also that Dr. Sarkar be requested to come back to the University within the extended lien period, i.e. upto 31.01.2017 and if he fails to join his duty at the University within the stipulated period his service at the University will be discontinued.

- 05(g) To place before the Executive Council of Vidyasagar University, the Annual Accounts along with the Balance Sheet, Income & Expenditure Accounts and Receipts and Payments Account of Vidyasagar University for the financial year 2015-2016.

**Resolution:** The Executive Council of Vidyasagar University noted the detailed Annual Accounts along with the Balance Sheet, Income & Expenditure Accounts and Receipts and Payments Account of Vidyasagar University for the financial year 2015-2016 prepared and submitted by the office of the Finance Officer and duly recommended by the Finance Committee of Vidyasagar University in its meeting dated 29.07.2016.

After thorough discussion on the Annual Accounts along with the Balance Sheet, Income & Expenditure Accounts and Receipts and Payments Account of Vidyasagar University for the financial year 2015-2016 prepared and submitted by the office of the Finance Officer, it was resolved that the said Annual Accounts of Vidyasagar University duly recommended by the Finance Committee of Vidyasagar University be accepted and forwarded to the Court of Vidyasagar University for approval.

- 05(h) To place before the Executive Council of Vidyasagar University, the detailed Inspection Report submitted by the duly constituted Inspection Team pertaining to the allegations made by Dr. Suparna Sadhu, Assistant Professor in Chemistry, Sukumar Sengupta Mahavidyalaya.

**Resolution:** The Executive Council of Vidyasagar University noted the detailed report submitted by the duly constituted Inspection Team pertaining to the allegations made by Dr. Suparna Sadhu, Assistant Professor in Chemistry, Sukumar Sengupta Mahavidyalaya regarding physical assault in the college premises.

After thorough discussion on the Inspection Report submitted by the duly constituted Inspection Team pertaining to the allegations made by Dr. Suparna Sadhu, Assistant Professor in Chemistry, Sukumar Sengupta Mahavidyalaya pertaining to physical assault in the college premises, it was resolved that the said Inspection Report be accepted. Resolved also that the recommendations of the said team in this regard be forwarded to the President of the Governing Body of the said college for his perusal and necessary execution. Resolved further that the Principal of the said college be requested to ensure that such events are not repeated in future. Resolved



again that the Principal of the said college be also requested to provide good/congenial academic environment in his college or in the college premises and to submit an Action Taken Report (ATR) to the Inspector of Colleges of this University in this regard. Resolved again that the Registrar be requested to send the letter to the Principal in this regard.

- 05(i) To place before the Executive Council of Vidyasagar University, the letter bearing No. VU/CC/349/16 dated 24.08.2016 submitted by the Director of Computer Centre of Vidyasagar University pertaining to empower the financial power up to rupees three thousand (Rs.3,000/-) only to the Director of Computer Centre for execution of certain work on urgent basis.

**Resolution:** The Executive Council of Vidyasagar University noted the letter bearing No. VU/CC/349/16 dated 24.08.2016 submitted by the Director of Computer Centre of Vidyasagar University stating that the Computer Centre of this University is now involved with the services/maintenance related work of the whole campus LAN, CCTV, ICT and Peripheral devices. As per the existing practice of the University, formal approval from the University for execution of such related jobs is necessary and for this purpose more time is required. In this connection, the Director of Computer Centre has requested to empower him a financial power of rupees three thousand (Rs.3,000/-) only so that they can execute certain works on urgent basis.

After thorough discussion on the letter submitted by the Director of Computer Centre of Vidyasagar University pertaining to empower the financial power up to rupees three thousand (Rs.3,000/-) only to the Director of Computer Centre for execution of certain work on urgent basis, it was resolved that the Director of Computer Centre of this University be empowered the financial limit up to rupees three thousand (Rs.3,000/-) only for urgent execution of ICT services related jobs.

- 05(j) To consider the letter bearing Memo No. P.B.C./1050/16 dated 22.08.2016 submitted by the Principal, Panskura Banamali College, affiliated to Vidyasagar University pertaining to registration of one migrated student in B.Ed. course for the session 2015-2016.

**Resolution:** The Executive Council of Vidyasagar University noted the letter bearing Memo No. P.B.C./1050/16 dated 22.08.2016 submitted by the Principal, Panskura Banamali College, affiliated to Vidyasagar University, stating that the duly filled-in Registration Form of one migrated student, namely, Sunil Samanta could not submitted within the time frame stipulated by the University due to delay issue of Migration Certificate by Vinayaka Mission University. The candidate concerned has attended classes both theoretical and practical regularly and also appeared in the internal examinations for the session 2015-2016. In this connection, the Principal has requested to consider the matter and to register himself to the said course for the academic session 2015-2016 so that he may receive the mark sheet of B.Ed. 1st Semester Examinations, 2016.

After thorough discussion on the letter submitted by the Principal, Panskura Banamali College, affiliated to Vidyasagar University pertaining to registration of Shri Sunil Samanta, a migrated student from the Vinayaka Mission University, in B.Ed. course at Vidyasagar University for the session 2015-2016 as the concerned incumbent could not submit his migration certificate within the stipulated date framed by the University authority, it was resolved that decided that Shri Samanta be permitted to

register himself in B.Ed. course at the Vidyasagar University for the session 2015-2016 as a special case subject to verification of genuineness of Migration Certificate of Vinayaka Mission University submitted by him for registration in this University.

- 05(k) To place before the Executive Council of Vidyasagar University, the Note dated 05.09.2016 prepared and submitted by the Ph.D. Cell of this University pertaining to formation of the Board of Research Studies in Arts & Commerce and Science as per the norms of the University.

**Resolution:** The Executive Council of Vidyasagar University noted the Note dated 05.09.2016 prepared and submitted by the Ph.D. Cell of this University stating that in pursuance of provision of Section 2.2 of the Ph.D. Regulations of Vidyasagar University, the Board of Research Studies in Arts & Commerce and Science was constituted for a period of four years with effect from 11.10.2012, the term of which is going to be expired on 10.10.2016. In this connection the Board of Research Studies in Arts & Commerce and Science are to be re-constituted. In terms of the said norms in clause (iii) of Section 2.2, two senior Professors of each faculty to be nominated by the Executive Council.

After thorough discussion on the note prepared and submitted by the Ph.D. Cell of this University pertaining to formation of the Board of Research Studies in Arts & Commerce and Science as per the norms of the University, it was resolved that the said Board of Research Studies be re-constituted and two Senior Professors of each faculty be nominated in terms of clause (iii) of Section 2.2 of the Ph.D. Regulations of Vidyasagar University. Resolved also that regarding nomination of two Senior Professors of each faculty, the matter be left to the Hon'ble Vice-Chancellor for necessary action.

- 05(l) To discuss the matter regarding introduction of the fees-structure for extension of affiliation to L.L.M. course under Vidyasagar University.

**Resolution:** The Executive Council of Vidyasagar University noted that the Seventh Executive Council of Vidyasagar University in its meeting dated 16.07.2013 introduced the fees-structure for inspection regarding extension of affiliation of subject(s)/course(s) etc. for the undergraduate colleges of Vidyasagar University except LL.M. course. The Executive Council also noted that the Inspector of Colleges of this University has proposed that the fees-structure for LL.M. course for this purpose is to be introduced. The Executive Council noted further that the Inspector of Colleges has also proposed that for starting LL.M. course rupees thirty thousand (Rs.30,000/-) only appears logical commensurate with the fees-structure of Self-financed B.Ed./M.Ed./B.P.Ed./M.P.Ed. College duly approved by the EC earlier.

After thorough discussion on the matter regarding introduction of the fees-structure for extension of affiliation to L.L.M. course under Vidyasagar University and careful consideration of the proposal submitted by the Inspector of Colleges of this University in this regard, it was resolved that an amount of rupees thirty thousand (Rs.30,000/-) only be charged for extension of affiliation to the said LL.M. course as proposed by the Inspector of Colleges in this regard.



- 05(m) To place before the Executive Council of Vidyasagar University, the letter bearing No. SLC/12/V.U./277/2016 dated 22.08.2016 along with the proposal for extension of affiliation to Sarsuna Law College, affiliated to Vidyasagar University, for introduction of LL.M. Course from the academic session 2016-2017.

**Resolution:** *The Executive Council of Vidyasagar University noted the letter bearing No. SLC/12/V.U./277/2016 dated 22.08.2016 along with the proposal submitted by the Teacher-in-Charge of Sarsuna Law College, affiliated to Vidyasagar University, stating that they have received No Objection Certificate from the Higher Education Department, CS Branch, Government of West Bengal for running LL.M. course from the academic session 2016-2017. They have sufficient and adequate infrastructure for running such course. In this connection, the Teacher-in-Charge has requested the University to extend affiliation them for introduction of the said course at Sarsuna Law College. The Executive Council also noted the Note bearing No. VU/IC/IN/1368/2016 dated 07.09.2016 prepared and submitted by the Inspector of Colleges of this University in this regard. The Executive Council noted further the No Objection Certificate received by the Sarsuna Law College from the Higher Education Department in this regard. After thorough discussion on the letter along with the proposal for extension of affiliation to Sarsuna Law College, affiliated to Vidyasagar University, for introduction of LL.M. Course from the academic session 2016-2017 and subsequently the note prepared and submitted by the Inspector of Colleges in this regard and also careful consideration of the No Objection Certificate issued by the Higher Education Department, Government of West Bengal in this regard, it was resolved that the temporary affiliation be extended to Sarsuna Law College, Kolkata for introduction of 2-Year LL.M. course of Sarsuna Law College with effect from the session 2016-2017 subject to the pending decision of the Inspection Team constituted for this purpose and also fulfillment of the terms & conditions which will be communicated after the inspection for this purpose is concluded.*

- 05(n) To consider the letter bearing No. 300-WCMID/16 dated 23.08.2016 submitted by the Principal, Raja N.L. Khan Womens' College, affiliated to Vidyasagar University, pertaining to permission of Ms. Runu Sinha, passed out student in B.Sc. (H) in the year 2013, for admission into M.Sc. course in Human Physiology with Community Health Coure at Raja N.L. Khan Womens' College for the session 2016-2017.

**Resolution:** *The Executive Council of Vidyasagar University noted the letter bearing No. 300-WCMID/16 dated 23.08.2016 submitted by the Principal, Raja N.L. Khan Womens' College, affiliated to Vidyasagar University stating that Ms. Runu Sinha passed B.Sc. (H) in the year 2013 from Tamralipta Mahavidyalaya. Unfortunately, she could not continue her study due to some personal reason. Now she has applied for admission into M.Sc. course in Human Physiology with Community Health course at their college for the session 2016-2017. In this connection, the Principal has requested to permit her for admission into the said course at their college as some seats are lying vacant. The Executive Council also noted the prayer of Ms. Runu Sinha in this regard submitted along with the said letter. After thorough discussion on the letter submitted by the Principal, Raja N.L. Khan Womens' College, affiliated to Vidyasagar University, pertaining to permission of Ms. Runu Sinha, passed out student in B.Sc. (H) in the year*

2013, for admission into M.Sc. course in Human Physiology with Community Health Course at Raja N.L. Khan Womens' College for the session 2016-2017 and subsequently the prayer submitted by Ms. Runu Sinha in this regard, it was resolved that Ms. Runu Sinha may be permitted to take admission into M.Sc. course in Human Physiology with Community Health at Raja N.L. Khan Womens' College for the session 2016-2017 as a special case subject to fulfillment of all other norms in this regard.

- 05(o) To place before the Executive Council of Vidyasagar University, the letter bearing No. MAC/PA(V.U.)/675/16 dated 28.07.2016 submitted by the Principal and Secretary, Midnapore Art College, Midnapore pertaining to extending affiliation to Midnapore Art College.

**Resolution:** The Executive Council of Vidyasagar University noted the letter bearing No. MAC/PA(V.U.)/675/16 dated 28.07.2016 submitted by the Principal and Secretary, Midnapore Art College, Midnapore pertaining to extension of affiliation to Midnapore Art College. The Executive Council also noted the No Objection Certificates received by them from the West Bengal State Council of Higher Education in this regard. The Executive Council noted further that the matter regarding transferring affiliation of Midnapore Art College from Rabindra Bharati University to Vidyasagar University was placed before the Eighth Executive Council of Vidyasagar University in its meeting dated 25.07.2016 [Item 2(b)] wherein the prayer regarding transferring affiliation of Midnapore Art College from Rabindra Bharati University to Vidyasagar University was regretted/declined as there is no such provision to offer such programme in this University at present.

After thorough discussion on the letter submitted by the Principal and Secretary, Midnapore Art College, Midnapore pertaining to extending affiliation to Midnapore Art College, it was resolved that the said prayer of Midnapore Art College be declined as decided by the Executive Council earlier in its meeting dated 25.07.2016 [Item No. 2(b)].

- 05(p) To consider the letter bearing No. MRC/16 dated 07.09.2016 submitted by the Principal, Mahishadal Raj College pertaining to increase of six (06) additional intake for postgraduate course in Chemistry and Chemical Technology of the said college for the session 2016-2017.

**Resolution:** The Executive Council of Vidyasagar University noted the letter bearing No. MRC/16 dated 07.09.2016 submitted by the Principal, Mahishadal Raj College stating that at present the college has twenty five (25) intake capacity for M.Sc. course in Chemistry and Chemical Technology duly approved by the University authority. To meet the demand of the students they need six (06) more seats in addition to the existing intake of twenty five (25) for the session 2016-2017. In this connection, the Principal has requested to increase the additional intake of six (06) for the said M.Sc. course of the college.

After thorough discussion on the letter submitted by the Principal, Mahishadal Raj College pertaining to increase of six (06) additional intake for postgraduate course in Chemistry and Chemical Technology of the said college for the session 2016-2017, it was resolved that five (05) intake in addition to the existing intake of twenty five (25) be increased for P.G. course in Chemistry and Chemical Technology of the said college for the academic session 2016-2017. The EC also decided that the Inspector of Colleges and the Secretary, Faculty Councils for Post-graduate Studies of this University be requested to communicate the same to the Principal of the concerned college in this regard.

- 05(q) To place before the Executive Council of the Vidyasagar University, the letter dated 07.09.2016 submitted by Dr. Subrata Kumar De, Professor & Head, Department of Zoology and Dean (Actg.), Faculty of Science of this University pertaining to donation of an amount of rupees twenty five thousand (Rs.25,000/-) only received from the Government of West Bengal as Siksha Ratna Award "Outstanding University Teacher Award" for 2016 to the University for the academic welfare of the poor students of the University.

**Resolution:** The Executive Council of Vidyasagar University noted the letter dated 07.09.2016 submitted by Dr. Subrata Kumar De, Professor & Head, Department of Zoology and Dean (Actg.), Faculty of Science of this University stating that he has received the award SIKSHA RATNA "Outstanding University Teacher Award" for 2016 along with twenty five thousand (Rs.25,000/-) only as award money from the Government of West Bengal. Now he desires to donate the said amount to the University for the academic welfare of the poor students of the University. In this connection Dr. De has requested to accept his prayer. The Executive Council also noted that a cheque bearing No. 343669 dated 07.09.2016 for rupees twenty five thousand (Rs.25,000/-) only submitted by him in his aforesaid letter.

After thorough discussion on the letter submitted by Dr. Subrata Kumar De, Professor & Head, Department of Zoology and Dean (Actg.), Faculty of Science of this University pertaining to donation of an amount of rupees twenty five thousand (Rs.25,000/-) only received from the Government of West Bengal as Siksha Ratna Award "Outstanding University Teacher Award" for 2016 to the University for the academic welfare of the poor students of the University, it was resolved that the said donation of rupees twenty five thousand (Rs.25,000/-) only be accepted gladly from Professor De. The Executive Council also congratulated Professor De for getting such award from the Government of West Bengal as one of the teachers of Vidyasagar University. Resolved also that a thanks letter be issued to Professor De in this regard. Resolved further that an amount of rupees twenty five thousand (Rs.25,000/-) only be sanctioned from the University for opening a corpus fund out of which a total amount of rupees eight six thousand (Rs.86,000/-) only [rupees twenty five thousand (Rs.25,000/-) only sanctioned by the University plus rupees twenty five thousand (Rs.25,000/-) only donated by Professor De as Siksha Ratna Award plus rupees thirty six thousand (Rs.36,000/-) only donated earlier by Professor De towards his honorarium of Merged Scheme of UGC] be deposited in the said corpus fund. The amount of interest which will be gained from such corpus fund be allotted for the academic welfare of the poor students of this University time to time under the discretion of the Hon'ble Vice-Chancellor of this University.

- 05(r) To consider the letter dated 07.09.2016 submitted by the Teacher-in-Charge, Ghatal Rabindra Satabarsiki Mahavidyalaya, Ghatal pertaining to increase of five (05) additional intake in B.A. (General) course of the said college for the session 2016-2017.

**Resolution:** The Executive Council of Vidyasagar University noted the letter dated 07.09.2016 submitted by the Teacher-in-Charge, Ghatal Rabindra Satabarsiki Mahavidyalaya, Ghatal requesting for increase of five (05) more intake in addition to the existing intake capacity of B.A. (General) course of the said college for the academic session 2016-2017 due to demand of the students of that area.

After thorough discussion on the letter submitted by the Teacher-in-Charge, Ghatal Rabindra Satabarsiki Mahavidyalaya, Ghatal pertaining to increase of five (05) additional intake in B.A. (General) course of the said

college for the session 2016-2017, it was resolved that decided that five (05) intake in addition to the existing intake be increased for B.A. (General) course of the said college for the academic session 2016-2017. The EC also decided that the Inspector of Colleges and the Secretary, Council for Undergraduate Studies of this University be requested to communicate the same to the concerned Principal/Teacher-in-Charge in this regard.

- 05(s) To place before the Executive Council of the Vidyasagar University, the note prepared and submitted by the Inspector of Colleges of this University pertaining to the proposal for inspection fees from institutions.  
**Resolution:** *The Executive Council of Vidyasagar University noted the note prepared and submitted by the Inspector of Colleges of this University proposing the inspection fees pertaining to increase of intake capacity and setting up of a new colleges/introduction of new courses of Self-financed affiliated Paramedical Courses, Law and Art Colleges both UG & PG etc. After thorough discussion on the note prepared and submitted by the Inspector of Colleges of this University pertaining to charging the inspection fees regarding increase of intake capacity and setting up of a new colleges/introduction of new courses of Self-financed affiliated Paramedical Courses, Law and Art Colleges both UG & PG etc. of this University, it was resolved that the said inspection fees be approved for this purpose as proposed by the Inspector of Colleges of this University.*
- 05(t) To place before the Executive Council of the Vidyasagar University, the matter regarding promotion of Dr. Keshab Chandra Mondal, Associate Professor, Department of Microbiology of Vidyasagar University to the post of Professor under the Career Advancement Scheme.  
**Resolution:** *After thorough discussion on the matter regarding promotion of Dr. Keshab Chandra Mondal, Associate Professor, Department of Microbiology of this University to the post of Professor under the Career Advancement Scheme, it was resolved that the performance of Dr. Mondal be kept under observation till October, 2016 for improvement and if the performance of Dr. Mondal improves during the above period, necessary process for his promotion under CAS be initiated in the month of November, 2016 onwards.*
- 05(u) To place before the Executive Council of Vidyasagar University, the letter bearing No. VMATCT/37/Spl.B.Ed./En.Fee/July 23,2016 submitted by the General Secretary, Vivekananda Mission Asram, Chaitanyapur regarding lowering the Enrolment Fees from ten percent (10%) of the course fees to rupees one thousand (Rs.1,000/-) only per trainees of the session 2014-2015 of VMA Training College of eachers of the Visually Impaired.  
**Resolution:** *The Executive Council of Vidyasagar University noted that the matter regarding payable of institutional dues of B.Ed. Spl. Ed. (V.I) course and also consideration of the enrolment fees for such course for the session 2014-2015 submitted by the General Secretary, Vivekananda Mission Asram, Chaitanyapur was placed before the Working Committee of Vidyasagar University in its meeting dated 13.07.2016 [Item No. 04(c)] wherein it was decided that the Vivekananda Mission Asram authority be requested to furnish the information regarding the total number of Physically Challenged students admitted to such course for the said session and if the enrolment fees for the above session is considered then what benefits should be extended to those students in this regard.*



The Executive Council also noted that as per the decision of the Working Committee, the concerned institution was communicated by the Inspector of Colleges and in reply to that the Asram authority has submitted a letter bearing No. VMATCT/37/Spl.B.Ed./En.Fee/July 23,2016 submitted by the General Secretary, Vivekananda Mission Asram, Chaitanyapur regarding lowering the Enrolment Fees from ten percent (10%) of the course fees to rupees one thousand (Rs.1,000/-) only per trainees of the session 2014-2015 of VMA Training College of eachers of the Visually Impaired.

After thorough discussion on the letter submitted by the General Secretary, Vivekananda Mission Asram, Chaitanyapur regarding lowering the Enrolment Fees from ten percent (10%) of the course fees to rupees one thousand (Rs.1,000/-) only per trainees of the session 2014-2015 of VMA Training College of eachers of the Visually Impaired, it was resolved that the Vivekananda Mission Asram, Chaitanyapur be permitted to deposit rupees one thousand (Rs.1,000/-) only per student as enrollment fees for the B.Ed. Spl.Ed.(V.I.) course for the session 2014-2015 as a special case as the Secretary of Vivekananda Mission Asram has communicated in its aforesaid letter that the benefit of such reduced fees will be extended to the students of such course.

- 05(v) To discuss the matter pertaining to conducting the Ninth (9th) Vidyasagar Memorial Lecture at the Vidyasagar University.

**Resolution:** After thorough discussion on the matter regarding holding the Ninth (9<sup>th</sup>) Vidyasagar Memorial Lecture at the Vidyasagar University, it was resolved that the said Memorial Lecture be held in this University. Resolved also that Dr. Subodh Sarkar be invited as Speaker to deliver his valuable speech on the said occasion. Resolved further that an amount of rupees fifty thousand (Rs.50,000/-) only be sanctioned for this purpose.


- 05(w) To place before the Executive Council of Vidyasagar University, the comparative statements prepared by the office of the University Engineer for selection of lowest bidders for different civil and electrical works of Vidyasagar University.

**Resolution:** The Executive Council of Vidyasagar University noted the detailed comparative statements prepared by the office of the University Engineer and duly recommended by the Maintenance/Repair Committee in its meeting held on 28.07.2016 and the Finance Committee of Vidyasagar University in its meeting dated 29.07.2016 respectively for selection of lowest bidders for different civil and electrical works of Vidyasagar University.

After thorough discussion on the comparative statements prepared by the office of the University Engineer for selection of lowest bidders for different civil and electrical works of Vidyasagar University, it was resolved that the said comparative statements duly recommended by the Maintenance/Repair Committee and the Finance Committee for this purpose be accepted and approved.

- 05(x) To discuss the matter regarding appointment to the post of Laboratory Attendant Gr.-III (Unreserved) of the University.

**Resolution:** The Executive Council of Vidyasagar University noted that the process for appointment to the post of Laboratory Attendant Gr.-III (Unreserved) was started and a screening test for this purpose was conducted on 12.02.2014 as huge number of candidates applied for the said



post. The Executive Council also noted that thereafter further process could not be completed in this regard.

After thorough discussion on the matter regarding appointment to the post of Laboratory Attendant Gr.-III (Unreserved) of Vidyasagar University, it was resolved that the said post be re-advertised as per the norms of the University for recruitment as the process of such appointment has not been completed till now.

**Re-employment:** 06(a) To consider the application submitted by Prof. Kartick Chandra Paul, Department of Business Administration of the Vidyasagar University in connection with extension of re-employment for a further period (Fifth & Final year) with effect from 01.10.2016.

**Resolution :** *The Executive Council of Vidyasagar University considered the application of Dr. Kartick Chandra Paul, Professor, Department of Business Administration of this University seeking extension of re-employment for a further period (Fifth & final year) with effect from 01.10.2016.*


*Resolved that a Screening Committee be constituted as per rules in connection with the extension of re-employment of Professor Kartick Chandra Paul, Department of Business Administration of this University for a further period (Fifth & final year) with effect from 01.10.2016. Resolved also that regarding nomination of two subject experts in the Screening Committee for extension of re-employment of Prof. Kartick Chandra Paul by the Executive Council, the matter be left to the Hon'ble Vice-Chancellor for necessary action. Resolved further that the Registrar be requested to take necessary steps in this regard.*

**Renewal of Service:** 07(a) To consider the application dated 20.07.2016 submitted by Syed Jafar Ali, Junior Peon (Contractual) of this University pertaining to renewal of his contract service for a further period.

**Resolution :** *The Executive Council of Vidyasagar University considered the application submitted by Syed Jafar Ali, Junior Peon of this University purely on contract basis pertaining to renewal of his contract service in his present post for a further period.*

*Resolved that on the basis of the satisfactory performance during his contract period, the contract service of Syed Jafar Ali in the post of Junior Peon of Vidyasagar University be renewed for a further period of two(2) years with effect from 01.09.2016 along with the admissible allowance as per the norms of the University.*
