*After thorough discussion on the letter of the Teacher-in-Charge, Swarnamoyee Jogendranath Mahavidyalaya, Amdabad in the district of Purba Medinipur pertaining to inclusion of two members of the Swarnamoyee Jogendranath Institute for Education, Research and Social Welfare to the Governing Body of Swarnamoyee Jogendranath Mahavidyalaya, it was resolved that one member of the SJIERS Welfare Trust based on their nominations be nominated to the Governing Body of Swarnamoyee Jogendranath Mahavidyalaya. Resolved also that the Inspector of Colleges of this University be requested to proceed further in this regard.*

- 06(c) To place before the Executive Council of Vidyasagar University, the letter bearing No. VU/IC/1A/2015 dated 21.11.2015 submitted by the Principal, Sabang Sajani Kanta Mahavidyalaya pertaining to election of the President of the 8th re-constituted Governing Body and recent stalemate situation in smooth functioning of the college.

**Resolution:** *The Executive Council of Vidyasagar University noted the letter bearing No. VU/IC/1A/2015 dated 21.11.2015 submitted by the Principal, Sabang Sajani Kanta Mahavidyalaya stating that they could not complete the process of the election of President of the 8th Governing Body in the month of July, 2015 & onwards in absence of regular students' representative and followed by grave situations caused for fatal incident (death of Krishna Prasad Jana, an ex-student) happened in their college premises on 07.08.2015. The Executive Council also noted that the President of the 7th Governing Body of the college has expressed his unwillingness to perform any sort of operation of fund. As a consequence, college is going to face a stalemate situation regarding financial transactions, payment of suppliers, construction works (MPLAD), payment of salary to staff, utilization of RUSA etc. In this connection he has requested to seek valuable opinion from the University authority in this regard. The Executive Council noted further that on the basis of the note bearing No. VU/IC/IN-710 dated 08.12.2015 put forwarded by the Inspector of Colleges*

of this University based on the request made by the Principal, Sabang Sajani Kanta Mahavidyalaya pertaining to appointment of Administrator in Sabang Sajani Kanta Mahavidyalaya regarding non-formation of the new Governing Body (8th) of the College, has appointed Dr. Asim Kumar Bera, Principal, Mahishadal Raj College as an Administrator of Sabang Sajani Kanta Mahavidyalaya with effect from 08.12.2015 for taking over the management of the college upto 31<sup>st</sup> December, 2015 or until the next meeting of the Executive Council.

After thorough discussion on the letter of the Principal, Sabang Sajani Kanta Mahavidyalaya pertaining to election of the President of the 8th re-constituted Governing Body and recent stalemate situation in smooth functioning of the college and subsequently the action taken by the Hon'ble Vice-Chancellor in appointing Dr. Asim Kumar Bera, Principal, Mahishadal Raj College as an Administrator of the said college as per the norms of the University, it was resolved that the action of the Hon'ble Vice-Chancellor in appointing Dr. Asim Kumar Bera as Administrator of the college be ratified. Resolved also that the tenure of Dr. Bera as Administrator of the said college be extended for a further period of six months or until further order whichever is earlier with effect from 29.12.2015.

- 06(d) To place before the Executive Council of Vidyasagar University, the letter dated 10.12.2015 submitted by Ms. Tanuja Sarkar, wife of Late Ashrujit Sarkar, former employee of DDE of this University pertaining to extend appointment in any family member of Late Ashrujit Sarkar under die-in-harness ground.

*After thorough discussion on the letter of the Principal, Sukumar Sengupta Mahavidyalaya pertaining to waiving the fines for delay in submission of Registration Forms of 1750 candidates of 1st year classes of Sukumar Sengupta Mahavidyalaya for the session 2015-2016, it was resolved that the prayer of the Principal in this regard be declined. Resolved also that a fine*

@ Rs.60/- (Rupees sixty) only per candidate be imposed for the purpose of said registration as a special case. Resolved further that an undertaking be made by the Principal/Teacher-in-Charge of the concerned college stating not to repeat such practice in future. Resolved again that the Registrar(Actg.) be requested to communicate the same to the concerned college for necessary action immediately.

- 06(l) To consider the letter dated 01/12/2015 submitted by Ms. Saswati Roy, Professional Assistant (Temporary), Women's Studies Centre of Vidyasagar University pertaining to granting of Maternity Leave for a period of six months starting from 05.01.2016.


