



After thorough discussion on the letter of the Principal, Vivekananda Mission Mahavidyalaya pertaining to nomination of one University Nominee to the 8th Governing Body of the College in place of Professor Mritunjoy Guchhait of Ramnagar College, it was resolved that the matter be left to the Hon'ble Vice-Chancellor for necessary action.

- 06(e) To consider the letter bearing No. DMP/VU/479/2015-16 dated 08.10.2015 submitted by the Director, M/s. D.M.P. Nirman Private Limited, Kolkata praying for an Ad-Interim Payment of Rs.6.00 Crores against the 1st & final bill for the balance work of Auditorium at Vidyasagar University.

**Resolution:** The Executive Council of Vidyasagar University noted the letter bearing No. DMP/VU/479/2015-16 dated 08.10.2015 submitted by the Director, M/s. D.M.P. Nirman Private Limited, Kolkata stating that the bill for Rs.12.98 crores was submitted to the University after successful completion of the balance work of Auditorium at Vidyasagar University and the said bill was fully checked by the Consultant and the University.



The Executive Council also noted that for the Bengali's biggest festival of Durga Puja, they have to pay their creditors and labourers at least a certain percentage so that they can enjoy this festival. In this connection he has requested to pay an Ad-Interim payment of Rs.6.00 crores against the said bill.

After thorough discussion and careful consideration on the letter of M/s. D.M.P. Nirman Private Limited, Kolkata praying for an Ad-Interim Payment of Rs.6.00 Crores against the 1st & final bill for the balance work of Auditorium at Vidyasagar University, it was resolved that a penalty of Rs.25,000/- (Rupees twenty five thousand) only per day be imposed if M/s. D.M.P. Nirman Private Limited fails to hand over the complete auditorium to the University latest by 15<sup>th</sup> December, 2015. Resolved also that the Registrar be requested to communicate the same to M/s. D.M.P. Nirman Private Limited, Kolkata in this regard.

- 06(f) To note the Comparative Statement submitted by the Teacher-in-Charge, Department of Business Administration of this University pertaining to selection of lowest bidder as Consultant for providing the Career Counselling Programme for the final year, i.e. 3rd & 4th Semester students of Vidyasagar University.

**Resolution:** The Executive Council of Vidyasagar University noted the letter dated 24.08.2015 submitted by the Teacher-in-Charge, Department of Business Administration of this University pertaining to providing the Career Counselling Programme for the final year, i.e. 3<sup>rd</sup> & 4<sup>th</sup> Semester students of Vidyasagar University. The Executive Council also noted the Comparative Statement prepared for selection of the lowest bidder, M/s. Careercoms as Consultant for providing said programme for the final year, i.e. 3rd & 4th Semester students of Vidyasagar University.

After thorough discussion on the letter of the Teacher-in-Charge, Department of Business Administration and careful consideration of the comparative statement prepared for selection of lowest bidder as Consultant for providing the Career Counselling Programme for the final year, i.e. 3rd & 4th Semester students of Vidyasagar University, it was resolved that the comparative statement prepared in this regard be accepted and approved for necessary action.

- 06(g) To consider the letter bearing No. VMAIOT/498/V.U./DOCA/Affiliation Fees dated 09.09.2015 jointly submitted by the General Secretary, Vivekananda Mission Asram and the Incharge, Institute of Ophthalmic Training, Vivekananda Mission Asram praying for Special Rate Scheduling of Affiliation Fees of DOCA Course.

**Resolution:** The Executive Council of Vidyasagar University noted the letter bearing No. VMAIOT/498/V.U./DOCA/Affiliation Fees dated 09.09.2015 jointly submitted by the General Secretary, Vivekananda Mission Asram and the Incharge, Institute of Ophthalmic Training, Vivekananda Mission Asram stating that the Diploma in Ophthalmic Clinical Assistance (DOCA) Course has been conducting by Vivekananda Mission Asram since 2003-2004 academic year under the Vidyasagar University. Vivekananda Mission Asram is a Charitable organization which renders manifold services specially for the poor and downtrodden communities of the society. The Executive Council also noted that the intake capacity of the said course was initially at 10 and from the academic session 2011-2013 it has been increased to 15. The Executive Council noted



further that most of the students come from very poor socio-economic background and it is very much difficult for them even to pay the existing fees @Rs.1,000/- only per year. It will be a great burden for them if the enrolment fees are increased to 10% of the course fees or Rs.1500/- whichever is higher per semester and it comes to Rs.3,000/- per year. In this connection they have requested to frame the affiliation fees at a very minimum special rate of Rs.1,000/- per semester i.e. Rs.2,000/- per year.

After thorough discussion on the letter jointly submitted by the General Secretary, Vivekananda Mission Asram and the Incharge, Institute of Ophthalmic Training, Vivekananda Mission Asram praying for Special Rate Scheduling of Affiliation Fees of DOCA Course, it was resolved that the prayer for Special Rate Scheduling of Affiliation Fees of DOCA course made by the Vivekananda Mission Asram be declined. Resolved also that Rs.3,000/- (Rupees three thousand) only per annum or Rs.1,500/- (Rupees one thousand five hundred) only per semester per student be charged as University Affiliation Fee for the said course. Resolved further that the matter be communicated to the concerned college in this regard.

- 06(h) To consider the letter dated 29.10.2015 submitted by Dr. Sumahan Bandyopadhyay, Assistant Professor, Department of Anthropology pertaining to protect his salary as per the pay of his previous employer.

**Resolution:** The Executive Council of Vidyasagar University noted the letter dated 29.10.2015 submitted by Dr. Sumahan Bandyopadhyay, Assistant Professor, Department of Anthropology stating that he joined this University on 06.05.2015. At the time of joining he submitted his Last Pay Certificate of his previous employer and he applied the post at Vidyasagar University through proper channel. The Executive Council also noted that Dr. Bandyopadhyay applied earlier for his pay protection but till date it has not been done. In this connection he has requested to protect his salary as admissible in this University considering his last pay at his previous employment.

After careful consideration of the letter of Dr. Sumahan Bandyopadhyay, Assistant Professor, Department of Anthropology pertaining to protect his salary as per the pay of his previous employment, it was resolved that the pay of Dr. Bandyopadhyay be protected in this University as per the norms of the University.

- 06(i) To place before the Executive Council of Vidyasagar University, the enquiry report of the one-man enquiry Committee, constituted by the Hon'ble Vice-Chancellor of this University pertaining to disruption of academic activities of the Department of Microbiology of this University.

**Resolution:** Consideration of the item was deferred.

- 06(j) To consider the letter dated 18.11.2015 submitted by the General Secretary, Vidyasagar University Teachers' Association (VUTA) pertaining to formation of a committee for simplification of the present format of application re-employment of the teachers of Vidyasagar University.

**Resolution:** Consideration of the item was deferred.

- 06(k) To consider the letter dated 18.11.2015 submitted by Dr. Ganesh Chandra Rana, Deputy Registrar of Vidyasagar University pertaining to continuation of 64 days leave from his accumulated earned leave in his previous employment at the Directorate of Fisheries, Government of West Bengal for getting the leave encashment benefit of 300 days at Vidyasagar University.

**Resolution:** Consideration of the item was deferred.

06(l) To note the Judgement passed by the Hon'ble Justice Tapabrata Chakraborty on 19.11.2015 bearing W.P. No. 26658(W) of 2015 regarding granting of without pay study leave to Subhabrata Pal, Junior Peon of Vidyasagar University.

Resolution : The Executive Council of Vidyasagar University noted the Judgement passed by the Hon'ble Justice Tapabrata Chakraborty on 19.11.2015 bearing W.P. No. 26658(W) of 2015 filed by Shri Subhabrata Pal, Junior Peon of Vidyasagar University regarding granting of without pay study leave stating

" the resolution dated 5th August, 2015 passed by the Executive Council of Vidyasagar University does not reveal that the competent authority had considered the relevant provisions of said Ordinance prior to rejection of the petitioner's claim for study leave. The said resolution does not reflect any independent application of mind and is not supported with appropriate reasons and thus the same being a cryptic one, is not sustainable in law. Accordingly, the impugned resolution of the Executive Council of the said University dated 5th August, 2015 pertaining to denial of study leave to the petitioner at Clause 06(s) is not sustainable in law and the same is accordingly set aside. The Executive Council of the said University, is directed to consider the petitioner's prayer for study leave without pay, afresh, in accordance with law and to communicate the said decision to the petitioner within a period of three weeks from the date of communication of this order."

After thorough discussion on the Judgement passed by the Hon'ble Justice Tapabrata Chakraborty of High Court regarding reconsideration of the prayer of Shri Subhabrata Pal, Junior Peon of Vidyasagar University for granting of without pay study leave for a period of two years, the E.C. noted the following facts :-

- (1) That Shri Pal is posted in the office of the Deputy Registrar. Shri Pal is the only Junior Peon in that office.
- (2) The office where Shri Pal is working, is running with acute shortage of staff and with a huge work load .
- (3) Shri Pal is associated with the issue of Migration Certificate to the students who are willing to migrate from this University to another and they need the Certificates urgently so that they can submit the same without delay in their present institutions.
- (4) Shri Pal is also associated with the process of Registration of the students. This process is in need of huge manpower with sincerity. If Shri Pal remains such absent from this office the entire process will be hampered and huge number of students will suffer.
- (5) Furthermore, the requisite qualification for the post of Junior Peon was Class VIII Passed and Post-Graduate Qualification is not a required qualification for promotional benefit. However, Shri Pal has already obtained a Master Degree from a recognized University. He will not suffer any promotional benefit if he does not obtain any Master Degree as per norms of the University.

It is also resolved that the prayer of Shri Pal regarding granting of without pay study leave be declined accordingly. Shri Pal may be informed about this decision.



**Resolution:** *The Executive Council of Vidyasagar University noted the letter bearing No. 962-Edn(U)/1U-41/11(Pt) dated 05.10.2015 received from the Joint Secretary to the Government of West Bengal, Higher Education Department, University Branch stating that in partial modification of the Higher Education Department's Order and in cancellation of the clarifications made by the Higher Education Department earlier in this regard, the Governor is pleased to decide that for the teachers, librarians, physical instructors and equivalent academic staff whose career advancement and re-designation falls due on a date during the period from 30/06/2010 to 31/10/2012 (both days inclusive), the Career Advancement Scheme and re-designation will be effective from the date it is due provided they have fulfilled at the relevant criteria as per stipulations of the UGC Regulations, 2010. It is also stated that those who failed to attend Refresher's Course and/or Orientation Course within the due date of promotion but have attended later though within 31/12/2013, will also be eligible to get promotion on due date in terms of the UGC's letter No. 1-2/2009(EC/PS) Pt VIII dated 07/12/2012.*

*After thorough discussion on the letter of the Higher Education Department, Government of West Bengal, University Branch pertaining to clarification regarding applicability of terms & conditions towards re-designation and Career Advancement Scheme for the teachers and equivalent academic staff of the State-aided Universities in West Bengal, it was resolved that the said guidelines of the Higher Education Department be implemented in this University in respect of the teachers and equivalent academic staff whose placement/promotion or re-designation falls due on a date during the period from 30.06.2010 to 31.10.2012. Resolved further that the said letter be sent to the Director, Internal Quality Assurance Cell (IQAC) & the Establishment Section respectively for further process in this regard.*

**Resolution :** The Executive Council of Vidyasagar University noted the letter bearing No. BCI:D:2101:2015 (Item No. 12/2015-A/LE: Mtg.27.05.2015) dated 31.10.2015 received from the Joint Secretary, Bar Council of India, New Delhi stating that the Legal Education Committee in its meeting dated 27.05.2015 after careful consideration of the letter No. NMU/Law BOS/214/2014 dated 04.08.2014 submitted by Dr. D.G. Hundiwale, Director, Board of College and Universities Development, North Maharashtra University, Jalgaon, Maharashtra regarding implementation of Legal Education Rules 2008 decided that the Bar Council of India would help only implementing its statutory rules framed under the Parliament Act. These rules have to be obeyed, followed by every functionaries who comes within its jurisdiction. If the State Govt. is not interested to follow these rules or University/college is not able to appoint requisite faculties for teaching the two courses namely three year and various five year law courses, they may not undertake those courses. These rules were framed after consulting all the Universities in India in the vider interest of the legal education. For the aforesaid reasons the aforesaid request of the Director could not be acceded to. The Executive Council also noted that the State Governments, Universities and colleges to proceed and follow the rules of Legal Education – 2008 without any exception if it wants to run the courses.

After thorough discussion on the letter of the Bar Council of India, New Delhi pertaining to following/implementation of the Legal Education Rules -2008 for conducting the 3-year and 5-year LL.B courses, it was resolved that the said rules be followed/implemented in this University for conducting the courses as stated herein above. Resolved also that the Inspector of Colleges be requested to convey the same to the concerned colleges in this regard.




