Resolution: The Executive Council of Vidyasagar University noted the letter dated 05.01.2015 submitted by Ms. Snigdha Naskar, Assistant Professor, Department of Library and Information Science of this University stating that in continuation of her earlier letter she informed that the Ph.D. course work programme was being started since 1st December, 2014 on every Tuesday and Thursday till 28th May, 2015 except University holidays. In this connection she requested to permit her in this regard.

He was not only a renowned educationist but also a dedicated affectionate teacher to the students. The Executive Council also noted that to honour his memory she intends to donate an amount of Rs.50,000/- (Rupees fifty thousand) only to the University for awarding scholarship to the topper of B.A. (Hons.) in Bengali of Vidyasagar University every year.

After thorough discussion on the letter of Shri Durga Senapati of Amlagora, Garhbeta pertaining to donation of an amount of Rs.50,000/- (Rupees fifty thousand) only in memory of Late Professor Kishore Mohan Senapati for awarding scholarship to the topper of B.A. (Hons.) in Bengali of Vidyasagar University it was resolved that the proposal submitted by Shri Senapati be accepted. In connection with the above his client serve this notice to the University authority for cancellation of recognition of the said proposed college as the same is to be established on another's land illegally.*

**Resolution:** Consideration of the item was dropped as Dr. Shit has already resigned from the post of Technical Assistant of Vidyasagar University.

08(b) To consider the letter dated 24.02.2015 submitted by Dr. Subhajit Sen Gupta, Associate Professor, Department of English and Culture Studies, University of Burdwan pertaining to extension of leave with lien for a further period of six months with effect from 11.03.2015.

**Resolution:** The Executive Council of Vidyasagar University noted that Dr. Subhajit Sen Gupta, Assistant Professor, Department of English of this University was granted leave with lien for a period of six months with effect from 11.09.2014 for joining the post of Associate Professor in the Department of English at the University of Burdwan and accordingly he joined the said post on that date. 
