

The Registrar (Acting) and Shri Banerwar Singh were publicly humiliated and insulted on that day. Dr Indrani Datta Chaudhuri also published an article " Vidyasagar Biswabidyalayer hal bombagarher matoi, achen aubbhutire rajamashai" in the Dainik Statesman on 28.05.2014 tarnishing the image of the university.

**Resolution:** The Executive Council of Vidyasagar University noted the following :

- (a) the detailed incident which took place on 11.06.2014 in the office of the Hon'ble Vice-Chancellor and the Registrar of this University pertaining to humiliation and insult the Registrar (Actg.) and Shri Banerwar Singh, one staff (who belongs to Scheduled Tribe) of the office of the Vice-Chancellor by garlanding both of them and also offering a flower bouquet to the Registrar (Actg.) in presence of photographers, media personnel and others under the leadership of Dr. Indrani Datta (Chaudhuri), Assistant Professor, Department of English of Vidyasagar University.
- (b) watched the CCTV Footage and the news telecasted by ETV in the evening of 11.06.2014 regarding the said incident on 11.06.2014 produced before the house through LCD projector.
- (c) on the basis of such incident that took place under the leadership of Dr. Datta (Chaudhuri), a show cause notice dated 16.06.2014 was issued to her as per the direction of the Hon'ble Vice-Chancellor.
- (d) the content of such show cause notice.
- (e) the e-mails, letters received from Dr. Datta (Chaudhuri) raising false allegations and her deliberate intention to blackmail and exert unlawful influence/pressure on the Hon'ble Vice-Chancellor in response to the show cause notice dated 16.06.2014 issued by the Vidyasagar University to her, by threatening to commit suicide and all letters/F.I.R. to the Superintendent of Police, Paschim Medinipur and local police station, Higher Education Department sent by the University authority in this regard.
- (f) the reply of the show cause notice and the responses received from Dr. Indrani Datta (Chaudhuri) pertaining to the incident on 11.06.2014.
- (g) Dr. Indrani Datta (Chaudhuri) forwarded the copies of her reply & responses to the show cause to several persons and brought them to the public domain and thereby further tarnished the image of the University in public and insulted the authorities of the University.
- (h) all the responses to the show cause notice reflect insubordination and the intention to challenge the Vidyasagar University Authorities.
- (i) an article " Vidyasagar Biswabidyalayer hal bombagarher matoi, achen aurbhature rajamashai" published by Dr. Datta (Chaudhuri) in the Dainik Statesman on 28.05.2014 tarnishing the image of the university.

After threadbare discussion on the incident that took place on 11.06.2014 in the office of the Hon'ble Vice-Chancellor and office of the Registrar pertaining to humiliating and insulting the Registrar (Actg.) and Shri Banerwar Singh, one staff (who belongs to Scheduled Tribe) of the office of the Vice-Chancellor by garlanding both of them and also offering a flower bouquet to the Registrar (Actg.) in the presence of photographers, media personnel and others under the leadership of Dr. Indrani Datta (Chaudhuri), Assistant Professor, Department of English of Vidyasagar University and also the CCTV footage and after considering the past incidents where also Dr. Indrani Datta (Chaudhuri) has been found to have been lacking in the discharge of her duties as a teacher, her publication in a newspaper lowering down the prestige of the University in the eyes of the public at large, all e-mails, letters and careful consideration of the responses to the show cause notice by Dr. Indrani Datta (Chaudhuri) it was resolved unanimously as follows :

- (a) the reply of the show cause notice dated 16.06.2014 submitted by Dr. Datta (Chaudhuri) was not satisfactory.
- (b) necessary action against Dr. Datta (Chaudhuri) be initiated and she be placed under suspension with effect from the afternoon of 21.07.2014 in contemplation of disciplinary proceedings as per the University rules.

- (c) a chargesheet be issued to Dr. Datta (Chaudhuri) in this regard and other complaints. If the reply to the chargesheet to be received from Dr. Datta (Chaudhuri) is not found to be satisfactory, an enquiry be conducted on the basis of the charge sheet issued to her and an Enquiry Officer be appointed and Dr. Arun Kumar Maiti, Development Officer of Vidyasagar University be appointed as Presenting Officer for secretarial purpose and present the case of the University before the enquiry officer & others (as to be required) to proceed further in this regard.
- (d) this item of the EC be taken as confirmed.

- 05.(h) To note that Shri Krishnakali Samanta, Junior Peon, DDE was issued the show cause notice pertaining to the incidence took place on 11.06.2014 in the office of the Vice-Chancellor and office of the Registrar of this University and also to note the reply on the show cause received from him in this regard.

**Resolution:** The Executive Council of Vidyasagar University noted that Shri Krishnakali Samanta, Junior Peon, DDE of the University was also issued the show cause notice pertaining to his activities in the incidence took place on 11.06.2014 in the office of the Vice-Chancellor and office of the Registrar of this University. The Executive Council also noted the reply on the show cause submitted by Shri Samanta in this regard.

After thorough discussion on the show cause notice pertaining to the activities of Shri Krishnakali Samanta in the incidence took place on 11.06.2014 and careful consideration of the reply on the show cause submitted by Shri Samanta it was resolved that necessary steps in this regard be taken by the University against Shri Samanta as per the University rules.

- 05.(i) To note the letter dated 26.06.2014 submitted by Dr. Indrani Datta (Chaudhuri), Assistant Professor, Department of English to the Hon'ble Vice-Chancellor of this University pertaining to submission of complaint to the Inspector-in-Charge, Kotwali Police Station, Midnapore and also the Superintendent of Police, Paschim Medinipur mentioning mental torture, discrimination and harassment.

**Resolution:** The Executive Council of Vidyasagar University noted the letter dated 26.06.2014 submitted by Dr. Indrani Datta (Chaudhuri), Assistant Professor, Department of English to the Hon'ble Vice-Chancellor stating that due to the acute mental trauma that she is suffering from as a result of mental torture, discriminatory treatment and harassment inflicted upon her by some senior colleagues and highest authority of the University. She has been compelled to submit the letters to the Superintendent of Police, Paschim Medinipur and Inspector-in-Charge, Kotwali Police Station, Midnapore in order to protect her dignity and honour at her workplace and safe-guard herself, her academic career and service.

In the context of highly disturbing and undesirable communication from Dr. Datta (Chaudhuri) subsequent to the show cause notice dated 16.06.2014, the action taken by Vidyasagar University authority (Lodging GD & FIR by Vidyasagar University and communicating to Higher Education Department) were also noted.

After thorough discussion on the letter dated 26.06.2014 submitted by Dr. Indrani Datta (Chaudhuri), Assistant Professor, Department of English to the Hon'ble Vice-Chancellor of this University pertaining to submission of complaint to the Inspector-in-Charge, Kotwali Police Station, Midnapore and also the Superintendent of Police, Paschim Medinipur, it was resolved that necessary steps as per rules be taken by the University in this regard.

- 05.(j) To note the letter dated 18.07.2014 submitted by Dr. Jayanta Kishore Nandi, Registrar (Actg.) of this University pertaining to complaint about the incident took place in Registrar's office on 17.07.2014 in between 3-00 - 4-00 P.M.

They did not permit him to speak anything and together started shouting. All these miscreants were very furious and were trying to beat him. The situation was too worst and he never experienced such incidence in his life earlier. He is very much scared and could not sleep the entire night on that day. All employees of this University are very much scared and worried about our safety and security. In this connection he has requested the University authority to take disciplinary actions against all such miscreants, immediately and provide us a safe and secured life in the University campus and good working environment.*

*After thorough discussion on the letter submitted by Dr. Jayanta Kishore Nandi, Registrar (Actg.) of this University pertaining to complaint about the incident took place in Registrar's office on 17.07.2014 in between 3-00 - 4-00 P.M. it was resolved that an F.I.R. be lodged in the local police station stating the detailed facts of incidence that took place on 17.07.2014 along with providing the CCTV footage.*

- 05.(k) To note the letter dated 07.06.2014 written by Mr. Batuk Chakrabarti, Kolkata to the Principal Secretary, Higher Education Department, Govt. of West Bengal pertaining to cases of "Plagiarism by Full-time faculty of Burdwan University and Vidyasagar University that got suppressed Calcutta University and Visva Bharati did not take any action".


