The DST also advised us that if Vidyasagar University give assurance to DST about Co-PI by permitting him independent research-oriented facilities then DST will send the entire fund to Vidyasagar University. In this connection he has requested to permit Co-PI for independent research-oriented

UGC in the meantime is working on preparing suitable guidelines/regulations for ensuring standards of teaching and learning in affiliated colleges offering courses/programs of professional and technical nature. In this connection he has requested the University to ensure that no further affiliations are granted to any more affiliated colleges offering courses/programs of professional and technical nature till UGC reaches out to the University again.

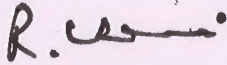
