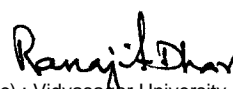
To consider the recommendation of the Standing Committee for appointment to the post of Deputy Inspector of Colleges of Vidyasagar University.

They have adequate infrastructural facilities, teaching faculties and other aspects for conducting the said course. Besides the road connectivity in the area is developed to reach the college. In connection with the above he has requested to accord necessary permission to the college for introduction of the said course from this session.*

### Agenda No. – 27

To discuss the matter regarding selection of new Vendor for operation of the Canteen of Vidyasagar University.

### Resolution

The Executive Council of Vidyasagar University noted that M/s. Gharana Caterer was entrusted with operation of the University Canteen for a period of two years as per the decision of the Executive Council. The Executive Council also noted that now they are unwilling to run the canteen. In this connection new Vendor for operation of the University canteen smoothly will have to be selected through tender process as per the University rule.

After thorough discussion on the matter relating to selection of new Vendor for operation of the Canteen of Vidyasagar University it was resolved that necessary steps for inviting the tender in this connection be taken as per the University norms.

### Agenda No. – 28

To discuss the matter relating to slow progress of the upcoming and ongoing different construction and repairing & renovation works etc. by the office of the University Engineer.

### Resolution

The Executive Council of Vidyasagar University noted that in view of the upcoming constructional works and ongoing repairing works in the Vidyasagar University campus and also in view of the slow progress of such works it implies that the UE's office should be strengthened. Various ways should be explored to give full assistance and co-operation to University Engineer to enable him to speed up these works.

After threadbare discussion on the matter regarding slow progress of the upcoming and ongoing different construction and repairing & renovation works etc. by the office of the University Engineer it was resolved that a 4-Member Committee be constituted to give their suggestions to strengthen the functioning of the Office of the University Engineer for quick progress of different construction and repairing and renovation works of Vidyasagar University. Resolved also that the Hon'ble Vice-Chancellor be authorized to nominate the members of the said Committee.

### Agenda No. – 29

To discuss about the dearth of human resources in the University administrative departments and particularly in the Registrar Department of Vidyasagar University.

#### Resolution

*The Executive Council of Vidyasagar University noted that there is a serious dearth of human resource in several administrative Depts. Some posts are lying vacant till date. It is also necessary to take up the matter with the HE Deptt. This shortage of staff is leading to inefficiency and frequent failures to meet deadlines. The Executive Council also noted that it is also necessary to explore ways of solving the problems in the Registrar's Deptt, in the greater interest of the students and teachers. After threadbare discussion on the matter about the dearth of human resources in the University administrative departments and particularly in the Registrar Department of Vidyasagar University it was resolved that a 3-Member Committee be constituted to give their suggestions and advise the Vice-Chancellor to strengthen the functioning of the Office of the Registrar, Vidyasagar University. Resolved also that the Hon'ble Vice-Chancellor be authorized to nominate the members of the said Committee. Resolved further that an Officer on Special Duty be appointed purely on contract basis.
