Resolution

*The Executive Council of Vidyasagar University noted the letter dated 07.06.2012 submitted by the Head, Education and Training, CMC Limited, Eastern Region stating that based on the discussion had with the University authority they have submitted a revised proposal to conduct the MCA, MBA, M.Sc.(Computer Science), M.Sc. (Computer Hardware & Networking) courses in collaboration with Vidyasagar University in distance education mode under the University-Industry Partnership program. The Executive Council also noted the revised proposal, eligibility criteria and course curriculum in this connection.*

### Resolution

The Executive Council of Vidyasagar University noted the action of the Hon'ble Vice-Chancellor in approving the Inspection Report submitted by the duly constituted Inspection Team in connection with extending affiliation to AMIK Institute of Engineering and Management, Durgapur for conducting B.S.W. (Hons.) Course from the academic session 2012-2013. The Executive Council also noted that accordingly AMIK, Durgapur has been extended affiliation for the said subject to the fulfillment of the following terms & conditions :

- (i) The intake capacity for such course will be 30 for the current year.
  - (ii) One time Course Affiliation fee for Rs.1,00,000.00 (Rupees one lac ) only is to be paid to the University at the time of granting affiliation. The amount is to be paid in two instalments.
  - (iii) The B.S.W. (Hons.) Course should be open to students from all backgrounds viz. Arts, Commerce, Science etc. The teaching institution may decide on the appropriate entrance criteria. The information concerning the admissions should be duly posted in the institutional web-site.
  - (iv) For each paper of 100 marks in B.S.W. (Hons.) Course, 20 marks will be allotted for internal assessment. For each 80 mark theoretical paper in examination, the time duration will be of 03 (three) hours.
  - (v) The part-time teachers should also be allowed to supervise project/field-work of the students, preferably in consultation with teacher/s of 'Social Work' background (where the concerned part-time teacher is of 'non-Social Work' background).
  - (vi) The academic and examination related issues will be under the overall supervision of Vidyasagar University.
  - (vii) There should be an academic exchange programme between the academic staffs of affiliating and the affiliated bodies.
  - (viii) 10% share of students' fees (minimum Rs.500/=) per student per semester is to be paid to the University as Affiliation Fee.
  - (ix) Library room to be furnished and equipped.
  - (x) Required number of class rooms to be furnished.
  - (xi) The University reserves the right to impose such other conditions as it may deem fit as and when the occasions arise.  
(xii) Required numbers of duly qualified teachers are to be appointed by the Institute before commencement of the classes. AMIK must increase its full-time faculty strength by at least 02 (two) for the first year class, and by at least 01 (one) at second year and third year each. Such full-time faculty members may be regular/contractual/guest/visiting etc.
  - (xiii) AMIK must have a Course Co-ordinator/Head of the Department for the Social Work Courses.
  - (xiv) The selection of teachers for appointment on contractual and part-time basis to be made by a Committee constituted for this purpose and a subject expert nominated by the University in each subject to be included in the Selection Committee.
  - (xv) The Institute must abide by the Vidyasagar University Act, Statutes, Ordinances, Regulations etc.
  - (xvi) Books worth Rs.1,00,000.00 (Rupees one lakh only) to be purchased as per syllabus.
- Resolved that the action of the Hon'ble Vice-Chancellor be approved.

### Agenda No. – 05

To consider the letter dated 04.07.2012 submitted by Dr. Sudip Datta Banik, Assistant Professor, Department of Anthropology in connection with re-consideration of extension of full-pay earned leave during the period from 01.05.2012 to 30.06.2012 for post doctoral research in Mexico.

### Resolution

The Executive Council of Vidyasagar University noted the letter dated 04.07.2012 submitted by Dr. Sudip Datta Banik, Assistant Professor, Department of Anthropology stating that he was on study leave between 01.11.2009 and 30.04.2012 (two and half years) for post doctoral research in Mexico. Further he applied for extension of his leave as Earned Leave for two months (May-June 2012) for academic and personal reasons. But the University authority sanctioned his extension of leave without pay. In this connection he has requested to re-consider his application dated

14.03.2012 and approve his extension of full pay earned leave for those two months from 01.05.2012 to 30.06.2012 for the purpose as stated herein above.

After careful consideration of the letter of Dr. Sudip Datta Banik in connection with re-consideration of extension of full-pay earned leave it was resolved that Earned leave be granted to Dr. Banik as per rule.

#### Agenda No. – 06

To place before the Executive Council the letter No. 03 dated 06.07.2012 submitted jointly by the President and Secretary of College & University Teachers' Association of Bengal (PTT) (CUTAB), Paschim Medinipur District Committee in connection with withdrawing support from the examination related matters and continuous class boycott with effect from 1st August, 2012 by the Part-time teachers of Govt., Govt.-Aided colleges and Universities of West Bengal.

#### Resolution

The Executive Council of Vidyasagar University noted the letter No. 03 dated 06.07.2012 submitted jointly by the President and Secretary of College & University Teachers' Association of Bengal (CUTAB), Paschim Medinipur District Committee stating that State Committee of their association after repeated meetings with the District Committee leaders, college unit leaders and members of the association has decided to stop all the voluntary services provided by them, such as examination duties, invigilation duties, checking equal number of University answer scripts etc. which are not included in their appointment conditions if Higher Education Department of the State do not agree with their legitimate demands, assure them of specific solutions for their service related problems and meet their delegation team within 10.07.2012. They have already sent the decision of the association to the Hon'ble Chief Minister of West Bengal and Minister-in-Charge, Department of Higher Education, Govt. of West Bengal. They have also stated that CUTAB the association will no longer be able to restrain the part time teachers of this State to go for continuous class boycott with effect from 01.08.2012 in all govt., govt.-aided colleges and Universities of West Bengal.

After thorough discussion on the letter of CUTAB in connection with withdrawing support from the examination related matters and continuous class boycott with effect from 1st August, 2012 by the Part-time teachers of Govt., Govt.-Aided colleges and Universities of West Bengal it was resolved that the letter be forwarded to the Government of West Bengal for consideration. Resolved also that the Registrar be requested to take necessary steps in this connection.

#### Agenda No. – 07

To place before the Executive Council the letter dated 19.06.2012 submitted by Prof. Raghunath Sen regarding nomination of Dr. A. K. Bhoumik as University Nominee of Bajkul Milani Mahavidyalaya.

#### Resolution

The Executive Council of Vidyasagar University noted the letter dated 19.06.2012 submitted by Prof. Raghunath Sen, former Member of the Executive Council and former member of Board of Studies at Vidyasagar University stating that Dr. A. K. Bhoumik has been nominated as University nominee of Bajkul Milani Mahavidyalaya who was Principal of the said college till his retirement. During his service in the said college as Principal, number of issues regarding financial irregularities in the college, rebellious act to comply with the orders of University are there against him. Further the D.P.I. ordered a special enquiry and implicated him in its report for financial irregularities in the college in number of circumstances. He believes that a person like A.K. Bhowmik, so implicated by D.P.I. and University may spoil the academic environment of the college and for greater good he should be called back by the University. The Executive Council also noted the documents submitted by Prof. Sen in this connection.

After thorough discussion on the letter of Prof. Raghunath Sen regarding nomination of Dr. A.K. Bhowmik as University Nominee of Bajkul Milani Mahavidyalaya it was resolved that Dr. A. K. Bhowmik be continued as a member of the Governing Body of Bajkul Milani Mahavidyalaya as University Nominee nominated by EC as there is no conflict between the allegation and nomination of the Governing Body of the College.

In this connection he has requested to grant him 4 months study leave from 15.08.2012 to 14.12.2012 for his Ph.D. programme.*

*After careful consideration of the letter of Sri Tarak Nath Sahu in connection with granting of Study Leave for pursuing Ph.D. programme it was resolved that study leave be granted to Sri Sahu as per the University rule for this purpose.*

Resolution

*The Executive Council of Vidyasagar University noted the letter dated 01.02.2012 submitted by the Head, Department of Applied Mathematics with Oceanology and Computer Programming stating that at present the full marks of each semester are 300 out of which only 25 marks are allocated for*

the practical paper. As per University rules, if an examinee gets less than 50% marks in a practical paper, he/she is declared as 'fail' for that semester, i.e. he/she cannot be promoted to the next semester though he/she secures good marks in the other paper in that semester. The Executive Council also noted that the Department of Applied Mathematics in its departmental committee meeting dated 01.02.2012 decided that if a candidate obtained less than 50% marks in a practical paper in a semester examination, he/she cannot be declared as a fail in the whole semester and that practical paper can be treated as supplementary". In this connection he has requested to change the rules for practical papers in the semester examinations in Applied Mathematics.

After thorough discussion on the letter of the Head, Department of Applied Mathematics with Oceanology and Computer Programming and careful consideration of the decision taken by the Departmental Committee in this connection it was resolved that the matter regarding changing the rules for practical papers in the semester examinations in Applied Mathematics be agreed on principle. Resolved also that the matter be referred to the Faculty Councils for Postgraduate Studies for necessary suggestion in this connection.
