Sub: - IGST Exemption/ Concession under GST on purchase of Equipments covered under DSIR certification

It is notified for information of all concerned that as per discussion in the GST Council meeting held on 18th /19th May, 2017, the Central Board of Excise and Customs, Department of Revenue, Ministry of Finance, Government of India has confirmed that the University comes under IGST Exemption/ Concession under GST on purchase of Equipments covered under DSIR certification. The extract of the resolution of the GST Council meeting is given below:


