**NOTIFICATION**

- (5) the Head, Department of Commerce of Vidyasagar University ;
- (6) Professor Anandamohan Pal, Department of Business Management, University of Calcutta;
- (7) the Inspector of Colleges of Vidyasagar University - Convener.

All members of the Committee so re-constituted are being informed accordingly. The Convener of the Committee is requested to do the needful in this regard in consultation with the other members.
