In case of any discrepancy in the said result, the students are advised to inform the office of the Controller of Examinations within 7 days from the date of publication of the result.

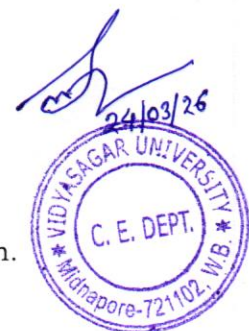
