CONCEPT NOTE

Standing in the 21st century, globalization has emerged as one of the defining processes for transforming societies and cultures, economies, and political systems across the globe. Characterised by the increasing interconnectedness of nations, it has accelerated economic growth and facilitated the exchange of knowledge and practices. However, alongside its benefits, it has also generated significant ecological challenges that threaten environmental sustainability and social well-being. The extraction of natural resources has caused deforestation, reduced biodiversity, pollution, the decline of freshwater resources, and climate change. The emission of greenhouse gases and the activities of transnational corporations have further caused massive environmental degradation.

It is important to view such ecological crises from a sociological perspective, as these environmental problems are socially constructed, with ecological degradation said to be extensively related to the modes of production, consumption, technology, and governance. The recognition of ecological problems has brought out the idea of a 'sustainable society'- the one which tries to maintain a balance between economic development, social equality, and environmental protection by keeping the requirements of the present generation satisfied without undermining the future generations' requirements. Sociologically, sustainability encompasses community participation, equal access to resources, and resilience to ecological and economic shocks.

Globalization is changing the ways of environmental governance. Various international agreements such as the Paris Agreement, SDGs, and climate talks are proof of the fact that environmental problems cannot be addressed at the national level alone but require both global and local cooperation to solve. The global agenda for 2030 of UN is based on the principle of universality: 'Leave No One Behind'. CSOs, indigenous peoples, environmental organizations, and youth-driven climate activism have become important players in the process of achieving sustainability and environmental justice. Also, the use of digital technologies in communication has facilitated transnational environmental advocacy.

In developing nations like India, globalization and ecological change together have posed both new opportunities and threats. Matters like climate-induced migration, displacement, industrial pollution, and the impact of climate change on vulnerable groups are some of the areas where sustainable development policies need to be made.

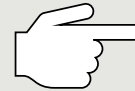
