Following are the qualifying ceriteria:-

- (1) Intending Quotation should produce credentials of a **similar nature of completed work** and at least minimum value of single work is **Rs.47,000.00 during 5 (Five) years** prior to the date of issue of this Quotation notice.
- (2) The prospective bidders must have valid upto date clearance of **Trade License (Latest), IT return (Last 3 years), PAN Card, GST, Voter ID card** for self identification.
- (3) An undertaking should be given stating thereby that the firm has not been debarred or penalized for any reasons out of work by any Government Deptt.
- (4) Subletting of contract is strictly prohibited.
- (5) **TAXES:** The rates quoted in the Price Schedule shall be inclusive of all taxes, G.S.T. , general tax turn-over tax, octroi, duty etc. as applicable on materials required to be supplied by contractor in his work, except for items supplied by the university. Further, if by amendment or New Tax imposition of any statutory law by State or by Central Government or any other competent authority to be paid by University as per Govt. G.O.
- (6) No mobilisation advance and secured advance will be allowed.
- (7) All materials required for the proposed work shall be of specified grade/specifications and approved brand inconformity with relevant code of practice (latest revision), schedule of works and PWD Schedule manufactured accordingly and shall be procured and supplied by the agency at their own cost including all taxes. If required by the Engineer-in-Charge, further testing from any Government approved Testing Laboratory shall have to be conducted by the agency at their own cost.
- (8) Any or all disputes out of the operation of this Agreement shall be initially resolved by mutual discussions between the signatories within a period of 30 days if failing matter shall be referred to the Hon'ble Vice-Chancellor for decision and his decision should be final and bindings on the parts.
- (9) Legal Clause
In the case of any legal dispute, other than there mentioned in clause the matter will be resolved in a court of law under the jurisdiction of Midnapore Court only.
- (10) Time Period of Completion is **07(Seven) days** after the issue of Work Order.
