The Executive Council in its aforesaid meeting has also decided that the Viva-voce of Ph.D. programme may be conducted through video conference.

(1) Honorarium for Adjudicators and Viva-voce for the evaluation of Ph.D. thesis :

(a) Adjudication Honorarium :	
(i) For Indian Expert @ Rs.2,500/-	: Rs. 2,500.00
(ii) For Foreign Expert @ US \$ 75	: Rs. US \$ 75
(b) Honorarium for Viva-voce Expert @ Rs.1,000/- per candidate.	: Rs. 1,000.00

(2) Fees for Ph.D. Programme :

(a) Registration Fees	: Rs. 6,100.00
(b) Course Work Fees	: Rs. 5,000.00
(c) Submission of thesis fees	: Rs. 10,000.00

(3) Extension Fees (if necessary) :

(i) Before Pre-submission Seminar @Rs.4,000/- in each.	: Rs. 4,000.00
(ii) After Pre-submission Seminar @Rs.3,000/- in each.	: Rs. 3,000.00

All concerned related with the Ph.D. Programme are being informed accordingly. The fees as revised by the Executive Council will come into force with immediate effect.
