### NOTIFICATION

It has been directed to notify that the Working Committee, re-constituted by the Eighth Executive Council of Vidyasagar University, in its meeting held on 16.06.2017 after thorough discussion on the scheme launched by the Higher Education Department, Science & Technology and Biotechnology, Government of West Bengal bearing Order No. 52-Edn(B)/5B-15/2017 dated 07.06.2017 for providing financial assistance to full-time non-NET research scholars pursuing M.Phil. or Ph.D. in the State-funded higher education institutions in West Bengal, has approved the said scheme in this University. The amount of fellowship to full-time M.Phil scholars who have not qualified for the NET Research Fellowship is rupees five thousand(Rs.5,000/-) per month (not exceeding a period of two(02) years and rupees eight thousand (Rs.8,000/-) only per month (not exceeding a period of four years) for full-time Ph.D. scholars. The scholars who have already in receipt of financial assistance from any other source including central or the State Governments or their agencies/bodies shall not be eligible for this fellowship. The scholars who have involved in a criminal case or in an offence related to moral turpitude or has been punished under disciplinary/penal proceedings shall also not eligible for this financial assistance.

In connection with the above, the non-NET research scholars who have engaged in this University for pursuing M.Phil./Ph.D. degree in various disciplines and also fulfilled the above stated criteria stipulated by the Higher Education Department, are requested to submit the duly filled-in application format along with the declaration and undertaking attached herewith to the undersigned within 20<sup>th</sup> July, 2017 for onward transmission to the Higher Education Department for awarding such fellowship. The claim of fellowship will be disbursed on receipt of the fund/grant from the Higher Education Department, Science & Technology and Biotechnology, Government of West Bengal in this regard.
