NOTIFICATION

In continuation to the Notification bearing Memo No. VU/R/WC-07/C0311/2017 dated 11.07.2017 issued by this office earlier pertaining to the scheme launched by the Higher Education Department, Science & Technology and Biotechnology, Government of West Bengal bearing Order No. 52-Edn(B)/5B-15/2017 dated 07.06.2017 for providing financial assistance to full-time non-NET research scholars pursuing M.Phil. or Ph.D. in the State-funded higher education institutions in West Bengal and subsequently another Order bearing No. 65-Edn(B)/5B-15/2017 dated 11.07.2017 issued by the Department of Higher Education, Science & Technology and Biotechnology, Budget Branch in this regard, it has been directed by the Hon'ble Vice-Chancellor of this University to notify again that the said benefit of fellowship will also be extended to those research scholars who have cleared NET-LS and are conducting full time research as M.Phil or Ph.D. scholars and still have not got employment as teachers in higher education institutions, and are not in receipt of any financial assistance from any other source.

It has also been directed to notify that pursuant to the order bearing No. 65-Edn(B)/5B-15/2017 dated 11.07.2017 issued by the Higher Education Department, the financial assistance will be admissible to those non-NET candidates and NET-LS candidates registered as full time M.Phil. or Ph.D. research scholars as on 01.04.2017 or on a date thereafter, with effect from 01.04.2017 and (subject to the overall time limit of two years for M.Phil. and four years for Ph.D.) up to till the day of submission of the Dissertation and no further.

In connection with the above, non-NET candidates and NET-LS candidates registered as full time M.Phil. or Ph.D. research scholars as on 01.04.2017 or on a date thereafter, with effect from 01.04.2017 in Vidyasagar University are requested to submit the duly filled-in application format prescribed by the Higher Education Department along with the declaration and undertaking attached herewith to the undersigned within 20<sup>th</sup> July, 2017 for onward transmission to the Higher Education Department for awarding such fellowship by the said department.


