**NOTIFICATION**

It is hereby notified for general information that as decided by the Board of Research Studies (BRS) of Vidyasagar University in its Sixth (6th) meeting held on 27.09.2022 based on the proposals received from different Institution(s)/existing Research Centre(s) for establishment of new Research Centre(s)/renewal or extension of the existing Research Centre(s) under Vidyasagar University, the Institution(s) concerned will have to appear before a Review Committee constituted for this purpose, alongwith the duly filled-in format prescribed by the University and to be supplied to the concerned Institutions in due course of time, for presentation of such a proposal. As decided by the BRS also, the Institution concerned will have to deposit an amount of Rs.20,000/- (Rupees Twenty thousand) only per proposal to the University being the processing fee of such establishment/renewal or extension. Thereafter, based on the final decision of the Review Committee, further process of such a proposal will be taken up. The presentation before the Review Committee may be scheduled in the month of January, 2023. Such practice as decided by BRS regarding establishment of new Research centre/extension or renewal of Research Centre will be followed in this University henceforth.

The Principal(s)/Teachers-in-Charge of the colleges affiliated to Vidyasagar University who are interested to establish a new Research Centre at their college alongwith the colleges those who have already established the Research Centre at their colleges are being informed accordingly. They are also requested to follow the instruction as decided by the BRS and stated herein above for this purpose.
