NOTIFICATION

Whereas, in terms of the provision of (3)(3.1)(a)(vii) of the Ph.D. Regulations, 2022 regarding the composition of the Ph.D. Committee in each of the Postgraduate Departments of this University, it is clearly stated that two External Experts not below the rank of Professor of a University or HEIs outside Vidyasagar University nominated by the Hon'ble Vice-chancellor out of a panel of five experts recommended by the Departmental Committee.

AND

Whereas, in terms of the provision of (3)(3.1)(b)(v) of the Ph.D. Regulations, 2022 regarding composition of the Ph.D. Committee for the Research Centres of Vidyasagar University, it is clearly stated that two External Experts, not below the rank of Professor of a University or HEIs outside Vidyasagar University nominated by the Hon'ble Vice-chancellor.

AND

Whereas, it has been observed from various records that some of the Professors in both the Ph.D. Committee(s) have been nominated repeatedly and some retired Professors in both the Ph.D. Committee(s) have been nominated although there are no specific guidelines for this purpose.

AND

Whereas, the matter was placed before the Board of Research Studies(BRS) of Vidyasagar University in its Twelfth (12th) meeting held on 24.06.2025 vide Item No.07 for formulation of a specific guidelines regarding nomination of the External Experts to the Ph.D. Committee(s) in both the cases.

Now, therefore, in view of the provision(s) laid down in the Ph.D. Regulations, 2022 of Vidyasagar University and subsequent the decision taken by the BRS in its aforesaid meeting, a Professor not to be appointed/nominated as an External Expert for more than two consecutive terms and a Professor upto the age of seventy (70) years to be appointed/nominated as an External Expert in the Ph.D. Committee(s) henceforth.

In connection with the above, as decided by the BRS, all concerned are being informed accordingly and are requested to kindly do the needful in this regard.
